The Williamson County Board of Review received notice of the appeal on August 12, 2021. PTAB granted the county a 90-day extension to submit evidence with a due date of November 10, 2021. By letter postmarked October 26, 2021, the board of review requested an additional 90-day extension to submit evidence. The board of review engaged Tri-State

Appraisal to complete an appraisal of the subject property. The subject property consists of a one-story building with 45,600 square feet of building area used as a 159-bed skilled nursing facility.

- b. Helia Healthcare of Energy: #20-08635-C-3 (Williamson)

The Williamson County Board of Review was notified of the appeals on July 29, 2021, and granted a 90-day extension to submit evidence with a due date of October 27, 2021. By letter postmarked October 26, 2021, the board of review requested a 90-day extension to submit evidence. The board of review engaged Tri-State Appraisal to complete appraisals of the subject properties.

- c. Courtyard Estates of Peoria: #20-05783-C-3 (Peoria)

The Peoria County Board of Review was notified of the appeal on July 29, 2021, and granted a 90-day extension to submit evidence with a due date of October 27, 2021. By letter postmarked October 27, 2021, the board of review requested an additional 90-day extension to gather sufficient documentation to defend the assessment.

- d. Hickory Point Realty, LLC: #20-06632-C-3 (Macon)

The Macon County Board of Review was notified of the appeal on August 12, 2021, and granted a 90-day extension to submit evidence with a due date of November 10, 2021. By motion received served on October 26, 2019, the board of review, through the Office of the State's Attorney Appellate Prosecutor, requests a 90-day extension for an appraisal to be prepared. The board of review and intervenor, Maroa-Forsyth Community School District No. #2, have agreed to share the cost for an appraisal of the subject property. The subject property is improved with a regional mall. Currently, the intervenor has an extension set to expire on February 2, 2022.

- e. Home Depot USA, Inc.: #19-09521-C-3 (Kane)

The Kane County Board of Review was notified of the appeal on August 12, 2021. It was granted a 90-day extension to submit evidence with a due date of November 10, 2021. By letter postmarked November 3, 2021, the board of review requested an additional extension of time to review and complete evidence.

f. Abidon, Inc.: #20-06756-C-3 (Winnebago)

The Winnebago County Board of Review was notified of the appeal on September 9, 2021. It was granted a 90-day extension to submit evidence with a due date of December 8, 2021. By letter postmarked November 2, 2021, the board of review requests an additional 60-day extension. The board of review asserted that the township is waiting on an appraisal of the subject property. The property is improved with a multi-tenant office building constructed in 1990 containing a gross building area, inclusive of the basement, of 160,000 square feet. Currently, the intervenor has an extension set to expire on February 8, 2022.

g. Delta Sonic Car Wash Systems: #20-05443-C-2 (Will)

Motion to Reinstate Intervenor

By letter postmarked April 21, 2021, Joliet Township High School District #204 filed a resolution and a request to intervene. The following dates are relevant to this matter:

May 13, 2021 - the intervenor was granted a 90-day extension to submit evidence with a due date of August 11, 2021.

October 15, 2021 - the intervenor was defaulted because no evidence was submitted by the established deadline.

By letter postmarked on October 29, 2021, the intervenor filed a Motion to Reinstate. The intervenor claims it adopted the evidence submitted by the Will County Board of Review and requested an extension to submit additional evidence in a letter dated August 2021. The letters were marked as Exhibit A.

h. Lansing Partners I LLC: #19-47261-C-2 (Cook - Thornton)

By letter postmarked February 22, 2021, the Village of Lansing filed a request to intervene and a 60-day extension to file evidence. The intervenor was granted a 90-day extension to submit evidence with a due date of June 9, 2021. By letter postmarked June 1, 2021, the intervenor requested a 90-day extension to submit evidence. The Board granted another 90-day extension with a due date of Wednesday, October 6, 2021. In a letter postmarked October 8, 2021, the intervenor now requests, an additional 60-day extension to file evidence and/or brief.

i. Josh & Jacquie Odelson: #20-33485-R-1 (Cook - Lyons)

Motion to Reinstate

By envelope postmarked April 28, 2021, the Property Tax Appeal Board received a new 2020 appeal from the appellants' attorney with an appraisal estimating the subject property had a market value of \$500,000 as of January 1, 2020. On July 8, the appeal was returned as incomplete because the appellants did not include a copy of the board of review's final decision to establish jurisdiction. By letter dated October 28, 2021, the appeal was dismissed for failure to respond to the incomplete checklist/notice. By letter postmarked November 2, 2021, the appellants' attorney argued that neither the appellants nor their attorneys received the notice or letter indicating that the appeal was incomplete. The IT staff reports that the letter of the incomplete appeal was successfully delivered to the appellants' attorney by email on July 8, 2021. Based on email tracking analytics, the attorney did not try to open the July 8, 2021 email until November 1, 2021. The links had expired, so the documents were not downloadable.

Motion to Reinstate

By envelope postmarked April 20, 2021, the Property Tax Appeal Board received a new 2020 appeal from the appellant's attorney contesting the assessment on three parcels (PINs). Included with the petition was an appraisal estimating the value two of the PINs that comprise the subject property as of January 1, 2020. On June 17, 2021, the appeal was returned as incomplete because the appellant's appraisal only valued two of the three PINS that make up the subject property. The appeal was dismissed by letter dated October 28, 2021 for failure to respond to the incomplete appeal. By letter postmarked November 6, 2021, the appellant's attorney asserts he checked emails and found no such email or letter that the appeal was incomplete. The IT staff reports the letter of the incomplete appeal as successfully delivered to appellant on April 20, 2021, but was not opened.

- k. Dennis J. Guest: #08-29234-C-1 (Cook - Rich)

Motion to Revive Judgment

On November 23, 2013, the Property Tax Appeal Board issued a decision lowering the assessment of the subject property to \$77,520 for the 2008 tax year. Due to an Attorney Lien placed on the property on November 25, 2013, by former counsel, the appellant was prevented from receiving the refund based on the PTAB decision. The appellant faced years of failed negotiation with former counsel and could not resolve the issue until January 2021, when the parties agreed to arbitration. On January 25, 2021, the parties reached a settlement agreement, and the lien was released. The Cook County Treasurer's Office has not refunded the overpayment of taxes based on the PTAB decision issued on November 22, 2013. The appellant prays that the judgment of the PTAB reducing the subject's assessment to \$77,520 for the 2008 tax year be revived.

Motion/Request to Intervene

The appellant filed appeals for tax year 2018 on June 6, 2019, and March 21, 2020. For the three 2018 appeals, the appellant was granted an extension to submit evidence with a due date of March 9, 2020. By postmark of March 5, 2020, the Appellant through counsel, Lena Henderson, filed its evidence consisting of an appraisal for each of the 2018 appeals. (*Please note that Lena Henderson is deceased (3/15/21), and Daniel Pappano entered his appearance on behalf of the appellant on July 21, 2021.*) For the 2019 appeal, an appraisal was filed as evidence of overvaluation. For the 2018 appeals, the Cook County Board of Review was notified of the appeals on July 2, 2020, or August 6, 2020. The Cook County Board of Review filed its Certificate of Service indicating the taxing districts were notified of the appeals on July 28, 2020, September 2, 2020, and October 20, 2020. Sixty days to Intervene expired on September 26, 2020, November 11, 2020, and December 19, 2020. (1910.60(d)(1)(A)).

By postmark of June 11, 2021, the City of Chicago filed its Request to Intervene in each appeal. For the 2018 tax years appeals, the City of Chicago contends it never received proper notice from the Cook County Board of Review despite the fact the appellant is requesting an assessment reduction in excess of \$100,000, and the City is listed on the 2018 or 2019 tax bills. For the 2019 tax year appeal, the City of Chicago contends it did not receive notice from the Cook County Board of Review on October 20, 2020. Instead, it contends it received notice not until it got an email from Matt Zenner from the Cook County Board of review on April 15, 2021. Based on this notice, the City filed the request to intervene within 60 days of service.

The City of Chicago asserts that after receiving notice of the 2019 PTAB appeal for the subject properties, the City engaged in an additional investigation regarding the appeal history for this property and discovered the existence of the three 2018 appeals. The City then contacted the Cook County Board of Review to determine why the City never received formal notice of this appeal from the Board of Review. The City then promptly filed this Request to Intervene in the 2018 appeals. Attached to the Motion are affidavits from Richard G. Danaher, Chief Assistant Corp. Counsel, and Mark Roschen, Assistant Commissioner for the Department of Planning and Development for the City of Chicago, contending they did not receive actual notice of the appeal until an email from Matthew Zenner on April 15, 2021. Danaher asserted that he would have filed a written request to intervene if he had received notice of the 2018 appeal.

Based on these assertions, the City requests the PTAB grant its Request to Intervene in each appeal.

Motion to Vacate Default

On August 5, 2021, and September 9, 2021, the board of review was found to be in default for not submitting its "Notes on Appeal" or evidence in support of its assessment of the properties. The Cook County Board of review asserts it attempted to timely submit substantive, documentary evidence supporting its position, the "Notes on Appeal," with an indication that the board of review would stipulate or a fully executed stipulation. The board of review explained that its system stamps the electronic file for each docket with a date. A timer runs nightly at 8:00 PM that exports the corresponding evidence (PDF) to a folder, and a text file is created. The docket, primary pin, hearing requested, and the Notes sent date is stamped in a text file. Each subsequent docket is appended with the same field to the daily text file. The board of review presented a spreadsheet showing the dates that the board of review transmitted its responsive pleadings to the PTAB. Due to a "transmission error"

from May 29 to May 31, 2021, the Cook County Board of Review was unable to establish a connection with the PTAB's "remote server." Therefore, the board of review requests the Property Tax Appeal Board vacate its finding of default; make the board of review submission a part of the record; amend its docket to indicate the board of review timely submitted evidence, and set the matter for hearing on the merits.

The Board received these new residential appeals by a postmark date of June 10, 2021, and the appellant requested an extension of time. The appellant was granted a **final** 90-day extension to submit evidence with a due date of November 24, 2021. On November 19, 2021, via email to the Executive Director, the appellants' attorney requested an extension to file appraisals of the subject properties. Counsel referenced a letter accompanied with the extension request from the appraiser asserting "which sets forth that they are still working on the appraisal." The letter from the appraiser dated November 19, 2021, states: We have been contracted to do an appraisal (of the subject properties) for *Ad Valorem Tax* purposes for the 2020 tax year. We are in the process of preparing an Appraisal Report for the subject properties. This appraisal assignment requires considerable analysis in order to arrive at a sound opinion of market value. Since the residential appeals were filed on June 10, 2021, the appellant had 167 days to file evidence by the November 24, 2021 deadline.

Dismiss sua sponte

This item appeared on the Board's November 2021 Agenda. The matter was on the Agenda because the Chicago Board of Education filed a motion to vacate a default order. During the discussion of the motion, the Board considered *sua sponte* dismissing the appeal with prejudice for lack of jurisdiction because the appellant's requests for an assessment reduction pertain to granting full exempt status for the 2019 tax year. Instead of dismissal, the Board voted to allow a response to be filed by the taxpayer with respect to jurisdiction. By email dated November 17, 2021, the appellant's attorney argued the exemption was granted by the Department of Revenue beginning with the 2018 tax year, and the Assessor has issued a Certificate of Error recommendation to the Cook County Board of Review for the 2019 tax year. The appellant requests the PTAB to reduce the assessment to \$0 based on the Department of Revenue determination. The appellant requested that that the Cook County Board of Review approve the Assessor's recommendation by December 10, 2021, so the 2019 PTAB appeal can be dismissed.
