In each appeal, the appellant filed by envelope postmarked June 10, 2021, from decisions issued by the board of review on March 22, 2021, and a transmittal date of May 12, 2021. On August 26, 2021, the appeals were returned as incomplete, as the appellant did not complete section 2C of the appeal forms (the assessment request).

- A 30-day extension to complete the appeal forms was granted to the appellant with a due date of September 25, 2021.
- By letter postmarked September 24, 2021, each appellant requested an extension to submit evidence.
- On October 14, 2021, each appellant was granted a **Final** 60-day extension with a due date of December 13, 2021.
- On December 10, 2021, by e-mail to the Executive Director, the appellant requested an extension to file its full narrative appraisal of the property identified in each appeal. Each appellant explained that it is currently working with Patrick M. Kelly, MAI, of Kelly Appraisal Consultants, Inc., who has not been able to finalize the appraisals before this date.

b. Dave Anderson: #20-04804-I-3 (Kane)

The Kane County Board of Review was notified of the appeal on September 16, 2021, and granted a 90-day extension to submit evidence with a due date of December 15, 2021. By letter postmarked December 8, 2021, the board of review requested the PTAB grant an additional extension to review and complete evidence to file for this appeal. The subject property is a one and part two-story, precast concrete panel industrial building constructed in 2017 and contains 133,400 square feet of rentable building area. The appellant has submitted a narrative appraisal estimating the subject property has a market value of \$9,600,000 as of 1/1/20 and has requested an assessment reduction of approximately \$1.25 million.

c. Gilman Realty LLC: #20-06846-C-2 (Iroquois)

The appellant filed the appeal in an envelope postmarked March 23, 2021, from a "Notice of Proposed Change in Assessed Value by Board of Review" dated March 5, 2021.

By letter dated May 6, 2021, the PTAB notified the Iroquois County Board of Review of the appeal and granted the board of review a 90-day extension to submit evidence with a due date of August 4, 2021. By enveloped postmarked September 14, 2021, the Iroquois County Board of Review filed its "Board of Review Notes on Appeal" and evidence. In a cover letter, the Chief County Assessment Officer and Clerk of the Board of Review asserted that "[f]rom oversight or e-mail issues our office never received the notice sent per the PTAB dated May 6, 2021. At this time the Board of Review is submitting the Certificate for notification of the taxing bodies for request of over \$100,000 as well as the evidence used by the Board of Review for their initial valuation reduction for the 2020 assessment year. The

Board of Review sent tentative notices of decisions on 03/05/21. The appellant did not appear for the final hearing, so no final notice was sent. This is all the evidence the Board of Review wished to present at this time. The Board of Review respectfully requests that the assessed value of the subject property be upheld based on the evidence provided supporting the market value of the subject property.”

IT indicated that an e-mail was sent to the Iroquois County Board of Review on May 6, 2021, notifying it of the appeal, but it does not appear that the e-mail was opened.

The St. Clair County Board of Review was notified of the appeals on September 16, 2021, and was granted a 90-day extension to submit evidence with a due date of December 15, 2021. By e-mail of December 14, 2021 (no postmark date), the St. Clair Board of Review requested an extension of time to evaluate the appellant's material and prepare its summation of value. Due to a hefty workload and a small staff, the BOR requested an extension of 60-days.

- e. Weber-Stephen Products LLC: #20-24158-I-2 (Cook - Palatine)
- July 20, 2021- Palatine Township High School Dist. No. 211 & Palatine Community Consolidated School Dist. No. 15 filed their Requests to Intervene.
 - August 12, 2021 - By letters dated August 12, 2021, the intervenors were granted a 90-day extension to submit evidence with a due date of November 10, 2021.
 - By letter dated November 10, 2021, but postmarked November 17, 2021 (7 days late), the Intervenor requested an additional 60-day extension to complete their review of the appellant's evidence in the above-referenced matter. The letter was received by PTAB on November 23.
 - On December 14, 2021, PTAB received an envelope from the appellant postmarked November 10, 2021, which had the request for the 60-day extension.

- January 5, 2022 – PTAB received an email from the intervenors’ attorney with a copy of a Certificate of Mail Receipt postmarked November 10, 2021, with a receipt signed by PTAB clerk Cathy Wilson on December 15, 2021. Also provided by the attorney was a copy of the USPS tracking results showing that the letter was in the post offices possession on November 10. The tracking numbers match.
- Intervenors expect to submit evidence and legal argument in support of the current assessment. They are now completing their review and preparing materials for filing with the Property Tax Appeal Board.

f. Chicago Food Property, LLC: #19-36580-C-2 (Cook - Northfield)

- February 26, 2021 - Glenbrook High School Dist. #225 (Dist. #225) filed a request to intervene.
- March 11, 2021 – By letter dated March 11, 2021, the intervenor was granted a 90-day extension to submit evidence with a due date of June 9, 2021. On the same date, the same attorney filed a request to intervene on behalf of Glenview Community Consolidated School Dist. #34 (Dist. #34).
- July 15, 2021 - By letter dated July 15, 2021, Dist. #34 was granted a 90-day extension to submit evidence with a due date of October 13, 2021.
- By letter postmarked June 2, 2021, the Intervenors’ counsel requested that both Dist. #225 and Dist. #34 be granted an additional 60-day extension in which to submit evidence. A letter from the retained appraiser was included asserting that additional time was needed to complete the assignment.
- August 5, 2021 - Dist. #225 was granted a 60-day extension to submit evidence until October 4, 2021.
- September 30, 2021 (by letter with 9/30/21 postmark date) - Both Intervenors requested an additional 45-day extension to submit evidence which was accompanied by a letter from the retained appraiser asserting that an additional 45 days was needed to complete the assignment.
- On October 21, 2021, Dist. #225 and Dist. #34 were granted a 45-day extension or until December 5, 2021, to submit evidence.
- December 1, 2021 – By letter postmarked December 1, 2021, the Intervenors requested an additional 45-day extension for completion of the appraisal with a letter from the appraiser requesting an additional 45-days to complete the assignment.
- December 13, 2021 - The Intervenors submitted an appraisal estimating the subject property had a market value of \$11,750,000 as of January 1, 2019.

The appraisal submitted on 12/13/21 is beyond the 12/5/21 date to submit evidence, hence the Intervenors' current request (filed 12/1/21) to extend the deadline.

- g. Lewis Williams: #20-43664-C-1 (Cook - Thornton)

Motion to Reinstate

On June 22, 2021, the appellant, through counsel, filed and requested a 60-day extension of time to file supporting documentation in this matter. The taxpayer received the PTAB's Notice of Appeal dated September 23, 2021, which granted the appellant a **final** extension until November 22, 2021, to file supporting evidence.

- On November 17, 2021 (letter dated and postmarked), the appellant, through counsel, filed a request to withdraw the appeal.
- By letter dated December 9, 2021, the PTAB granted the request to withdraw the appeal.
- However, by letter dated December 3, 2021, and received by the PTAB on December 6, 2021, the appellant, through counsel, asserted that on November 17, 2021, the taxpayer inadvertently filed a request to withdraw the appeal. The appellant stated that as of December 3, 2021, a Notice of Dismissal had not been received. The appellant requested that if a Dismissal Order has been entered, the PTAB vacate the Dismissal Order and reinstate the subject appeal. Counsel asserts that the taxpayer has recently secured a 2020 appraisal and wishes to submit evidence to the PTAB. The taxpayer requested that the PTAB allow the letter of December 3, 2021, to also serve as a Motion to Amend the taxpayer's letter of November 17, 2021, and allow the taxpayer to request additional time to submit the evidence in support of the appeal. Counsel contends that no prejudice will result from this inadvertent oversight by the taxpayer and the reinstatement of the appeal.

- h. Boreas LLC: #20-05155-C-3 Kane

Intervenor's Motion to:

1. Dismiss Absent Evidence of Timely Request to File Single Petition Pursuant to PTAB Rule 1910.30.
2. Or in the alternative:
 - a. Require the appellant to file: (a) competent appraisal to support a market value for each non-contiguous parcel, (b) the Regulatory and Operating Agreement, the Extended Use Agreement, development agreement, property management documents, and other documentation referred to by appellant and its appraisers in the Brief of Taxpayer and Renzi & Associates appraisal; and
 - b. Grant the Intervenor 90-days from the date of receipt of those filings, or the PTAB's determination of this Motion, whichever is later, to file additional evidence or argument in its case-in-chief.

Relevant Facts

- 2/5/2021 – The appellant filed the appeal from decisions issued by the Kane County Board of Review and requested a 90-day extension to submit valuation evidence.
- The appeal involves 39 scattered homes within Kane County.
- The PTAB granted the appellant a final 90-day extension to expire on June 23, 2021.
- 06/16/2021 – In an envelope postmarked June 16, 2021, the appellant submitted a letter requesting that the 2020 appeal consisting of non-contiguous parcel numbers be treated as a single petition. The appellant asserted the homes are used as low-income housing subject to a Regulatory and Operating Agreement. In support of the overvaluation argument, the appellant submitted an appraisal prepared by an Illinois Certified General Appraiser identifying the property as the Fox Prairie Homes, with all the homes located in Aurora, 39 of which are located in Kane County, and 1 in DuPage County. Using the income capitalization approach, the appraiser arrived at an estimated market value for the property of \$2,950,000 as of January 1, 2019.
- 07/22/2021 – On July 22, 2021:
 - 1. The PTAB sent an acknowledgment to the appellant that all information necessary to complete the filing of the appeal has been received and incorporated all the non-contiguous parcel numbers into a single petition/appeal.
 - 2. The PTAB also sent notice to the Kane County Board of Review of the appeal by separate letter dated July 22, 2021.
- 08/3/2021 – On August 3, 2021, the Kane County BOR notified the taxing districts of the appeal.
- 08/25/2021 – On August 25, 2021, West Aurora School Dist. No. 129 filed a request to intervene and a request for a 90-day extension of time to submit evidence.
- 09/9/2021 – On September 9, 2021, the PTAB granted West Aurora School Dist. No. 129 a 90-day extension to submit evidence to expire on December 8, 2021.
- 09/17/2021 – On September 17, 2021, the City of Aurora and East Aurora School Dist. No. 131 each filed a Request to Intervene.
- 09/30/2021 – On September 30, 2021, the PTAB granted East Aurora School Dist. No. 131 a 90-day extension to submit evidence to expire on December 29, 2021.
- 10/7/2021 – On October 7, 2021, the PTAB granted the City of Aurora a 90-day extension to submit evidence expiring on January 5, 2022.
- The intervenors are represented by the same counsel.

Intervenors' Motion

On December 6, 2021, the Intervenors filed a Motion to Dismiss Absent Evidence of Timely Request to File a Single Petition Pursuant to PTAB Rule 1910.30. The Intervenors assert the appellant has filed a single petition appealing the assessed value of 39 separate, non-contiguous parcels located all over the City of Aurora for properties spanning two different school districts. The Intervenors acknowledge the appellant's evidence in this appeal considers and values an additional parcel in another county for a total of 40 separate, non-contiguous parcels.

The Intervenors argue PTAB rule 1910.30 requires that a petition for appeal "shall be on the prescribed form and a separate petition must be filed for each separately assessed parcel except for contiguous single-owner parcels that constitute a single property and except for condominium buildings or unless a written request is made to the Board for the filing of a single petition for multiple parcels." 86 Ill. Admin. Code 1910.30. The Intervenors assert that in this appeal, only a single petition was filed. The parcels are not contiguous. There was no request made by the appellant to file a single petition for multiple parcels.

The Intervenors also contend that the appellant filed 39 separate appeals with the Kane County Board of Review for the 2020 tax year.

The intervenors assert that based upon PTAB's online docket and the documents provided to the Intervenors, this mandatory prerequisite was disregarded by the appellant, and the appeal should be dismissed.

The appellant did not respond to the Motion.

- i. John and Laura Cerretani: #19-49659 R-1 (Cook – Palatine)
Motion to Issue a Subpoena

This matter is a residential appeal filed pro se. The appellant's evidence includes an appraisal. The matter has been set for hearing on January 21, 2022, at 11:30 a.m. The appellant filed a motion, via email, asking the PTAB to issue a subpoena for the appraiser, Charles Walsh, to ensure the appraiser's appearance at the hearing. Notice of the request has been sent to the individual who is to be summoned. Rule 1910.68 requires the Chairman or his designee to issue a subpoena.
