 - a. **Covia Corp Utica Plant: #20-07934-I-3 (LaSalle)**

The LaSalle County Board of Review was notified of the appeal on November 10, 2021 and was granted a 90-day extension to submit evidence with a due date of February 8, 2022. By email received on February 7, 2022, the board of review requested the PTAB grant an additional 90-day extension to complete its submission of factual data for their commercial property. Due to Covid-19, the person who

collects the BOR data was off for several weeks and was not expected to be back in the office until February 17, 2022.

The property consists of 37 parcels containing approximately 1,960 acres of land with various building improvements (34 buildings) associated with the extraction and processing of subterranean silica material.

- b. Ira Bodenstein as Chapter 7 Trustee of Westlake Property: #20-36203-C-3 (Cook - Proviso)

The subject property is improved with a six-story hospital complex known as Westlake Hospital. Westlake, through counsel, filed the appeal with the PTAB and submitted an appraisal estimating the property had a market value of \$7,740,000 as of 1/1/20.

The BOR submitted its Certificate indicating it had notified taxing districts of the appeal on 8/11/21.

9/22/21 – Proviso Township High Schools District No. 209 filed its Request to Intervene.

11/10/21 - Proviso Township High Schools District No. 209 was added as an intervenor and granted a 90-day extension to submit evidence with a due date of February 8, 2022.

By letter postmarked February 7, 2022, the Intervenor requested an additional 120-day extension to submit evidence relative to the above-referenced appeal. The Intervenor has retained Mr. Neil J. Renzi, MAI, a certified appraiser, to assist in preparing evidence. Included with the requested extension was a letter from Renzi dated February 7, 2022, requesting a 120-day extension to complete the assignment due to the delay of inspection of the subject property.

- c. RRP Franklin Park LLC: #20-24133-I-2 (Cook - Leyden)

Motion to Vacate Default and for Leave to Adopt Evidence

3/8/21 - The appellant timely filed the appeal based on overvaluation. The property comprises a 71,264 square foot site improved with a one-story, masonry-constructed, single-tenant, industrial/warehouse building built in 1985, containing approximately 40,200 square feet of building area. The appellant's appraiser estimated the subject had a market value of \$1,275,000 as of January 1, 2019. The appellant requested that the assessment be reduced from \$472,350 to \$318,750 to reflect the appraised value.

5/24/21 – The board of review notified the taxing districts of the appeal.

6/21/21 – PTAB received Veterans Park District's Request to Intervene. The taxing district did not submit any evidence but did request a hearing.

7/8/21 – The PTAB acknowledged the intervention and granted Veterans Park District a 90-day extension to submit evidence that expired on October 6, 2021.

10/6/21 – Veterans Park District requested an additional 60-day extension for the filing of evidence.

10/28/21 – PTAB granted the Intervenor a 60-day extension to submit evidence that expired on Monday, December 27, 2021.

By letter dated December 27, 2021, postmarked/stamped on two lines "CAROL STREAM IL" & "December 29 2021" (not very legible), and received by the PTAB on January 13, 2022, the Intervenor filed a request to adopt and incorporating the evidence submitted by another Intervenor, Leyden Community High School District No. 212.

1/18/22 – The PTAB issued a letter to Veterans Park District defaulting the Intervenor for not submitting any evidence. The request to adopt the evidence was untimely filed – being two days late.

2/8/22 - Intervenor, Veterans Park District, requests that PTAB vacate the default judgment and grant Intervenor leave to adopt the evidence submitted by Leyden High School. Leyden High School's evidence includes a brief and five comparable sales.

The Intervenor asserts that it deposited correspondence to the Illinois Property Tax Appeal Board into the US Mailbox at 9501 W. Devon Avenue, Suite 800 Rosemont, Illinois, before the last mail pick-up on December 27, 2021. The Intervenor also submitted an Affidavit from Kathleen A. Kestler, a paralegal at the law firm representing the Intervenor. Ms. Kestler asserts that on December 27, 2021, she prepared the certified mailing on behalf of Veterans Park District, placed the correct postage on the envelope, and placed the same envelope in the USPS mailbox, before the last mail pick-up, at 9501 W. Devon Ave., Rosemont, IL. The appellant also provided a copy of the USPS Tracking Plus document stating that on December 29, 2021, 11:56 pm, the mailed document arrived at the USPS Regional Facility, Carol Stream IL Distribution Center.

The Intervenor, Veterans Park District, requests the PTAB vacate the default judgment entered against Veterans Park District and that, pursuant to the timely filed correspondence mailed on December 27, 2021, Veterans Park District be allowed to

adopt and incorporate any evidence filed by Leyden High School District No. 212 as evidence submitted on behalf of the Intervenor.

d. Town & Country Distributors, Inc.: #20-08337-I-1 (DuPage)

Motion to Reinstate Intervenors

The appellant filed the appeal from a BOR decision issued on 3/31/21. The property consists of a 96,307 square foot site improved with a one-story, masonry constructed, single-tenant, warehouse/industrial building built in 1981 containing 39,724 square feet of gross building area. The appellant submitted an appraisal estimating the subject property had a market value of \$1,990,000 as of January 1, 2019. The property has a total assessment of \$770,760, reflecting a market value of approximately \$2,312,500, rounded. The appellant requested that the subject's assessment be reduced from \$770,760 to \$670,761, a difference of \$99,999.

10-28-21 – The PTAB notified the DuPage County Board of Review & the DuPage County State's Attorney of the appeal. Since the change in assessment, the request is less than \$100,000 (this is a class 1 appeal), the BOR does not need to send a certificate to the taxing districts notifying them of the appeal. A taxing district has 60-days from the date of the PTAB's notice to the State's Attorney to file a Request to Intervene (86 Ill.Admin.Code 1910.60(d)(1)(A), which expired on Monday, December 27, 2021.

1-10-22 – The PTAB received a stipulation signed by the appellant and the DuPage County BOR reducing the assessment to \$727,860.

1-13-22 - Itasca Community Library, Itasca Fire Protection District, Itasca Park District, Itasca School District #10, and Lake Park High School District #108 filed their resolutions and a Requests to Intervene.

1-19-22 – The PTAB dismissed the taxing districts as the Requests to Intervene were not timely filed.

1/31/22 – The taxing districts filed a joint Motion to Reinstate. The taxing bodies assert that they received notice of the appeal from the DuPage County Board of Review on November 23, 2021, which was marked as Exhibit A. Therefore, the taxing bodies contend that they had 60 days to submit the Request to Intervene from November 23, 2021, notice, pursuant to Section 1910.60(d)(1)(B) of the PTAB's rules, which would have expired on Monday, January 24, 2022. The taxing bodies contend they timely filed their Requests to Intervene on January 13, 2022. Exhibit A was a letter from the Chairman of the DuPage County BOR to Chris Kunze, President of the Itasca Fire District, regarding the appeal. The board of review provided no

other notices to taxing bodies. The taxing bodies request they be reinstated as parties to the appeal.

- e. SNH Medical Office Properties LLC: #19-04318-C-3 (Lake)
- SNH Medical Office Properties LLC: #20-01071-C-3 (Lake)
- SNH Medical Office Properties LLC: #21-02161-C-3 (Lake)

Joint Motion to Stay Proceedings Based Upon Multi-Year Settlement

The Taxpayer, the Lake County Board of Review, and the Intervenor, North Chicago Community Unit School District 187 (“Parties”), request the Illinois Property Appeal Board (“PTAB”) to issue a Stay Order in the proceedings. In support of this motion, the Parties state as follows:

1. The taxpayer, the Lake County Board of Review, the Waukegan Township Assessor, Warren Township Assessor, and Intervenor (North Chicago Unit School District 187) have agreed on a settlement that will result in stipulations for 2019, 2020, and 2021 PTAB appeals.
2. The taxpayer agrees that within 30-days of confirmation that the 2022 assessment is not in excess of \$2,416,425 and is final and not subject to an underassessment appeal, the taxpayer will ask PTAB to enter orders for the 2019-2021 matters in accordance with the stipulations.
3. It is not in anyone’s interest that the Parties be required to expend resources and submit evidence on matters that have been settled; therefore, the Parties request that PTAB stay any hearings and evidence filing deadlines until the entry of the orders based on the 2019-2021 stipulations.
4. If the 2022 final Board of Review assessment exceeds \$2,416,425, the parties agree that the stipulations will be void, and the matters can proceed on a timeline determined by the PTAB.
5. No prejudice will result from the entry of the requested stay. It appears to be in the PTAB's interest of Administrative Economy and stated preference of resolving cases by stipulation.

- f. Walgreens: #20-06131-C-2 (Rock Island)

Rock Island County Board of Review Motion to Dismiss for Lack of Jurisdiction

2/15/21 - The appellant, Walgreens, filed the appeal from a “Notice of Dismissal” from the Rock Island County Board of Review dated 1/19/2020 (*sic*). The appellant submitted an appraisal estimating the property had a market value of \$1,000,000 as of January 1, 2019. The Notice of Dismissal provides in part:

Our office is in receipt of your complaint. However, in reviewing the complaint, we noticed the ownership name is Palm Beach MB 2LLC, and the taxpayer's name is Wayne Kao.

Our office sent a letter requesting clarification and/or lease with a return date of 12/23/2020. The due date has passed, and the requested information was not received. The above complaint has been dismissed.

4/8/21 - The PTAB returned the appeal as incomplete because the appellant did not include a copy of the board of review's final decision to establish jurisdiction and an addendum

5/6/21 – The appellant responded to the incomplete checklist by including the completed addendum and another copy of the board of review “Notice of Dismissal.” The appellant also submitted an authorization letter from Walgreens authorizing the Mullen Law Offices to represent Walgreens in assessment appeals for the property, a copy of the Rock Island County Board of Review complaint, and a copy of a lease between Great Midwest of Rock Island, Inc. (Landlord) and Bond Drug Co. of Illinois (Tenant) for the property. The lease provides that the Landlord is to make a mailing address change on the property tax records so that the tax bill and tax notices for only the leased premises be mailed to the tenant at the following address: Walgreen Co., 300 Wilmot Road, Deerfield, Illinois, 60015, Attention: Tax Department. The lease also provides that the tenant shall have the right to contest the validity of the amount of any tax or assessment. Walgreens signed a Guaranty guaranteeing the full and faithful performance and compliance with all the terms, covenants, and conditions upon the part of Bond Drug Co. of Illinois as Tenant and its assigns in the lease.

7/8/21 - the PTAB sent notice to the appellant’s counsel acknowledging the filing of the appeal and, by separate letter, sent notice to the Rock Island County Board of Review of the appeal. The board of review had until October 6, 2021, to submit evidence or request an extension.

9/15/21 – the board of review requested a 90-day extension to submit evidence.

10/13/21 – the PTAB granted the BOR a final 90-day extension to submit evidence to expire on Tuesday, January 11, 2022.

12/17/21 – The Chief County Assessment Officer and Clerk of the Rock Island County Board of Review filed a Request to Dismiss for Lack of Jurisdiction through the State's Attorney. In summary, the board of review contends it sent two notices to the appellant's counsel on December 15, 2020. The letter requested that the appellant's counsel provide a written/notarized authorization signed by the owner/taxpayer with the board of review complaint and explain why the owner/taxpayer's name differs from the County's. Additionally, the letter requested counsel clarify & if there is a lease. The board of review asked the appellant's attorney to respond to both requests

by December 23, 2020. Both notices provided that "Failure to supply this requested information by the due date may result in dismissal of the complaint." The appellant's counsel did not respond by December 23, 2020, and on January 19, 2021, the board of review provided the appellant with a Notice of Dismissal. On February 11, 2021, the appellant's counsel provided the requested information to the Chief County Assessment Officer. The board of review contends the appellant's appeal was dismissed due to the appellant's failure to prosecute or follow procedure. It argues the appellant received a notice informing it that their application was insufficient and identified specifically the information needed by December 23, 2021. The board of review acknowledged that the eight (8) day-time period to bring the complaint into compliance with the BOR rules violates of the ten (10) working days as provided by Section 16-55(d) of the Property Tax Code (35 ILCS 200/16-55(d)) that provides in part that:

The notification must identify which rules have not been complied with and provide the complainant with no less than ten business days to bring the complaint into compliance with those rules. If the complainant complies with the board of review rules either upon the initial filing of a complaint or within the time as extended by the board of review for compliance, then the board of review shall send, electronically or by mail, a notice of hearing and the board shall hear the complaint and shall issue and send, electronically or by mail, a decision upon resolution. Except as otherwise provided in subsection (c), if the complainant has not complied with the rules within the time as extended by the board of review, the board shall nonetheless issue and send a decision.

Subsection (c) provides in part that:

If a complaint is filed by an attorney on behalf of a complainant, all notices and correspondence from the board relating to the appeal shall be directed to the attorney. The board may require proof of the attorney's authority to represent the taxpayer. If the attorney fails to provide proof of authority within the compliance period granted by the board pursuant to subsection (d), the board may dismiss the complaint. . . . 35 ILCS 200/16-55(c).

The board of review contends that because the appellant failed to appear the PTAB has no jurisdiction or, in the alternative, the appellant cannot appeal the decision on the merits because the merits of their appeal was not heard by the board of review as the appellant did not provide the board of review the required documents. The board of contends the appellant lacks standing to bring the present appeal and requests the appeal be dismissed with prejudice.

1/19/22 – Appellant filed its Response to Rock Island County Board of Review’s Request to Dismiss for Lack of Jurisdiction.

The appellant asserts that an appeal was timely filed with the Rock Island County Board of Review contesting the 2020 assessed valuation. Previous appeals were filed for the tax years 2013, 2015, 2018 and 2019 without any request for a copy of the lease. On December 15, 2020, the Board of Review sent a notice to Walgreens' attorney stating that the attorney must submit a written authorization with the complaint by December 23, 2020. Also, on December 15, 2020, the Board of Review sent a second notice requiring a copy of any lease by December 23, 2020. Walgreens provided a written notarized authorization form to the Board of Review on December 29, 2020. In the latter part of January 2021, a telephone conference was held between Larry Wilson, the Chief County Assessment Officer and Clerk of the Rock Island County Board of Review, and Walgreens’ attorney concerning the need for the lease pertaining to the property when complaints in 2013, 2015, 2018 and 2019 were accepted by the Board of Review without a lease. Following the conversation, the appellant sent a letter to the board of review dated February 11, 2021, enclosing a copy of the lease between Great Midwest of Rock Island, Inc. and Bond Drug Co. of Illinois.

In summary, Walgreens contends it filed its 2020 complaint within the time frame put forth by the Rock Island County BOR. The Rock Island County BOR requested some additional information, which was complied with. Walgreens had filed complaints before the Rock Island County Board of Review for four previous years without a copy of the lease, nor was it requested. The appellant requested that the Motion to Dismiss for Lack of Jurisdiction be denied.

2/11/22 – the Rock Island County Board of Review filed a Reply to Walgreen’s Response contending that Walgreens did not comply with the Board of Review’s rules resulting in the dismissal of the appeal. The board of review contends the PTAB has jurisdiction, by statute, limited to valuation decisions issued by the county board of review. The board of review contends that while the PTAB may review assessment decisions made by the board of review, it has no authority to review a decision of a board of review determining whether a party has complied with the board of review’s rules.
