Motion – Appellant's Motion to Reinstate Stipulated Decision

The appellant filed this appeal on December 30, 2016. The following facts are relevant to the current “Motion to Reinstate.”

1. The property comprises two parcel numbers (PINs) 05-08-400-036-000 & 05-08-321-043-0000.
2. PTAB scheduled a hearing for November 20, 2020.
3. On December 28, 2020, the Property Tax Appeal Board received a signed stipulation dated November 18, 2020, from the Cook County Board of Review, including both PINs.
4. On March 16, 2021, the PTAB issued a decision based on the stipulated total assessment of \$300,000. The stipulation divided the total assessment as follows:
 - a. PIN 05-08-321-043-0000 – \$118,859.
 - b. PIN 05-08-400-036-0000 – \$181,141.
5. The stipulated assessment resulted in an increase in the assessment for PIN 05-08-321-043-0000 from \$118,619 to \$118,859.
6. On May 4, 2021, the appellant, through counsel, filed a Motion to Reinstate for Vacation and Withdrawal of Docket No. 16-23209.001-R-1 and the March 16, 2021, stipulated assessment on the parcel.
7. On May 24, 2021, the PTAB granted the Motion to Vacate the Decision and Withdrawal the appeal.
8. Almost one year later, on May 5, 2022, the appellant filed this Motion to Reinstate.

The Current Motion.

The appellant, through counsel, requests the PTAB to allow the reinstatement of the November 18, 2020, stipulation to lower the assessment on the parcel for the above-entitled cause for the following reasons as summarized:

- a) The parcel at issue has two PINs, 05-08-321-043-0000 and 05-08-400-036-0000.
- b) On November 18, 2020, the appellant and the Board of Review stipulated a total assessed valuation of \$300,000 to cover both PINs.
- c) The resulting PTAB decision, which was based on the stipulation, raised the assessment value for one PIN (05-08-321-043-0000) and lowered it for the other (05-08-400-036-0000).
- d) The appellant’s attorney attempted to resolve the error in May 2021 by filing a motion before PTAB to vacate and withdraw the decision solely for the increased PIN. The PTAB granted the request on May 24, 2021, but the order entered by the PTAB included both PINs.

- e) Based on the May 24 order that withdrew both PINs, the Cook County Treasurer's office seeks to recover the sum of \$15,409.08 from the appellant, which is not in line with the settlement entered into between the Board of Review and the appellant.

Request for Relief.

The appellant requests equitable relief from the PTAB and is asking that the PTAB enter an order to allow the reinstatement of the 2016 Docket in the above-entitled cause and to reinstate the \$300,000 assessed value pursuant to the stipulation dated November 18, 2020, wherein the parties agreed to a total assessment of \$300,000.

Notice to Board of Review.

The PTAB required the appellant to send notice of this motion to the Cook County Board of Review (BOR), which the appellant did. PTAB has not received an objection in opposition to granting this motion.

- b. Covia Corp Utica Plant: #20-07934-I-3 (LaSalle)

Motion – Appellant’s Motion to Amend Requested Values

The appellant filed this appeal by mail on April 19, 2021. The subject property is made up of 39 PINs.

1. The appellant asserted that the subject property had an aggregate assessed value of \$23,597,111, equating to a market value of \$70,791,333.
2. The appellant requested that the subject property be valued at a revised aggregate assessed value of \$11,798,562, reflecting a market value of \$35,395,686.
3. The appellant further requested an extension of time to submit evidence. On June 24, 2021, the PTAB granted the appellant an extension of time to submit evidence with a due date of August 23, 2021.
4. The appellants submitted a copy of the appraisal estimating the subject property had a market value of \$16,800,000 as of January 1, 2020.
5. On November 10, 2021, the PTAB notified the appellant that all information to complete the appeal had been received, and sent notice to the board of review of the appeal.

Intervenors.

- 1/10/22 - the BOR notified the taxing districts of the appeal.

- 1/31/22 - Waltham Community Consolidated School District No. 185 filed a Request to Intervene and requested a 90-day extension to submit evidence. On 2/17/22, the PTAB acknowledged the request to intervene, added Waltham Community Consolidated School District No. 185 as a party to the appeal, and granted an extension of time to file evidence until 5/18/22. On 5/18/22, the Intervenor filed a request for an extension of time to submit evidence.
- 3/4/22 - LaSalle-Peru Township High School Dist. No. 120 filed a Request to Intervene and requested a 90-day extension of time to submit evidence. On 3/17/22, the PTAB acknowledged the request to intervene and added LaSalle-Peru Township High School Dist. No. 120 as a party to the appeal and granted an extension of time for filing evidence until 6/15/22.

Current Motion to Amend Requested Values to Conform with Evidence.

By correspondences dated April 28, 2022, and May 9, 2022, the appellant filed Motions to Amend the Requested Values to Conform with its Evidence. The appellant explained that their appraisal was not completed when the appeal was filed. The amounts requested on the appeal forms for the taxpayer's requested assessed value were based upon mere estimates of value for the property (a mining operation of a silica sand quarry). The appellant now seeks to amend those estimates to match the appraisal's values.

Pursuant to Section 1910.31(a) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code 1910.30(a)), the appellant moved to revise its requested value to that same value supported by the appraisal. Section 1910.31(a) of the PTAB's rules provides:

After the Property Tax Appeal Board has transmitted an appeal to the Board of Review, and the period for intervention under Section 1910.60 has expired, a petition for appeal may be amended to correct any technical defects, except when the amendment would be prejudicial to a party.

The appellant contends that both intervenors were timely provided with copies of the appellant's appraisal evidence which supports this revision, and therefore timely notified them of the values now being sought by the appellant.

Accordingly, the appellant seeks leave to submit the enclosed appeals (Addendum) with the revised requested assessments for the 2020 assessment on the 39 parcels. The aggregate proposed assessed value of the parcels is \$23,597,111, which equates to a fair market value of \$70,791,333. The appellant requests the revised

assessed value of \$5,600,000 (in the aggregate), which equates to a fair market value of \$16.8 million, the appraised value submitted by the appellant.

The appellant provided an addendum containing the amended assessment requests for each of the 39 PINs under appeal, which totals \$5,600,000.

c. Eddie Lindt: #19-54366-R-1 (Cook – Lake)

Motion – Appellant’s Motion to Reject the Board of Review’s Untimely Disclosure of Supplementary Documentary Evidence

- On January 14, 2022, the Property Tax Appeal Board received this direct appeal for the tax year 2019 within 30-days of the 2018 decision issued by the PTAB (Docket No. 18-32372.001-R-1), reducing the assessment to \$30,600.
- In support of the appeal, the appellant marked a recent appraisal as the basis of the appeal and submitted an appraisal estimating the subject property had a market value of \$306,000 as of January 1, 2018. The appellant did not request a hearing.

Board of Review’s Initial Evidence

- On March 3, 2022, the Cook County Board of Review was notified of the appeal and given an extension of time to submit evidence with a due date of June 1, 2022.
- On March 23, 2022, the Cook County Board of Review filed evidence consisting of a copy of its “Board of Review-Notes on Appeal” disclosing a total assessment for the subject property of \$52,419. The board of review indicated that 2018 was the first year of the general assessment cycle and indicated that this was a "Direct Appeal pursuant to 35 ILCS 200/16-185 and the decision in PTAB case #18-32372."
- The board of review completed a description of the subject property in the Comparable Sales/Assessment Equity Grid Analysis in the "Notes on Appeal" but provided no additional evidence of value. The board of review did not request a hearing.

On April 21, 2022, the **PTAB notified both parties that the filing period for submitting evidence in the appeal was closed.** The appellant was provided a copy of the evidence submitted by the board of review, and the 30-day rebuttal period began.

Board of Review's Second Submission of Evidence (After Evidence Closed).

- On April 29, 2022, the Cook County Board of Review submitted "Amended Notes on Appeal" with a completed Comparable Sales/Assessment Equity Grid Analysis containing four comparables, three of which were sold. Additionally, the board of review requested a hearing.
- On May 2, 2022, the appellant was mailed a copy of the "Amended Notes on Appeal" filed by the board of review.

Appellant's Motion.

On May 17, 2022, the appellant, through his attorneys, filed a Motion to Reject Respondent's Untimely Disclosure of Supplemental Documentary Evidence.

In support of this motion, the appellant's counsel reiterated the above facts concerning the filing of the documents by the parties. Counsel then explained that on April 28, 2022, the appellant's counsel emailed the board of review a proposed stipulation in an effort to timely resolve the matter without the PTAB having to incur the time and expense of issuing a decision (Exhibit D). On April 29, 2022, the board of review emailed the appellant's counsel a response rejecting the proposed stipulation explaining that a BOR analyst reviewed the stip and did not approve the 2019 or the 2020 appeals as rollovers and further stated, "These will have to wait until PTAB schedules a hearing." (Exhibit E)

Later that same day, the appellant's counsel received an email from the PTAB enclosing a copy of entirely new supplementary documentary evidence and amended Notes on Appeal, which PTAB said was received from the board of review by email that day. The appellant's counsel also received a letter dated May 2, 2022, from the PTAB enclosing the same new supplementary documentary evidence. (Group Exhibit F).

Counsel argues that the board of review's new supplementary documentary evidence was filed during the appellant's rebuttal evidence period, attached to the Motion as Exhibit G.

Counsel argued that section 1910.40(a) of the PTAB's rules grants the board of review 90-days to submit all written and documentary evidence. Section 1910.40(d) further provides that the PTAB may grant the board of review a 30-day or longer extension for good cause shown upon receiving a request in writing. The appellant's counsel further argued that Section 1910.40(d) notably provides in part that, "*Without a written request for an extension, no evidence will be accepted after the Board of Review Notes on Appeal is filed.*" (86 Ill.Admin.Code 1910.40(d))

Counsel argued that this section is not discretionary and that without a request for an extension, the PTAB must reject any evidence submitted by the board of review after its Notes on Appeal have been filed. The appellant contends that the board of review filed its Notes on Appeal on March 23, 2022, and the evidentiary submission period closed on April 21, 2022, and the appellant's rebuttal period commenced. Appellant's counsel argued that the board of review submission of evidence on April 29, 2022, should be rejected.

Alternatively, counsel argued that the board of review evidence filed on April 29, 2022, is improper rebuttal evidence as section 1910.66(c) of the PTAB's rules states that "*Rebuttal Evidence shall not consist of " of new evidence such as an appraisal or newly discovered comparable properties. A party to the appeal shall be precluded from submitting its own case in chief in the guise of rebuttal evidence."* (86 Ill.Admin.Code 1910.66(c)). Counsel argued that the board of review amended "Notes on Appeal" consists of new evidence, including newly discovered comparables, not allowed as rebuttal evidence.

Counsel further argues that if the board of review untimely disclosure of additional documentary evidence is rejected, there will be no timely written request from any party for a hearing on this matter. Therefore, the PTAB should issue a written decision on the evidence without hearing.

Finally, and only if the appellant's motion is denied and PTAB accepts the board of review's untimely disclosure of supplementary documentary evidence, the appellant requests the PTAB accept the enclosed and timely filed rebuttal evidence.

For these reasons, the appellant requests that the PTAB enter an order rejecting the untimely disclosure of supplementary documentary evidence by the Cook County Board of Review and issue a final administrative decision based on the documentary evidence submitted.

Motion to Reinstate & Withdraw

On May 17, 2022, the PTAB issued decisions in each of the above appeals based on a stipulation signed by the parties to the appeals.

On May 31, 2022, counsel for the appellants submitted a request to the Property Tax Appeal Board to rescind the recently issued decisions and withdraw the above referenced appeals.

The appellants' counsel explained that the basis for the request is due to an administrative error in processing settlements for the above-referenced five (5) dockets that were a subset of hundreds of residential cases set for hearing over the past few months. As part of the settlement process, the appellants inadvertently executed stipulations instead of submitting a withdrawal request for each appeal. The recently issued decisions resulted in an increase in the assessed value for the above-referenced dockets, none of which was contemplated by the parties.

Accordingly, the appellants request that the Property Tax Appeal Board enter an order to allow the reinstatement and subsequent withdrawal of the above-referenced dockets.
