Board of Review Motion for Extension of Time

The Lake County Board of Review (BOR) was notified of the appeal on January 20th, 2022, and granted a 90-day extension to submit evidence with a due date of April 20th, 2022. By letter dated March 30th, 2022, the BOR requested the PTAB grant an additional 90-day extension to submit evidence. On March 30th, 2022, a final 90-day extension was granted with a due date of July 19th, 2022.

By email on June 10th, 2022 (no postmark date), the Lake County Board of Review requested an additional 120-day extension to finalize pending settlement offers for multiple years and allow the 2022 publication, which is projected to be July 14th, 2022, and the BOR process to proceed.

The BOR has had 180 days in extensions and is requesting 120 more days.

b. Covia Corp Utica Plant: #20-07934-I-3 (LaSalle)

Intervenors' Motions for Extensions of Time

On March 8th, 2022, the Board of Education of LaSalle-Peru Township High School District No. 120 (District #120) filed its Request to Intervene. On March 17th, 2022, the PTAB granted District #120 a 90-day extension to submit evidence with a due date of June 15th, 2022. On June 8th, 2022, District #120 requested an additional 180-day extension.

District #120 asserts it is working in tandem with another intervening party – Waltham Community School Dist. - in this matter to acquire a fair appraisal that appropriately attends to the unique valuation of these properties. Due to the complexity of this matter and the difficulty in acquiring a qualified appraiser, District #120 is requesting an extension of one hundred eighty (180) days to file evidence or a brief in this appeal.

Waltham Community Consolidated School Dist. No. 185 (Waltham School Dist.) filed its request to intervene on January 31st, 2022, requesting a 90-day extension to submit evidence. On February 17th, 2022, the PTAB granted Waltham School Dist. a 90-day extension with a due date of May 18th, 2022. On May 18th, 2022, Waltham School Dist. filed a request for a 180-day extension to submit evidence supported by an affidavit of counsel explaining the difficulty in locating a mineral valuation expert appraiser due to the use of the property in silica manufacturing. Waltham School Dist. expects to complete its search for a qualified mineral valuation expert within thirty (30)-days of the May 18<sup>th</sup> letter. Counsel also explained that the parties are working together to arrive at a fair property tax assessment.

The subject property is composed of 37 PINs comprising approximately 1,963 acres, with improvements consisting of structures associated with the extraction and processing of silica material. In summary, there are 34 separate buildings on the subject property, ranging in size from 336 to 42,000 square feet.

- c. Grand Tower Energy Center LLC: #20-06868-I-3 (Jackson)

Intervenor's Motion to Dismiss – Carried forward from the PTAB's May meeting.

#### Procedural History

This Motion to Dismiss appeared before this Board during the May 2022 board meeting. In May, the Intervenor's attorney advised that the issues presented in this Motion are identical to those in a case that was, at that time, pending before the Illinois Appellate Court. The Board continued this matter to the July 2022 Board meeting on the chance that the Appellate Court might issue a decision addressing the issues presented here. The case pending before the Appellate Court addressed the issues identical to the ones in this Motion and involved the same parties. On June 17th, 2022, the Appellate Court published its decision.<sup>1</sup>

#### Relevant Facts

The following is a brief recitation of the facts.<sup>2</sup> This case involves the property tax assessment of the Grand Tower Energy Center LLC ("Grand Tower"), a power plant in Jackson County, for the tax year 2020. The School District and BOR aver that on October 19th, 2021, Grand Tower's 2020 real estate taxes of \$2,275,845 came due. According to the School Board and BOR, instead of paying the 2020 taxes under protest, as required by 35 ILCS 200/23-5, Grand Tower chose to default on paying the taxes. On December 10th, 2021, the circuit court entered an order finding that the entire 2020 taxes associated with Grand Tower property, \$2,275,845, was delinquent and ordered the taxes sold at a tax sale. As a result, the School District and other Jackson County taxing districts risk losing approximately half of their expected local tax revenue. The School District and the BOR argue that the relief sought by the Grand Tower at the PTAB is limited to a refund of property taxes paid. They contend that since Grand Tower did not pay its taxes within 60-days of the first penalty date, the PTAB must dismiss the appeal. The School District and the BOR further contend that once the Order of Tax Judgement was entered against the subject's property, Grand Tower could no longer contest the taxes, and due to the tax sale, the PTAB lacks jurisdiction over the appeal.

The Appellate Court rejected the argument put forth by the School District and BOR. The Appellate Court ruled that a plain reading of Sections 23-5, 23-10, and 23-10 of the Property Tax Code demonstrates that section 23-5 does not apply to appeals filed with the PTAB requiring any person objecting to his or her taxes to pay all taxes due within 60-days of the due date. The payment requirement set forth in section 23-5 of the Code applies to tax objections filed in the circuit court. *Shawnee Cmty. School Dist. No. 84 v. Illinois Property Tax Appeal Board*, 2022 IL App (5<sup>th</sup>) 190266, ¶51.

- d. John T. Cooper: #21-06952-R-1 (Cass)

Motion to Dismiss

Issue: This is a jurisdictional question. The BOR contends that the appellant filed this appeal late and therefore, PTAB lacks jurisdiction over this matter.

Relevant Dates and Facts:

1. 3/17/2022 – Final Notice of Assessment from the Cass County Board of Review.
2. 4/18/2022 – Last Day for the appellant to file an appeal after the 30 days from the Final Notice of Assessment. Calculated by counting 30 days after the 3/17/2022 date. The resulting date is 4/16/2022, a Saturday. 4/18/2022 is the next business day.
3. 4/20/2022 – Date the envelope containing this appeal was postmarked.

On June 8th, 2022, the Cass County Board of Review hand delivered a Motion to Dismiss based on the fact the appellant and his representative, Nancy E. Steffen, Power of Attorney, did not file or have postmarked the appeal by April 16th, 2022. The board of review asserted the Final Notice of Assessment was dated and postmarked March 17th, 2022.

The PTAB notified the appellant of the Motion to Dismiss by letter dated June 9th, 2022. By letter postmarked June 24th, 2022, the appellant acknowledged receipt of the Cass County BOR final decision dated March 17th, 2022 but contends he did not receive the final decision until March 20th, 2022; therefore, he believes he replied within the 30-day timeline.
