Motion to Vacate & Reinstate

The appellant states during the summer of 2021 the Cook County Board of Review (BOR) engaged in a summer project with the law firm Crane and Norcross, LLC

(“Crane”) to resolve all outstanding 2017 residential appeals. Over 700 PTAB matters were resolved between Crane and the BOR through either a withdrawal, stipulation or agreement to have the matter written on evidence. At some point, during communications between Crane and the BOR, the above reference matters were unintentionally withdrawn when the intention was to have the matters written on evidence.

The appellant requests that PTAB vacates the withdrawal of the above-referenced matters, reinstate the appeals and have the decisions written on evidence previously submitted, without hearing.

The Cook County Board of Review has no objection to the Motion to Vacate and Reinstate.

b. Ursa Farmers Co-Operative Co.: #21-02981-C-3 (Adams) – Subpoena Request

The subject property is improved with a grain elevator with a storage capacity of 2,832,000 bushels. The grain bins and associated building improvements are around one year old. The appellant contends assessment inequity using equity comparables and overvaluation based on comparable sales supported with cost schedules from IDOR publication 126.

Intervenor’s Request for a Subpoena Duces Tecum

Central Community Unit School District No. 3 (the Intervenor) filed its Request to Intervene. On 04/28/2022, the PTAB granted the Intervenor a 90-day extension to submit evidence with a due date of 7/27/2022.

On 07/08/2022, the Intervenor hand-delivered a Motion for a Final 60-day Extension of Time to Submit Documentary Evidence to the PTAB.

On 07/21/2022, the PTAB granted a 60-day extension which extended the due date for documentary evidence until 9/19/2022.

On 08/04/2022, the Intervenor filed a Request for the issuance of a Subpoena *Duces Tecum*. The Intervenor avers the appellant has raised in part the issue of the cost of construction, therefore, the cost to construct the various improvements is relevant to a final determination of this appeal.

Steps Taken by Intervenor to Obtain Information without a Subpoena:

The Intervenor explained that on 07/05/2022, it requested from the Appellant the subject property’s construction costs with a due date of 07/20/2022.

The Appellant informed the Intervenor on 07/22/2022, that it would comply with the Intervenor’s request and submit the costs by “next week.” As of the filing date

of this request (8/4/2022), the Intervenor has not received the requested construction cost documentation from the Appellant.

Subpoena Request:

The Intervenor requests the PTAB issue a subpoena *duces tecum* requiring the Appellant to disclose the following records within 30 days of issuance:

- A. All building permits issued to general and sub-contractors involved in the construction of each improvement located on the subject property, including but not limited to four (4) grain bins, dryer, two (2) scales, dump building, warehouse, and office.
- B. All taxpayer documents and correspondence relating to the construction cost of each improvement, including but not limited to documents filed with the state, county, township, or municipal units of government or agencies, and
- C. General and subcontractor statements, sworn or otherwise, and affidavits, together with labor costs, both direct and indirect, that relate to the construction of the subject's improvements.

Extension of Time:

Additionally, the Intervenor's current extension deadline to submit evidence ends on 09/19/2022. Should the PTAB grant the Intervenor's subpoena request, the Intervenor contends it will need additional time upon receipt of the Appellant's construction costs to review the documents, consult with a valuation expert to determine if an appraisal of the subject will be needed, and prepare its documentary evidence submission to PTAB.

The Intervenor requests the PTAB issue a subpoena *duces tecum* to the Appellant requiring the disclosure of all documentation related to the costs to construct each improvement comprising the subject property. Secondly, the Intervenor requests a 60-day extension to file documentary evidence from the date the Intervenor's subpoena request is issued.
