Motion to Vacate Default and Reinstate

These cases involve the property tax assessment of Dakin Self Storage at 6500 W. Dakin St., Chicago, IL, for 2017 and 2018. The appellant's motion requests that the PTAB vacate two separate defaults. The first default concerns the appellant's failure

to provide a court reporter at a scheduled hearing, and the second involves the appellant's untimely filing of a direct appeal.

1-Failure to Provide a Court Reporter.

On 06/02/2022, the PTAB sent a Notice of Virtual Hearing for Docket Nos. 17-35773 & 18-35390 for 07/05/2022, at 9:00 a.m. The hearing notices stated that the appellant was responsible for providing a court reporter at its own expense for the hearing since the appellant is seeking a change of \$100,000 or more.

On 07/05/2022, at the scheduled hearing time, the ALJ, Intervenor, Board of Review's Attorneys, and appellant's counsel appeared for the virtual hearings. The ALJ asked the appellant's counsel if his court reporter was present, and counsel informed his assistant had scheduled the court reporter. The ALJ postponed the hearing until 9:15 a.m. to allow time for the appellant's counsel to find a court reporter. At 9:15 a.m., the appellant's counsel informed us it would be at least 9:30 a.m. before a court reporter would be available. The ALJ then found the appellant to be in default pursuant to Section 1910.69(d) of the Property Tax Appeal Board rules. The PTAB has not formally voted on and issued a decision of default.

On 7/30/2022, the appellant, through counsel, filed a Motion to Vacate Default and Reinstate the appeals. The appellant explains that on 05/24/2022, the parties agreed and set a second hearing date for 07/05/2022 at 9:00 a.m. A previous hearing date was rescheduled because of a scheduling conflict.

According to the appellant, on 07/04/2022, the Law Office of Ronald Justin, the appellant's counsel, was notified and advised that the court reporter scheduled for the hearing had a family emergency involving a shooting over the holiday. On 07/05/2022, at 9:00 a.m., all parties appeared for the scheduled hearing. The PTAB's ALJ then granted the appellant's counsel a 15-minute window to contact and secure a new court reporter. The appellant's counsel was able to reach a court reporter, who indicated they could be present at 9:30 a.m. and advised all the parties present at the hearing of the same. The ALJ, on the [PTAB]'s motion to enter an Order of Default against the Petitioner (appellant) in the matter and the Respondent (Intervenor), seconded the motion. The appellant's attorney objected and advised the PTAB of the above facts. The ALJ then entered an Order of Default against the Petitioner.

The appellant contends that given the fact that he was notified on a holiday that the court reporter could not attend, he was unable to secure a replacement court reporter. Counsel argues that it is a daunting task to get a court reporter on short notice on a holiday weekend.

On 08/09/2022, PTAB notified the Appellee Cook County BOR, and Intervenor Chicago Board of Education (BOE) of the appellant's Motion to Vacate Default and Reinstate and were granted 15 days to respond. On 08/24/2022, Intervenor Chicago BOE and Appellee Cook County BOR provided a joint response to the appellant's Motion to Vacate Default. The Chicago BOE and Cook County BOR stated that on 07/05/2022, at 9 a.m., all parties and witnesses, including the Administrative Law

Judge, were present via WebEx for a hearing on this matter. Pursuant to the Property Tax Code and the rules of the PTAB, Dakin Self Storage was required to produce a court reporter for the hearing. However, Dakin Self Storage failed to do so, and an order of default against Dakin Self Storage was entered.

The Intervenor Chicago Board of Education and Appellee Cook County BOR assert that in accordance with Section 16-190 of the Property Tax Code (35 ILCS 200/16-190) and Section 1910.98(a) of the rules of the PTAB (86 Ill. Admin. Code §1910.98(a)), in all cases where the contesting party is seeking a change of \$100,000 or more in assessed valuation, the contesting party must provide a court reporter at their own expense.

They also contend that Illinois Supreme Court Rule 361(a) provides that when the motion is based on facts that do not appear on the record, it shall be supported by affidavit or verification by certification pursuant to section 1-109 of the Code of Civil Procedure. Dakin Self Storage's Motion to Vacate Default failed to include an affidavit from the court reporter that was originally scheduled to be present at the July 5, 2022 hearing, confirming that the reporter was scheduled to attend but had an emergency preventing the reporter's appearance. The Motion to Vacate also failed to provide any evidence, such as receipt or confirmation from the court reporter, establishing the reporter was retained for the July 5, 2022, hearing. The Motion to Vacate also failed to provide an affidavit from counsel for Dakin Self Storage to support its claims that it had secured a court reporter for attendance at the July 5, 2022, hearing. The Intervenor and Appellee request the PTAB deny the Petitioner's Motion to Vacate Default as it is absent of any evidentiary support.

On August 11, 2022, the ALJ requested that the appellant's attorney obtain an affidavit from the court reporter attesting to the fact that she canceled the engagement. It was not until August 26, 2020 - after the Intervenor and BOR filed their objection - that Mr. Justin responded with an affidavit from the court reporter Toni Rae Pileggi (sp?). According to the affidavit, the court reporter states that the appellant's counsel retained her to be the court reporter and be present on July 5, 2022, and transcribe the property tax appeal. However, on July 4, 2022, she informed the Law Office that she had a family emergency and would not be able to appear and or transcribe the hearing set for July 5, 2022, at 9:00 a.m.

2-Untimely Appeal

A second issue, with respect to PTAB Docket No. 17-45892-C-2, the appellant stated that on 08/21/2020, a Friday, a direct appeal was filed regarding the same property from a PTAB decision for the prior tax year in Docket Number 16-38670-C-3 issued on Tuesday, July 21, 2020. The appellant explained that the tax year 2016 was the general assessment year for the subject property. The PTAB time stamped (received) the appeal on 08/24/2020 and the USPS time stamp (postmark) was 08/21/2020. The appellant recently learned that PTAB sent out a notice on 03/10/2022, which the appellant contends it did not receive, stating the above direct appeal was not filed

timely. The appellant does not believe this is true per the information stated above. (30 days from Tuesday, July 21, 2020, expired on Thursday, August 20, 2020.)

b. Grand Tower Energy Center LLC: #20-06868-I-3 (Jackson)

Appellant's Motion to Dismiss Intervenor, Shawnee Community Unit School District (CUSD) No. 84 (School District)

This case involves the property tax assessment of Grand Tower Energy Center LLC ("Grand Tower"), a power plant located in Jackson County, for the tax year 2020. The Fifth District recently upheld the Property Tax Appeal Board (PTAB) decision for the 2014/2015 tax years.

The appellant, Grand Tower Energy, filed the Motion to Dismiss the Intervenor, School District, in the above matter based on an amendment to section 18-233 of the Property Tax Code that became effective on August 20, 2021. Section 18-233 (35 ILCS 200/18-233), which is within the Property Tax Extension Limitation Law (PTELL), provides:

Adjustments for certificates of error, certain court orders, or final administrative decisions of the Property Tax Appeal Board. Beginning in the levy year 2021, a taxing district levy shall be increased by a prior year adjustment whenever an assessment decreases due to the issuance of a certificate of error, a court order issued pursuant to an assessment valuation complaint under Section 23-15, or a final administrative decision of the Property Tax Appeal Board results in a refund from the taxing district of a portion of the property tax revenue distributed to the taxing district. On or before November 15 of each year, the county treasurer shall certify the aggregate refunds paid by a taxing district during such 12-month period for purposes of this Section. For purposes of the Property Tax Extension Limitation Law, the taxing district's most recent aggregate extension base shall not include the prior year adjustment authorized under this Section.

The appellant contends that in accordance with Section 1910.60(d)(1) of the PTAB's rules (86 Ill.Admin.Code 1910.60(d)(1)), taxing bodies are to have a revenue interest in an appeal before the PTAB to become an intervening party. However, the appellant asserts that taxing bodies can now recoup property tax revenue lost due to property tax refunds in accordance with Section 18-233 of the Code. (35 ILCS 200/18-233.) The appellant argued the increase in the taxing district's levy as provided by Section 18-233 is mandatory and not discretionary. Therefore, any refunds obtained pursuant to a PTAB decision are passed on to taxpayers in the subsequent year's levy, and since Section 18-233 requires an increase to the subsequent year's tax levy, a decision of the PTAB is revenue neutral to taxing bodies. As such, the Intervenor, School District, lacks standing in this matter because it is no longer a taxing body that has a revenue

interest in an appeal before the PTAB, and there will be no revenue loss to the Intervenor. The appellant requested the School District be dismissed from the appeal.

On 08/01/2022, Intervenor Shawnee CUSD No. 84 (School District) filed Intervenor's Response to Appellant's Motion to Dismiss. The Intervenor stated that pursuant to the practice and procedure for appeals before the PTAB, any taxing body that has a revenue interest in an appeal before the PTAB may become an intervening party. (86 Ill.Admin.Code §1910.60(d)(1)).

The Intervenor acknowledged that the appellant's Motion to Dismiss claims that Shawnee CUSD No. 84 lacks a revenue interest in this appeal due to an amendment to the Property Tax Extension Limitation Law (PTELL), which permits county tax officials to recover property tax refunds from taxing districts that are subject to the PTELL. This provision of the code allows certain taxing districts to recapture refunds resulting from PTAB appeals in a subsequent tax levy.

The Intervenor stated that the Illinois Attorney General, the Jackson County State's Attorney, and the Jackson County Treasurer have found that the refund recapture legislation does not apply to Shawnee CUSD No. 84 because the school district is not a PTELL district. (The School District provided a copy of an informal response from the Attorney General to the Vermilion County State's Attorney on the application of Section 18-233 (Exhibit A), a letter from a Jackson County Assistant State's Attorney regarding Section 18-233 (Exhibit B), and a notice from the Jackson County Treasurer applying Section 18-233 only to taxing districts subject to PTELL (Exhibit C)). Therefore, Shawnee CUSD will continue to incur refunds (revenue loss) resulting from PTAB reductions which cannot be recaptured under Section 18-233.

Additionally, the School District contends it has a revenue interest in PTAB proceedings apart from refunds because of the impact not only on tax funds available for the year in question but for other reasons, including the overall effect on the tax base upon which the taxing district relies. Furthermore, when assessments are reduced, a taxing district's tax rates are increased to compensate for the lost revenue from the taxpayer who received the reduction. Ultimately, these reductions can cause taxing districts to face tax rate limitations that result in increased taxes for their constituents and impede their ability to provide funding for their educational staff, services, and students. Other recognized revenue interests in PTAB proceedings include the taxing district's right to initiate PTAB appeals and the right to seek increases in PTAB appeals initiated by taxpayers. Legislature has granted taxing districts the statutory right to intervene in County Boards of Review appeals even though BOR reductions do not result in refunds.

The Intervenor also argued the PTAB's jurisdiction concerns assessments and not taxes contending the Board's rules provide that the PTAB is without jurisdiction to determine the tax rate, the amount of a tax bill, or the exemption of real property from taxation. 86 Ill.Admin.Code §1910.10(f).

The Intervenor requested that PTAB deny the Appellant's Motion to Dismiss.

c. Amerco Real Estate Company: #20-46115 C-3 (Cook – Bloom Twp.)

Village of Glenwood's, Intervenor, Motion for an Extension

This case involves the property tax assessment of the Amerco Real Estate Company for the tax year of 2020. The property is composed of a 1,026,399 square foot site improved with a one-story retail building with approximately 155,597 square feet that has been modified to accommodate lockers for self-storage and truck and trailer rental.

On 01/10/2022, the Village of Glenwood timely filed a Request to Intervene and requested a 30-day extension of time to file additional evidence.

On 01/27/2022, the PTAB notified the Village of Glenwood that it had been added as an Intervenor. The PTAB granted the Village an extension until 04/27/2022 to submit evidence.

On 04/26/2022, the Village of Glenwood filed a request for an extension of time to submit evidence with the PTAB asserting that it was determined that it needed to obtain a full appraisal but before spending funds for an appraisal, the appellant, with the support of the Village, has contacted Cook County about obtaining a Class 8 Property Tax Incentive, which would assist in the resolution of the appeal without the need for the Village to expend funds for an appraisal.

On 05/19/2022, the PTAB granted the Intervenor, Village of Glenwood, a final 90-day extension to submit evidence with a due date of 08/17/2022.

On 08/12/2022, the Intervenor, Village of Glenwood, submitted a Motion for a Final Short Extension to Submit Appraisal Evidence. The Intervenor explained it had engaged an appraiser who is completing a full appraisal of the subject property of this appeal. In an affidavit submitted with the motion, the appraiser advised he has 90% of the information needed for the appraisal but needs an additional 3 weeks, until 09/07/2022, to complete his appraisal of the subject property as he needs to complete the following:

The appraiser has attempted to schedule an inspection of the property with the appellant; however, the appraiser has been unable to do so and is relying upon the Village's influence to get an inspection with the appellant. The appraiser estimates that the inspection will not be completed until the week of August 15, 2022.

The appraiser is waiting to receive an itemized list of equipment that was added to the subject property to convert it from its prior use to its current use as a rental and self-storage facility.

The appraiser advised the subject property is more involved than most appraisals and requires more time to synthesize the data already received with the additional data still desired to complete the appraisal.

The appraiser advises that a 3-week extension of time is necessary to complete the assignment.

The Intervenor asserts that granting a 3-week extension to complete an appraisal of the subject property is necessary to achieve substantial justice so that the matter can be appropriately decided on the merits. The Village also contends that no party will be prejudiced by granting the short extension, and given the current backlog in PTAB cases and the fact this matter will not be set for hearing for several years, it would be an abuse of discretion for PTAB to deny the extension request and deprive the ability itself of the ability to decide the matter on all available evidence.

d. Richard Parrilli: #21-07127-R-2 (DuPage)

Motion to Vacate Dismissal and Reinstate

The appellant, through counsel, filed the appeal marking recent sale and construction as its basis. The appellant completed Section VI of the appeal (Recent Construction Information on Your Residence), stating that the land was purchased on May 28, 2019, for a price of \$537,000, and the building cost \$800,000. Submitted with the appeal was a copy of a settlement statement dated May 28, 2019, disclosing the purchase of the land for a price of \$537,000. The appellant also submitted a copy of the Application for Building Permit & Plan Review identifying the contractors and the approximate job cost of \$800,000. The appellant also submitted a copy of a certificate of occupancy dated August 23, 2021.

On 05/19/2022, the PTAB notified the appellant of an incomplete petition requesting Section IV – Recent Sale Data of the appeal be completed and further requested documentation of the land purchase and construction costs associated with the construction of the dwelling. The appellant was given 30 days to provide the requested documents with a due date of 06/18/2022.

On 07/28/2022, the PTAB dismissed the appeal for failure to respond to the incomplete checklist and the failure to submit sufficient evidence to challenge the assessment.

On 8/29/2022, the appellant, through counsel, filed a Motion to Vacate Dismissal and Reinstate. The appellant states that on or about June 15, 2022, the appellant responded to PTAB's Incomplete Appeal Checklist correspondence addressing all concerns and included a copy of the initially submitted appeal as the original appeal submitted had

all the information that was checked missing on the correspondence received from PTAB. A copy of the purported response was marked as Exhibit A and included the previously identified documents as well as a completed Section IV – Recent Sale Data of the appeal regarding the land purchase. (IT did not find anything in DocuWare or the system that the PTAB received the 6/15/22 response from the appellant.)
