 - a. **Development LLC: #21-07091-C-2 (DuPage)**

Motion to Reinstate

This appeal involves the 2021 property tax assessment of Development, LLC at 400 S. County Farm Rd., Wheaton, IL. The property is composed of eight parcels (PINs). The PTAB dismissed this appeal because the appellant failed to submit

evidence to meet its burden of proof on time. The appellant now seeks to vacate that dismissal and reinstate the appeal.

Relevant Facts:

- 03/24/2022 – the DuPage County Board of Review (BOR) entered its 2021 assessment decisions for Development LLC, establishing a combined total assessment of \$810,160, reflecting a market value of approximately \$2,430,480.
- 4/22/2022 – the appellant, through counsel, filed the appeal with a postmark date of 04/22/2022 and requested a 90-day extension to prepare and submit evidence supporting the appeal.
- 05/19/2022 – the PTAB granted the appellant a 90-day extension with a due date of 08/17/2022 – a Wednesday.

The relevant portion of the 5/19/2022 letter:

The Property Tax Appeal Board is also in receipt of your request for an extension of time for the submission of evidence. Please be advised that the Board is hereby granting an extension of time to August 17, 2022.

- 08/18/2022 – the appellant, through counsel, submitted its evidence and a cover letter. The cover letter is dated 08/16/2022. The postmark on the envelope containing the evidence is dated 08/18/2022 (see below). The PTAB received the evidence on 8/22/2022. The appellant submitted an appraisal estimating the subject property had a market value of \$1,820,000 as of January 1, 2021.



- 09/08/2022 – the PTAB sent a letter to the appellant notifying the PTAB received and reviewed the submitted information; however, the Appellant did not provide substantive, documentary evidence or legal argument sufficient to challenge the correctness of the assessment of the subject

property. The PTAB found the information did not satisfy the burden of going forward, dismissed docket number 21-07091, and closed the file.

- 09/16/2022 – the appellant, through counsel, submitted this Motion to Reinstate the Appeal, arguing it had submitted a legal brief with supporting evidence, including an ad valorem appraisal valuing the subject property as of 01/01/2021, and that this evidence is sufficient to challenge the correctness of the assessment set by the DuPage County BOR.

b. Sidell & Kodjayan Properties, LLC: #20-39174-C-1 (Cook – Lake View)

Motion to Vacate and Withdraw

The appellant timely filed the appeal from the Cook County Board of Review decision issued on March 22, 2021, establishing a final total assessment of \$24,280. The appeal was based on assessment inequity, and the appellant requested a revised total assessment of \$7,191.

- 08/10/2022, the Appellant and the Cook County Board of Review executed a Stipulation of Assessment(s) by the Parties for a total stipulated assessment of \$28,495.
- 09/20/2022, the PTAB issued a decision according to the assessment agreement establishing a total assessment of \$28,495.
- 09/26/2022, the Appellant requested to vacate the PTAB’s decision dated 9/20/2022 and withdraw the appeal as the original Cook County BOR assessment of \$24,280, dated 3/22/21, is lower than the stipulated amount of \$28,495 that the parties agreed to on 08/10/2022.
- 09/26/2022, the Cook County BOR informed the PTAB and the appellant that it had no objection to the withdrawal request.

**c. Jon & Jennifer Groh: #17-02963-C-1 (Lake)
Jon & Jennifer Groh: #17-02965-C-1 (Lake)
Jon & Jennifer Groh: #17-02966-C-1 (Lake)**

Motion to Reinstate and Schedule New Hearings

These three appeals involve the tax assessments on three properties owned by Jon & Jennifer Groh located at 1618 Kildeer Dr., Round Lake Beach, IL; 1513 Round Lake Dr., Round Lake Beach, IL; and 408 E. Clarendon Dr., Round Lake Beach, IL for the 2017 tax year. The appellants are self-represented and requested a hearing in each appeal.

On 02/04/2020, the PTAB notified the appellants of hearings for the above-referenced appeals scheduled for 04/29/2020 in Lake County.

On 03/31/2020, the PTAB notified the appellants, the Lake County BOR, and the Lake County State's Attorney that the hearings scheduled for 04/29/2020 were postponed. The hearings were postponed due to COVID.

On 06/15/2022, the PTAB notified the appellants of the rescheduled hearings for the above three appeals, set for 09/13/2022, at the Lake County Board of Review offices. The appellants did not appear for the scheduled hearings.

On 09/29/2022, the PTAB notified the appellants, the Lake County BOR, and the Lake County State's Attorney that the above-referenced appeals were dismissed for failure of the appellants to appear at the hearings scheduled on 09/13/2022.

On 10/04/2022, by e-mail, the appellants filed a request to reinstate the above-referenced appeals. The appellants asserted that they did not receive the letters mailed in June 2022, setting the matters for hearing even though the address was correct. They contend they have several properties and have appealed at PTAB before, and would never miss an appeal or want to waste anyone's time. Therefore, the appellants requested that the above-referenced three appeals be reinstated and scheduled for new hearings.

The BOR was notified of the appellants' request by e-mail. The BOR responded and had no objection to the motion.
