  - a. Marc Lifshin: #20-48594.001-R-1 (Cook – West Chicago)

Motion to Vacate Decision & Withdraw

**Relevant Facts**

- On 02/23/2022, the appellant filed this 2020 tax year appeal from a favorable PTAB decision issued for the 2019 tax year, establishing a total assessment of \$110,723.

- On the appeal, the appellant contends that the subject property was owner occupied, had a total assessment for the 2020 tax year in the amount of \$106,870 and requested the assessment be reduced to \$97,500 based on an appraisal estimating the subject property had a market value of \$975,000 as of January 1, 2018.
- On 04/12/2022, the CCBOR filed its "Notes on Appeal," disclosing the total assessment of the subject property of \$106,870. The BOR also stated that it had no objection to the appellant's rollover request and that 2018 was the first year of the general assessment cycle.

**PTAB's Decision:**

- On 09/20/2022, the PTAB issued a decision establishing a total assessment of \$110,723 based on the "rollover" provision of section 16-185 of the Property Tax Code, which increased the subject's assessment for the 2020 tax year.

**Appellant's Motion:**

On 10/14/2022, the appellant, through counsel, filed a Motion to Vacate the PTAB Decision and Withdraw the Appeal. The appellant asserts he filed the appeal on 02/23/2022 based on an interim decision from the CCBOR, which was inadvertently misapplied. The appellant submitted a copy of the CCBOR's final decision for the 2020 tax year dated 2/08/2021, which established a total assessment of \$106,870, which is below the assessment determined in the PTAB's decision for the 2019 tax year. The appellant contends that an unjust and inequitable evaluation would result if the PTAB's decision is not vacated and the appellant is not allowed to withdraw the appeal. Therefore, the appellant requests the PTAB to vacate the 09/20/2022 decision and allow the appellant to withdraw the appeal for the 2020 tax year.

- b. Lumanair, Inc.: #21-05200.001 thru .006-C-2 (Kane)

**Motion to Request an Extension & Accept Submitted Evidence**

This appeal involves the leasehold interest of Lumanair, Inc., regarding the assessment of multiple parcels (6 PINs) owned by the City of Aurora at Aurora Municipal Airport, Sugar Grove, IL, for the 2021 tax year. On 01/07/2022, the Kane County Board of Review (BOR) issued its 2021 assessment decision for Lumanair, Inc. establishing a total assessment of \$528,028. The appellant requested the subject's total combined assessment be reduced to \$325,350. Lumanair, Inc. filed an appeal postmarked 01/18/2022 from the board of review decision and requested a 90-day extension to submit evidence.

- On 03/10/22, the PTAB granted the appellant an extension of time to submit evidence to expire on 06/08/22. The appellant submitted its evidence consisting of an appraisal in an envelope postmarked 06/03/2022.

- On 06/16/2022, the PTAB notified the Kane County BOR of the appeal and provided the BOR a copy of the appellant's evidence. The PTAB notified the Kane County Board of Review (BOR) it had until 09/14/2022 to submit its evidence or request for an extension of time to submit evidence. The BOR did not submit any evidence by this deadline.
- On 09/29/2022, the PTAB notified the parties that all evidence had been submitted, the filing period for submitting evidence was closed, and each party had a 30-day rebuttal period to address any new evidence that was enclosed, if any.
- On 10/03/2022 (in a letter dated December 10, 2020), the Kane County BOR filed a motion for an extension of time to submit evidence and included its evidence with the request.

Board of Reviews Mistake with Filing its Evidence:

- The BOR explained that on 08/26/2022, it had attempted to request an extension of time to submit evidence on these dockets. However, the BOR acknowledged; it made two mistakes:
  - (1) it transmitted the extension request through an electronic evidence portal that it has since learned was not an appropriate means of requesting an extension; and
  - (2) the BOR, through its Clerk, inadvertently transmitted the wrong PDF file.
- The Kane County BOR acknowledged and accepted responsibility for the mistakes and requested that the time for filing evidence be extended so the documents attached to the request may be admitted into evidence.

The PTAB's IT Department could not recall who talked to the Kane County BOR about this issue. However, the Kane County BOR was trying to use its electronic evidence filing process to submit these extension requests. The PTAB had nothing set up to process these types of requests. The BOR was told it needed to send extension requests by mail or email with a list of cases requesting an extension, similar to the process used by the Cook County BOR and the Lake County BOR. IT indicated that the Kane County BOR first filed evidence electronically on 04/08/22.

Appellant's Objection to the BOR's Motion:

- On 10/17/2022, the appellant objected to the Kane County BOR's motion for an extension of time to file evidence.
- The appellant avers the Kane County BOR failed to provide evidence prior to the letter from PTAB dated 09/29/2022, stating the filing period for submission of evidence was closed.
- The Kane County BOR's letter requesting an extension of time until October 3, 2022, was incorrectly dated 12/20/2020.

- The Notes on Appeal attached to the request were dated and signed on 10/03/2022, and the motion was not filed with PTAB until 10/03/2022, which was after the time for filing evidence had closed; therefore, the request to file its evidence is late.
- The appellant contends that a motion to file evidence after the time for filing is closed can only be granted upon a showing of good cause or excusable neglect. The appellant argued Kane County BOR's reasons for failure to timely file its evidence falls short of the standards. The methods for filing an extension are not overly hard and do not require technical expertise. The BOR negligently failed to confirm that its request was filed properly and negligently failed to discover its error until after the deadline had passed. The Kane County BOR failed to show good cause, and the admitted neglect is not excusable.
- The appellant's counsel argued that the Kane County BOR sending the wrong PDF file is even less excusable. Negligently sending the wrong file, failing to follow up and confirm the correct file was received and properly filed, and failing to discover its error until after the deadline had passed is inexcusable. Therefore, the Kane County BOR's motion should be denied.

From a procedural standpoint, on 09/29/2022, the appellant was granted a 30-day period from that date to submit rebuttal evidence solely addressing any new evidence enclosed with the letter from PTAB. No evidence was enclosed with this letter; therefore, the appellant accordingly filed no rebuttal evidence. Therefore, if the PTAB determines to allow Kane County BOR to file its evidence, the appellant must be given a 30-day period within which to file rebuttal evidence.

- c. THK America, Inc: #21-21377.001-I-1 (Cook - Schaumburg)

#### Motion to Reinstate Appeal

This appeal involves the property tax assessment of THK America, Inc. at 200 East Commerce Dr., Schaumburg, IL, for the tax year 2021.

#### **Relevant Facts:**

- On 05/09/2022, the Cook County Board of Review (BOR) issued its 2021 assessment decision for the property, establishing a total assessment of \$1,377,000.
- On 06/02/2022, THK America, Inc. filed an appeal requesting that the assessment be reduced to \$1,282,000. The appellant submitted an appraisal estimating that the subject had a market value of \$5,070,000 as of 01/01/2019. The appellant also provided a brief in which it requested that the subject's total assessment be reduced to \$1,282,000 to reflect a market value of \$5,128,000.

PTAB Determines that Petition was Incomplete:

- On 07/07/2022, the PTAB found the appellant's petition for appeal incomplete because the land and improvement requests on the petition totaled \$1,282,612 rather than \$1,282,000, and the appellant was given 30 days to complete the petition or request an extension, with a due date of 08/06/2022; the appellant did not respond.
- On 09/16/2022, the PTAB dismissed the appellant's petition because the information provided by the appellant did not satisfy the burden of going forward and for failure to comply with the Property Tax Appeal Board Rules, 86 Ill. Admin. Code §1910.30 (k) 1910.63(a), 1910.63(b), 1910.69(a).

**Appellant's Prayer for Relief:**

- On 10/06/2022, the appellant filed a motion requesting PTAB reinstate the appeal. The appellant acknowledged failing to print out the PTAB correspondence dated 07/07/2022 and failing to timely address the correspondence by correcting the calculation due to inadvertent error. The appellant thus requests the PTAB reinstate the appeal and allow time to submit the correction in the Appellant Assessment Request section on the appeal form. The appellant believes no prejudice will result to any adverse party by allowing the reinstatement of this appeal and correction of the requested assessment calculation.

d. Elwood Energy LLC: #21-05933.001 thru .002-I-3 (Will)

**Intervenor's Request for an Extension**

The subject property is composed of two parcels comprising a simple cycle gas-fired power plant with a combined land area of 68.30 acres. On 01/26/2022, the Will County Board of Review (BOR) issued its 2021 assessment decision for Elwood Energy LLC, establishing a combined total assessment of \$17,372,234. Elwood Energy, LLC filed an appeal postmarked 02/22/2022, from the board of review decision with an appraisal estimating the real property had a combined fair cash value of \$4,100,000 as of January 1, 2021, and the M & E had a value of \$201,764,700. The appellant requested that the subject's assessment be reduced to \$1,366,667.

**Relevant Facts:**

- On 04/07/2022, Elwood Community Consolidated School District No. 203 (School District) filed its Request to Intervene and requested a 90-day extension to submit evidence.

- On 05/12/2022, the School District was confirmed as an intervenor, and PTAB granted an extension of time for filing evidence, with a due date of 08/10/2022.
- On 08/08/2022, the School District requested an additional 60 days to submit evidence.
- On 08/25/2022, the PTAB granted the School District an extension until 10/24/2022 to submit its evidence.
- On 10/26/2022, the School District requested an additional 14 days to finalize the submission of evidence, as its appraiser needed no more than 14 days to finalize the appraisal. The School District's attorney inadvertently missed the date to request the extension because he was dealing with a medical issue.
- On 10/31/2022, the School District submitted its narrative appraisal of the subject property prepared by Robert Herman of Kroll, LLC estimating the subject property has a market value, inclusive of real and personal property, of \$330,000,000 as of January 1, 2021.

The appeal involves a differential of 15 million dollars concerning the Elwood Energy Peaker Plant. Counsel asserts that the appraisal will be used in mediation in this case and the JPower Combined Cycle case that will be heard at the end of November 2022 (appears to be referring to BOR hearings).

- Therefore, School District 203 requests an extension of 14 days from 10/26/2022 to provide additional evidence.

**Note:**

This is the same appraisal submitted by Laraway Community Consolidated School Dist. No. 70-C, intervenor, by correspondence, postmarked October 31, 2022. Laraway Community Consolidated School District No. 70-C had been granted a final 90-day extension on August 4, 2022, which expired on November 2, 2022.

- e. Kroger Limited Partnership I: #21-05509.001-C-3 (Tazewell)

**Intervenor's Request for an Extension**

This appeal involves the property assessment of Kroger Limited Partnership I at 201 S. Main St., East Peoria, IL 61611, for the tax year of 2021. On 01/05/2022, the Tazewell County Board of Review (BOR) issued its 2021 assessment decision for Kroger Limited Partnership I, establishing a total assessment of \$966,670. Kroger Limited Partnership I, through counsel, filed an appeal postmarked 02/01/2022, from the board of review decision, with a basis of recent appraisal.

On 05/05/2022, the City of East Peoria filed its Request to Intervene in the above matter and requested a 90-day extension to submit evidence.

On 07/14/2022, the PTAB confirmed the City of Peoria was named as an intervenor regarding the above petition, and the intervenor was granted an extension of time for filing evidence, with a due date of 10/12/2022.

On 10/12/2022, the City of East Peoria provided a copy of an appraisal report with an effective date of January 1, 2018. The City of East Peoria requested an additional 60 days to file additional evidence including but not limited to an update to the appraisal.

Without ruling on the extension request, on 10/27/2022, the PTAB notified the intervenor the filing period for submission of evidence regarding this petition was closed. A copy of all the evidence received was enclosed, and the intervenor was granted a 30-day period from the date of the letter to submit rebuttal evidence solely addressing any new evidence enclosed.

- f. Thomas Blank: #19-04401.001-R-1 (Lake)

#### Motion for Reconsideration

On October 18, 2022, the PTAB issued a decision in the above matter confirming the assessment of the subject property as established by the Lake County Board of Review, totaling \$162,727.

On 10/28/2022, Thomas Blank, through counsel, filed a Motion to Reconsider for the following reasons contending the [PTAB]<sup>1</sup>:

1. Failed to properly consider the difference in the number of bathrooms contained in the Board of Review's comparables when compared with the subject.
2. Failed to consider or adjust for the fact that none of the BOR's comparables were located immediately across the road from the Ravinia Festival parking area, which houses as many as 2,000 vehicles during the summer concert season, all of which exit the venue at the same time once an event has concluded, usually at 10 p.m., both during the week and on the weekends.
3. Failed to adequately consider that 3 of the 4 comparables tendered in support of the appeal were located on the same block as the subject and also faced the same Ravinia Festival parking area.
4. Failed to properly consider and adjust for the lower range of improvement values of the comparables when compared to the subject.

5. Placed too much weight on the differences in housing design between the appellant's comparables and those of the BOR, while other significant differences between the BOR's comparables and the appellant's were given insufficient consideration and only nominal, if any adjustments were made.

The appellant requested the PTAB Board reconsider the initial decision and grant the relief requested.

- g. Covia Corp Utica Plant: #21-06964.001 thru .039-I-3 (LaSalle)

#### Intervenor's Request for an Extension

This appeal involves the assessment of multiple parcels (39 PINs) of Covia Corp Utica Plant for the tax year of 2021. On 03/22/2022, the LaSalle County Board of Review (BOR) issued its 2021 assessment decision for Covia Corp Utica Plant, establishing a combined total assessment of \$23,597,111. Covia Corp Utica Plant filed an appeal postmarked 04/20/2022 and submitted an appraisal estimating the subject property had a market value of \$16,800,000 and requested an assessment of \$5,600,000.

- On 07/12/2022, Waltham Community School District No. 185, through counsel, filed its Request to Intervene.
- On 07/28/2022, the PTAB added Waltham Community School District No. 185 as an intervenor and granted an extension of time for filing evidence with a due date of 10/26/2022.
- On 10/26/2022, the Waltham Community School District No. 185 requested an additional 180 days to file evidence or a brief for the above reference matter contending this case involves the fair cash value of Covia Corp Utica Plant, a silica mining, processing, and distribution facility. An appraisal of the subject property involves highly specialized valuation techniques that include the development of a discounted cash flow analysis utilizing a specialized rent royalty methodology to determine market rental rates for the mining and removal of the silica from the subject property. The intervenor is currently in consultation with multiple appraisers in Illinois and nationwide that have the qualifications necessary to understand the silica market, energy, and fracking on the effective date of value, and to appraise a mining, processing, and distribution facility like the subject property.

The intervenor and appellant are currently scheduled to meet to discuss settlement negotiations on 11/02/2022. If the parties are unable to settle this appeal by the final evidence deadline for the tax year 2020 appeal pending before this Board (20-07934), the intervenor will file its evidence by that date for the 2020 appeal and will then need an additional ninety days to update the



evidence for this 2021 tax year appeal. The intervenor is requesting 180 days to file evidence and / or a brief with respect to the above appeal.

h. Jackson Generation LLC: #21-05929.001-I-3 (Will)

Intervenor's Request for an Extension

This appeal involves the property assessment of Jackson Generation LLC at 24650 South Brandon Road, Elmwood, IL 60421, for the tax year of 2021. On 01/26/2022, the Will County Board of Review (BOR) issued its 2021 assessment decision for Jackson Generation LLC, establishing a total assessment of \$76,486,290. Jackson Generation LLC, through counsel filed an appeal postmarked 02/22/2022 and submitted an appraisal estimating the subject real estate had a fair cash value of \$16,700,000 as of January 1, 2021, and requested the assessment be reduced to \$5,566,667. The appellant also submitted an appraisal of the M & E estimating the M&E assets had a value of \$201,764,200 as of January 1, 2021.

- On 03/21/2022, Joliet Township High School District 204 filed its Request to Intervene.
- On 04/07/2022, the PTAB confirmed that Joliet Township High School District 204 was named as an intervenor and granted the intervenor an extension of time for filing evidence, with a due date of 07/06/2022.
- On 07/05/2022, Joliet Township High School District 204 requested an additional extension of time to submit evidence.
- On 07/14/2022, the PTAB granted Joliet Township High School District 204 an extension until 08/13/2022 to submit all evidence in response to the appellant's petition.
- On 08/10/2022, Joliet Township High School District 204 requested an additional extension of time to submit evidence. It explained it had retained Real Estate Investment Corporation to perform an appraisal, but the appraisal was not yet completed.
- On 08/25/2022, the PTAB granted Joliet Township High School District 204 a **final** 60-day extension to submit all evidence in response to the appellant's petition with a due date of October 24, 2022.
- By correspondence postmarked 11/01/2022, Joliet Township High School District 204 filed a Motion for Extension of Time to Submit Evidence together with an appraisal prepared by Real Estate Analysis Corporation estimating the total going concern value (real estate, personal property, and business value) as of 1/1/21 was \$919,620,000. The intervenor acknowledged being granted three extensions of time to submit evidence, with the third extension of time concluding 10/24/2022. During these extensions, the District had contracted, along with other intervening bodies, to have an appraisal performed on the subject property. Due to unforeseen

circumstances, the appraiser was unable to complete the appraisal by the 10/24/2022 deadline. However, the appraisal has now been completed and is attached to the motion. The District requests the Board extend its time to submit evidence up to and including the date of filing this motion and accept the attached appraisal as its evidence. Wherefore, Joliet Township High School District 204 requests the Board grant its motion for an extension of time to submit evidence and for any further relief this Board deems just and equitable.

Other intervenors that are parties to the appeal include Elmwood CCSD #203, which had an extension of time that expired on November 2, 2022, and Manhattan-Elwood Public Library District, which had an extension that expired on November 9, 2022.

On 10/31/22, Elmwood CCSD #203 filed the same appraisal prepared by Real Estate Analysis Corporation, estimating the total going concern value (real estate, personal property, and business value) as of 1/1/21 was \$919,620,000.

i. Sanford Kahn: #21-23830.001-C-1 (Cook- Rogers Park)

Appellant's Request for an Extension

Sanford Kahn, through counsel, filed an appeal postmarked 06/29/2022, from the board of review decision, with a basis of recent appraisal and requested an extension of 90 days to file documentary evidence.

On 08/11/2022, the PTAB confirmed receipt of the appellant's petition for appeal and granted an extension of time for the submission of evidence with a due date of 11/09/2022.

By correspondence postmarked 11/01/2022, the appellant requested an extension of time to submit evidence. The appellant has engaged Urban Real Estate Research, Inc. to prepare an appraisal. However, Urban Real Estate Research, Inc., in a letter dated October 27, 2022, states they need an additional 90 days to complete the report. The appellant is requesting the PTAB grant an additional 90 days to file evidence.

k. Sanford Kahn: #21-23835.001 thru .002-C-1 (Cook- Rogers Park) -

Appellant's Request for an Extension

Sanford Kahn filed an appeal postmarked 06/29/2022, from the board of review decision, with a basis of recent appraisal and requested an extension of 90 days to file documentary evidence.

On 08/11/2022, the PTAB confirmed receipt of the appellant's petition for appeal and granted an extension of time for the submission of evidence with a due date of 11/09/2022.

By correspondence postmarked 11/01/2022, the appellant requested an extension of time to submit evidence. The appellant has engaged Urban Real Estate Research, Inc. to prepare an appraisal. However, Urban Real Estate Research, Inc., in a letter dated October 27, 2022, states they need an additional 90 days to complete the report. The appellant is requesting the PTAB grant a further 90 days to file evidence.

By correspondence postmarked 11/01/2022, the appellant requested an extension of time to submit evidence. The appellant has engaged Urban Real Estate Research, Inc. to prepare an appraisal. However, Urban Real Estate Research, Inc., in a letter dated October 27, 2022, states they need an additional 90 days to complete the report. The appellant is requesting that the PTAB grant a further 90 days to file evidence.
