Motion to Reinstate

Procedural History:

This matter originally appeared on the October 2022 agenda. The PTAB dismissed this letter by which stated the reason for the dismissal was for a failure to submit evidence which would satisfy the burden of proof. The letter should have stated that the reason for the dismissal was in fact the failure of the appellant to timely submit its evidence. The PTAB decided to continue this matter so the appellant could address the true reason for the dismissal of the appeal.

Relevant Facts:

- The property comprises eight office condominium units with 20,658 square feet of rentable area located in a three-story building constructed in 2005.
- 03/24/2022, the DuPage County Board of Review (BOR) entered its 2021 assessment decision for Doyle Development LLC, establishing a total combined assessment of \$810,160.
- Doyle Development, LLC, through counsel, filed an appeal postmarked "04/22/2022" and requested a 90-day extension to prepare and submit evidence supporting the appeal.
- ***On 05/19/2022, PTAB granted the appellant a 90-day extension with a due date of Wednesday, 08/17/2022 – this is the date which the appellant failed to meet. The letter stated, “If all information required to fully complete the filing of your appeal is not postmarked by the above date, your appeal may be dismissed....”***
- ***08/18/2022 – Doyle Development, LLC submitted its evidence postmarked Thursday, 08/18/2022, which included an appraisal estimating the subject property's market value at \$1,820,000 as of 1/1/21. The appraisal report is dated May 6, 2022. This submission is one day past due.***
- 09/08-2022 - On 09/08/2022, the PTAB sent a letter to the appellant explaining that the PTAB received and reviewed the submitted information and determined that the appellant did not provide substantive, documentary evidence or legal argument sufficient to challenge the correctness of the assessment of the subject property. The PTAB found that the information did not satisfy the burden of going forward, dismissed the appeal, and closed the file – the letter should have explained the evidence was not timely filed.
- 09/16/2022 – On 09/16/2022, the appellant, through counsel, submitted a motion to Reinstate the Appeal contending a legal brief and supporting evidence, including an ad valorem appraisal valuing the subject property as of 01/01/2021, was filed and is sufficient to challenge the correctness of the assessment set by the DuPage County BOR.
- October Board Meeting – On 10/11/2022, the PTAB voted to allow the appellant to explain why it failed to timely file the evidence.
- 11/08/2022 – By correspondence dated 11/08/2022, Doyle Development, LLC explained that in the ordinary course of process and procedure, it is believed the submission of evidence was placed in a package and postmarked timely. It is the custom of counsel for a designated individual to process correspondence from the PTAB, including the notice granting an extension of time to file

evidence in this case. The same individual enters the extension deadline and ensures the evidence is postmarked on or before that date. The counsel for the appellant has experienced staffing issues due to illness and overwhelming deadlines due to delays at the Cook County Assessor level. The appellant recognizes these are not excuses but potential explanations of human error - if it did occur. The appellant acknowledges the 05/19/2022, extension letter issued from the PTAB was not a final extension; it is within PTAB's power to grant further time; the PTAB has the discretion to dismiss the appeal if evidence was not received by 08/17/2022; and that the PTAB has the discretion to admit the evidence. The appellant requests the PTAB reinstate the appeal in consideration of the above, in fairness to the taxpayer, and in recognition of the counsel's history of compliance with PTAB's procedures and deadlines.
