Chairman Freeman convened the meeting at 10:00 a.m. and welcomed the Board Members and the Management Team to the Property Tax Appeal Board Meeting.

2. Approval of Minutes from Previous Meeting

Mrs. Kinion made a motion to approve the Board Minutes of April 12th, 2022, as presented. Mr. Steffen seconded the Motion, and it carried 5-0.

3. Adoption or Amended to the Agenda

Item F from Section 5 - Discussion of Motion

University Park Energy LLC: #20-05696 - I -3 (Will – Monee) LSP University Park LLC: #20-05697 - I -3 (Will – Monee)

Chairman Freeman made a motion to move item F from Section 5 up in the agenda for discussion, Mr. Steffen seconded the Motion, and it carried 5-0.

Mr. Nemanich of Klein, Thorpe, & Jenkins, Ltd. spoke, requesting an extension of time to submit an appraisal.

Mr. Trowbridge, Deputy Supervisor of Assessments of Will County, spoke as a witness to Mr. Nemanich regarding the status of the time an appraisal may take and the length of time for an extension.

Chairman Freeman moved to grant a final 90-day extension to enable the petitioner to obtain the necessary appraisal; Mr. Steffen seconded the Motion. Mr. Bilotta abstained, and it carried 4-0.

4. Executive Director's Report

a. HR/Fiscal Update:

- a. HR: On May 15th, Phyllis McJunkins will start as Administrative Assistant to the Executive Director and the Board. Phyllis is replacing Dianne. The position is moving from the DPO to the SPO.
- b. Fiscal Update: No new updates.

b. IT Update:

- a. E-filing We bid out for an e-filing vendor and only received one bid back. We have signed the purchase order with that vendor and will build out the system to accept appeals electronically. The vendor and our IT staff will start with the residential appeal form, and during this period, our staff will be trained on how to create and integrate petition forms into our existing systems. Our IT staff will be able to modify current forms or create new ones as the need arises. IT will also be able to build upon the capabilities of our existing system to create greater efficiencies in the drafting of decisions. Two law firms have agreed to test the system, and hopefully, the system will be open to all law firms by the end of the year at the latest, at least for residential appeals.
- b. F-filing Rule Making We have put together a team to draft rules that will require appeals to be filed electronically. The requirements will be staggered between types of appeals and counties based on population.
