Intervenor's Request for an Extension

The subject property consists of a two-story limited-service hotel containing 66,500 square feet of building area with 120 guestrooms. The property has a 5.38-acre site. The hotel opened in 1970. The appellant submitted an appraisal estimating the real

estate had a market value of \$1,600,000 and requested the assessment be reduced from \$980,375 to \$533,280.

- On 05/11/2022, West Aurora School District No. 129 filed its Request to Intervene in the above matter and requested a 90-day extension to submit evidence- the first extension request.
- On 05/26/2022, the PTAB confirmed West Aurora School District No. 129 was named as an intervenor and granted the first 90-day extension of time for filing evidence, with a due date of 08/24/2022.
- On 08/23/2022, West Aurora School District No. 129 requested a second 90-day extension to submit evidence.
- On 09/08/2022, the PTAB granted the intervenor a **final** 90-day extension to submit evidence with a due date of **12/07/2022**.
- On 12/06/2022, West Aurora School District No. 129 requested an additional two-week extension to file its evidence, which would allow the resolution of two pending appeals before the PTAB (Docket Nos. 20-08986 & 21-05502). The parties to these appeals have reached a tentative settlement of both matters. They are circulating formal stipulations for execution by the Appellant, School District, and the Board of Review. The School District anticipates requesting that PTAB set the assessed value of the subject in accordance with the stipulations for Docket Nos. 20-08986 & 21-05502.

b. Grand Tower Energy Center LLC: #21-05950.001 thru .10-C-3 (Jackson)

Appellant's Request for an Extension to File Rebuttal

This case involves the property tax assessment of the Grand Tower Energy Center LLC ("Grand Tower") for the assessment of multiple parcels (10 PINS) for the tax year 2021. On 02/24/2022, the Jackson County Board of Review issued its 2021 assessment decision for Grand Tower, establishing a total assessment of \$26,538,842. On that same date, the appellant timely appealed, requesting the subject's total combined assessment be reduced to \$583,275 with a recent appraisal.

- On 04/21/2022, the PTAB named Shawnee Community Unit School District #84 as an intervening taxing district in the above matter.
- Several stipulations were presented, but the parties did not reach an agreement.

- On 11/02/2022, Intervenor Shawnee School District No. 84 submitted its evidence, including an appraisal containing a valuation as of 1/1/2020. The evidence was served on the appellant via email.
- On 12/13/2022, the appellant requested an extension of time to file its rebuttal evidence to the intervenor's filing. Grand Tower is requesting a 90-day extension to file its rebuttal evidence. The appellant avers the request will not cause a delay in the hearing of this matter as:
 - The 2014 & 2015 decision of PTAB on the value of the property is currently pending before the Illinois Supreme Court.
 - Note: The basis of the appeal is a jurisdictional issue. The School District is arguing that the PTAB lacks jurisdiction to hear the appeals because Grand Tower did not pay its property taxes which were subsequently sold.
 - Appeals of the 2016 – 2020 assessment of the property are currently pending before PTAB.
 - Grand Tower is obtaining proposals at the current time and expects to engage experts shortly.
 - The status of these appeals will be at least several years before this appeal is set for hearing.

Therefore, Grand Tower requests an extension of 90 days to submit rebuttal evidence.

Notice of this motion was served on the intervenor by PTAB.

c. Marklund Children's Home 18-51277.001 thru .002-C-3 (Cook- Hannover)

Motion to Stay the Appeal Pending Status of a Certificate of Error.

This case involves the omitted property tax assessment of the Marklund Children's Home for the assessment of multiple parcels (2 PINS) for the tax year 2018. On 05/24/2022, the Cook County Board of Review issued its 2018 omitted assessment decision for Marklund Children's Home, establishing a total assessment of \$1,925,605. The appellant requested the subject's total combined assessment be reduced to \$0. Marklund Children's Home filed an appeal postmarked 07/01/2022 from the board of review decision with a basis of recent appraisal and contention of law.

- On 08/11/2022, the PTAB confirmed receipt of the appellant's incomplete appeal, and Marklund Children's Home was granted a 30-day extension to complete the appeal with a due date of 09/10/2022.

- On 08/29/2022, Marklund Children's Home, through counsel, requested a 90-day extension to submit documentary evidence.
- On 09/22/2022, the PTAB granted Marklund Children's Home a final 90-day extension to submit evidence.
- On 12/14/2022, Marklund Children's Home requested an extension to submit documentary evidence or a stay of the appeal proceeding until after the Cook County Assessor's Certificate of Error is adjudicated. On 08/25/2022, the Illinois Department of Revenue deemed the subject's property to be under a charitable use exempt from taxation for the 2021 tax year. Because the property has been under the same charitable use since 2016, the appellant is trying to void the subject tax year 2018 back taxes through the Cook County Assessor's Certificate of Error process.
- On 10/11/2022, the Cook County Assessor confirmed to the appellant's counsel that a Certificate of Error for the subject property was being issued and should be completed within 60 days. The Certificate of Error is still being processed, and once completed, the Certificate of Error will void the entire 2018 omitted assessment back-tax bill in accordance with 35 ILCS 200/14-15. Therefore, the subject matter of this appeal will become moot, and the PTAB appeal will be promptly withdrawn.

Therefore, Marklund Children's Home is requesting an extension of time to submit documentary evidence or a stay of the appeal proceeding until after the Cook County Assessor's Certificate of Error is adjudicated.

d. Baldwin Enterprises, Inc.: #21-07444-C-2 (Jefferson)

Board of Review Motion for an Extension

This case involves the property tax assessment of Baldwin Enterprises, Inc. for the tax year 2021. On 06/08/2022, the Jefferson County Board of Review issued its 2021 assessment decision for Baldwin Enterprises, Inc. establishing a total assessment of \$1,290,433. The appellant requested the subject's total combined assessment be reduced to \$1,016,670. Baldwin Enterprises, Inc. filed an appeal postmarked 07/01/2022 from the board of review decision with a recent appraisal.

On 08/11/2022, the Jefferson County Board of Review was notified of the above matter and provided an opportunity to submit evidence or a written request for an extension of time to submit evidence by 11/09/2022.

On 12/8/2022, the PTAB found the Jefferson County Board of Review in default for failure to provide any information or evidence and notified the Jefferson County Board of Review that the PTAB would proceed with the appeal based on the evidence submitted.

On the postmark date of 12/14/2022, the Jefferson County Board of Review avers a letter was mailed to PTAB on 11/09/2022, requesting an extension of time to better prepare for the above matter, along with three other letters requesting extensions of time for dockets: 21-07443, 21-07445, and 21-07449. By letters dated 11/24/2022, the PTAB granted these other 3 Jefferson County Board of Review requests and provided a 90-day extension for each. Therefore, the Jefferson County Board of Review requests a review, verification, or consideration to allow the extension request for docket 21-07444.
