Appellant's Motion to Compel Issuance of Subpoena(s) for Deposition(s) & Production of Documents

Description of the Property: The subject property is a power plant located at 2635 West Dralle Road, University Park, Will County.

Procedural History & Timeline of Discovery:

- The appellant timely filed its appeal and submitted an appraisal estimating the retrospective market value as \$2,900,000. The appellant is seeking a reduction in the assessed value from \$3,836,298 to \$833,333.
- On 09/21/2021, the Will County Board of Review adopted the evidence submitted by the Intervenors.
- Crete-Monee Community Unit School District No. 201-U (School District) timely intervened, but untimely sought to adopt the Will County Board of Review's evidence.
- On 02/08/22, the PTAB found the School District in default for failure to timely file evidence.
- University Park Public Library District (Library) timely intervened and granted four 90-day extensions to submit evidence. On 08/10/22, the Library filed an appraisal that values the property at \$118,000,000.
- On 8/27/2022, the PTAB sent a letter to the parties informing them that the filing period for the submission of new evidence was closed. However, the parties were given 30 days to file rebuttal evidence.
- On 10/26/2022, the appellant filed rebuttal evidence consisting of an appraisal review report of the Library's appraisal evidence. The rebuttal was timely because the PTAB granted the appellant an extension to file its rebuttal evidence.
- In December 2022, the appellant served Interrogatories and a deposition request on the intervenor.
- This appeal is scheduled for an in-person hearing on 03/20/2023.

Argument:

- On 01/13/2023, the appellant filed a Motion to Compel seeking the issuance of a subpoena(s) and production of documents to be served on the Will County Board of Review and intervenors pursuant to 35 ILCS 200/16-175 and 86 Ill. Admin. Code § 1910.68(a). The appellant seeks subpoena(s) for the production of documents along with the production of each of the opposing parties' witnesses (as yet undisclosed) for deposition, in addition to taking the deposition of the appraiser, Mark Pomykacz of Federal Appraisal, LLC (Exhibits D, E, and F of the motion). The appellant contends that the intervenor, Library submitted an appraisal estimating the market value of the subject's total assets of the business, including working capital, business intangibles, personal property, and real property. The appellant contends that the intervenor's appraiser does not identify what property or interests at the subject property fall into the categories mentioned above, nor does the appraisal separately identify any portion of its concluded value attributable to each component of the property. The

appellant informally attempted to obtain documents and depositions on 12/27/22, but the response from the Library was vague at best. The appellant avers Will County, nor the intervenors have submitted any other documentation identifying what they contend constitutes assessable real estate of the subject property or assigning a value to assessable real estate. Therefore, the appellant cannot determine from any of the information Will County's or the intervenors' position concerning the issues in dispute at the hearing scheduled on 03/20/2023. The appellant desires that PTAB make Mr. Pomykacz available for a deposition to allow the appellant to learn the opinions of Mr. Pomykacz on these issues and to explore the basis for these opinions. The appellant also requests the same order for any other undisclosed witnesses to the extent they plan to call such persons to testify on these central issues in the upcoming hearing.

- The Library and Board of Review jointly timely objected to the appellant's Motion to Compel under an expedited briefing schedule. These respondents contend the request is untimely, unnecessary, and inappropriate given the upcoming hearing, evidence being closed in this matter, and various requests still outstanding for which the responsive deadline had not yet passed, such as the request for witnesses (provided with the response). No basis has been shown for an evidence deposition allowed by procedural rules; discovery depositions are not a common practice before PTAB. Likewise, the interrogatories proposed by the appellant are not appropriate and can be answered at the scheduled hearing.
- The appellant promptly replied, contending that formal discovery is necessary at this time because the Library's appraisal report fails to identify or provide a value for what has been deemed real property. In addition, the appellant contends that a dispute exists between the parties regarding what constitutes assessable property and justifies the requested discovery. The appellant clarifies that a discovery deposition of appraiser Pomykacz is being requested. Furthermore, the appellant contends the discovery requests for deposition, production, and interrogatories were timely made approximately 90 days [*sic*] prior to the scheduled hearing.

b. LSP University Park LLC: #20-05697.001 thru .003-I-3 (Will)

Appellant's Motion to Compel Issuance of Subpoena(s) for Deposition(s) & Production of Documents

Description of the Property: The subject property is a power plant located at 787 Industrial Dr., University Park, Will County.

Procedural History & Timeline of Discovery:

- The appellant submitted an appraisal estimating the retrospective market value as \$4,500,000 and requested that the total assessment be reduced from \$7,990,662 to \$1,383,333.
- Crete-Monee Community Unit School District No. 201-U (School District) timely intervened and was granted to 12/15/21 to submit evidence. On 01/11/22, the School District untimely submitted a letter adopting the evidence filed by the Will County Board of Review. On 04/26/22, the School District was found to be in default for failing to file evidence timely.
- The PTAB erroneously reinstated the School District by letter dated 08/17/22, which the PTAB corrected on 01/23/23.
- On 09/24/21, the Will County Board of Review adopted the evidence submitted by the Intervenors.
- University Park Public Library District (Library) timely intervened and was granted three extensions to submit evidence, the last of which was objected to by the appellant. The PTAB granted this final extension request, and on 08/10/22, the Library filed an appraisal report with a value conclusion of \$312,000,000.
- On 10/26/2022, the appellant filed rebuttal evidence consisting of an appraisal review report of the Library's appraisal evidence. The rebuttal was timely because the PTAB granted the appellant an extension to file its rebuttal evidence.
- In December 2022, the appellant served Interrogatories and a deposition request on the intervenor.
- This appeal is scheduled for an in-person hearing on 03/27/2023.

Argument:

- On 01/13/2023, the appellant filed a Motion to Compel for issuance of a subpoena by PTAB to the Will County Board of Review and intervenors, School District, and the Library pursuant to 35 ILCS 200/16-175 and 86 Ill. Admin. Code § 1910.68(a), to produce documents and the production of each of the opposing parties' witnesses (as yet undisclosed) for deposition, in addition to taking the deposition of the appraiser, Mark Pomykacz of Federal Appraisal, LLC (Exhibits D, E, and F of the motion). The appellant contends that the Library submitted an appraisal estimating the market value of the subject's total business assets, including working capital, business intangibles, personal property, and real property. The appellant contends that the intervenor's appraiser does not identify what property or interests at the subject property falls into each of the categories mentioned above, nor does the appraisal separately identify any portion of its concluded value attributable to each property component. The appellant informally attempted to obtain documents and deposition on 12/27/22, but the response from the Library was vague. The appellant avers Will County, nor the intervenors have submitted any other documentation identifying what they contend constitutes assessable real estate of the subject

property or assigning a value to assessable real estate. Therefore, the appellant cannot determine from any of the information Will County's or the intervenors' position concerning the issues in dispute at the hearing scheduled on 03/20/2023. The appellant desires that PTAB make Mr. Pomykacz available for deposition to allow the appellant to learn the opinions of Mr. Pomykacz on these issues and to explore the basis for these opinions. The appellant also requests the same order for any other undisclosed witnesses to the extent they plan to call such persons to testify on these central issues in the upcoming hearing.

- The Library and Board of Review jointly timely objected to the appellant's Motion to Compel under an expedited briefing schedule. These respondents contend the request is untimely, unnecessary and inappropriate given the upcoming hearing, evidence being closed in this matter, and various requests still outstanding for which the responsive deadline had not yet passed, such as the request for witnesses (provided with the response). No basis has been shown for an evidence deposition allowed by procedural rules; discovery depositions are not a common practice before PTAB. Likewise, the interrogatories proposed by the appellant are not appropriate and can be answered at the scheduled hearing.
- The appellant promptly replied, contending that formal discovery is necessary at this time because the Library's appraisal report fails to identify or provide a value for what has been deemed to be real property. In addition, the appellant contends that a dispute exists between the parties regarding what constitutes assessable property and justifies the requested discovery. The appellant clarifies that a discovery deposition of appraiser Pomykacz is being requested. Furthermore, the appellant contends the discovery requests for deposition, production, and interrogatories were timely made approximately 83 days [*sic*] prior to the scheduled hearing.

c. Linda Jelinek: #19-55147.001-R-2 (Cook) (Evanston)

Appellant's Motion for a 3rd Extension to Submit initial evidence

This appeal concerns a residential property at 1722 Judson Ave., Evanston. The appellant timely filed an appeal postmarked 07/20/2022, based on a favorable PTAB decision issued 06/21/2022. The property address and the appellant's address are identical. The appellant is requesting that the assessment be reduced to \$198,972, although data has yet to be provided concerning the 2019 assessed value. On 09/22/2022, the PTAB confirmed receipt of the appeal and informed the appellant that the petition needed to be completed. The appellant was given 30 days to complete the appeal, with a due date of 10/22/2022. On the due date, the appellant requested an additional extension to submit evidence.

On 11/10/2022, the PTAB granted the appellant a **final** 60-day extension to submit evidence, with a due date of 01/09/2023. On the due date, the appellant requested an

extension due to a medical issue. The medical issue was disclosed, but the staff is withholding the specific issue for privacy reasons. The appellant is in the process of going to new doctors for treatment and has been unable to obtain files from her storage to complete the appeal process. Therefore, the appellant is requesting an extension.

d. Linda Jelinek: #18-51318.001-C-1 (Cook) (Evanston)

Appellant's Motion for an Extension

This pro se appeal concerns a commercial property at 834 Custer Ave., Evanston. The appeal was postmarked 07/20/2022. The appellant requested that the assessment be reduced to \$50,000 and provided a copy of a partially signed stipulation from Docket No. 17-25826 dated October 4, 2021, for which a PTAB favorable decision was issued 12/21/2021.

On 09/22/2022, the PTAB confirmed receipt of the appeal and informed the appellant that the petition was incomplete, including the lack of a board of review or favorable PTAB decision for jurisdictional purposes. The appellant was given 30 days to complete the appeal, with a due date of 10/22/2022. On the due date, the appellant requested an extension to submit evidence and submitted a copy of the favorable PTAB decision issued on 12/21/21 in Docket No. 17-25826.

On 11/10/2022, the PTAB granted the appellant a **final** 60-day extension to submit evidence, with a due date of 01/09/2023. On the due date, the appellant requested an extension due to being newly diagnosed with cancer. The appellant is in the process of going to new doctors for treatment and has been unable to obtain files from her storage to complete the appeal process. Therefore, the appellant requests an extension.

e. Linda Jelinek: #19-55148.001-C-1 (Cook) (Evanston)

Appellant's Motion for an Extension

This appeal concerns a commercial property at 834 Custer Ave., Evanston. The appellant filed an appeal postmarked 07/20/2022. The appellant requested that the assessment be reduced to \$50,000 and provided a copy of a partially signed stipulation from Docket No. 17-25826 dated October 4, 2021.

On 09/22/2022, the PTAB confirmed receipt of the appeal and informed the appellant that the petition was incomplete, including the lack of a board of review decision and/or favorable PTAB decision for jurisdictional purposes. The appellant was given 30 days to complete the appeal, with a due date of 10/22/2022. On the due date, the appellant requested an extension to submit evidence and submitted a copy of the favorable PTAB decision issued on 12/21/21 in Docket No. 17-25826.

On 09/22/2022, the PTAB confirmed receipt of the appeal and informed the appellant that the petition was incomplete. The appellant was given 30 days to complete the appeal, with a due date of 10/22/2022. On the due date, the appellant requested an extension to submit evidence and included a copy of the PTAB favorable 2017 decision dated 12/21/2021.

On 11/10/2022, the PTAB granted the appellant a **final** 60-day extension to submit evidence, with a due date of 01/09/2023. On the due date, the appellant requested an extension due to being newly diagnosed with cancer. The appellant is in the process of going to new doctors for treatment and has been unable to obtain files from her storage to complete the appeal process. Therefore, the appellant is requesting an extension.

- f. The Dean Project Owner, LLC: #21-05664.001 thru .005-C-3 (Champaign)

Motion to Intervene and Request for an Extension

This inequity and contention of law appeal concerns multiple parcels (5 pins) at 708 S. Sixth St., Champaign, improved with a 17-story, 322-unit, apartment building with several retail spaces and 84 indoor parking spaces. The appellant timely appealed from decisions of the Champaign County Board of Review with a combined total assessment of \$27,897,130. The appellant seeks a combined assessment reduction to \$13,367,720.

On 10/06/2022, the PTAB notified the Champaign County Board of Review of the pendency of this appeal and set a deadline of 01/04/2023 to file evidence or seek an extension to do so. The board of review timely filed its Notes on Appeal and evidence concerning the recent purchase price of the subject property.

The Champaign County Board of Review filed its Certificate averring that copies of this appeal were mailed to all affected taxing districts on 11/02/2022.

On 12/30/2022, the City of Champaign timely intervened. On 01/19/2023, the PTAB established a deadline of 04/19/2023 for the submission of evidence by the intervenor City of Champaign.

With a postmark of 01/12/2023, a date 71 days after the certified date that notice was issued, by counsel Champaign Unit School District No. 4 filed its request to intervene along with an extension to 03/30/2023 or later to submit evidence. The School District avers it did not receive official notice of this matter, although counsel confirmed the Board of Review states notice was sent. Counsel also avers PTAB was contacted by telephone months ago asking when one could send in a request to intervene in the above matter and was told to wait for the notice. Therefore, while recognizing that the

deadline has expired, the School District requests permission to intervene in this matter and requests an extension of more than 90 days to submit evidence.
