 - a. Pangea Equity Partners: #21-30150.001 thru .003-C-1 (Cook) (West Chicago)**

Appellant's Motion to Reconsider

This appeal involves commercial real estate. Pangea Equity Partners timely appealed the decision of the board of review by postmark of 08/19/2022, which included an appraisal.

On 10/20/2022, the PTAB confirmed receipt of the appellant's petition for appeal and requested additional information through an Incomplete Checklist with a due date of 11/19/2022.

On 01/19/2023, the PTAB dismissed the appeal for failure to respond to the Incomplete Checklist.

On 02/10/2023, the appellant submitted its Motion to Reconsider. The attorney argues the additional documentation was timely submitted to PTAB via FedEx on 11/01/2022. The appellant provided an affidavit from counsel's employee, Scott Klingler, averring he timely filed the additional evidence with PTAB, which was completed on 10/28/2022 and delivered to PTAB via FedEx on 11/01/2022. The appellant also submitted a shipment receipt from FedEx, tracking number 770344813921, with a ship date of 10/28/2022 and a delivery date of 11/01/2022. The appellant also submitted the "missing" documentation that was purportedly shipped.

The appellant requests the case be reinstated, and a 30-day extension is granted to resubmit their additional information.

b. UAFCY Selfreliance: #21-30311.001 thru .005-C-1 (Cook) (West Chicago)

Appellant's Motion to Reconsider

This appeal involves commercial real estate. UAFCY Selfreliance timely appealed the decision of the board of review by postmark of 08/18/2022, with a basis of recent appraisal, however, an incorrect appraisal was provided.

On 10/20/2022, the PTAB confirmed receipt of the appellant's petition for appeal and requested additional information with an Incomplete Checklist with a due date of 11/19/2022, noting the appraisal concerned only one parcel, but five parcels were being appealed.

On 01/19/2023, the PTAB dismissed the appeal for failure to timely respond to the Incomplete Checklist.

On 02/10/2023, the appellant submitted its Motion to Reconsider. The attorney argues the additional documentation was timely sent to PTAB via FedEx on 11/01/2022. The appellant provided an affidavit from counsel's employee, Scott Klingler, averring he timely filed the additional evidence with PTAB, completed on 10/28/2022 and delivered to PTAB via FedEx on 11/01/2022. The appellant also submitted a shipment receipt from FedEx, tracking number 770344813921, with a ship date of 10/28/2022 and a delivery date of 11/01/2022. The appellant also submitted the "missing"

documentation, an appraisal concerning the five parcels on appeal that were purportedly shipped.

The appellant requests the case be reinstated, and a 30-day extension is granted to resubmit their additional information.

c. Craig White: #21-30314.001-R-1 (Cook) (West Chicago)

Appellant's Motion to Reconsider

The appeal involved the residential property and was timely postmarked on 08/18/2022; a basis of the appeal was not provided; however, an appraisal of the subject property was included.

On 10/20/2022, the PTAB confirmed receipt of the appellant's petition for appeal and requested additional information concerning the basis of the appeal, with a due date of 11/19/2022.

On 01/19/2023, the PTAB dismissed the appeal for failure to respond to the Incomplete Checklist timely.

On 02/10/2023, the appellant submitted its Motion to Reconsider. The appellant argues that the additional documentation was timely sent to PTAB via FedEx on 11/01/2022. The appellant provided an affidavit from counsel's employee, Scott Klingler, averring he timely filed the additional evidence with PTAB, which was completed on 10/28/2022 and delivered to PTAB via FedEx on 11/01/2022. The appellant also submitted a shipment receipt from FedEx, tracking number 770344813921, with a ship date of 10/28/2022 and a delivery date of 11/01/2022. The appellant also submitted the "missing" documentation, a Residential Appeal with recent appraisal as the basis, that was purportedly shipped.

The appellant requests that the case be reinstated, and a 30-day extension be granted to resubmit their additional information.

d. Pangea Equity Partners: #21-30321.001 thru .002-C-1 (Cook) (West Chicago)

Appellant's Motion to Reconsider

This appeal involves the property tax assessment of commercial real estate, which was timely filed by postmark of 08/18/2022 and included an appraisal.

On 10/20/2022, the PTAB confirmed receipt of the appellant's petition for appeal and requested additional information, through an Incomplete Checklist, with a due date of 11/19/2022.

On 01/19/2023, the PTAB dismissed the appeal for failure to respond to the Incomplete Checklist timely.

On 02/10/2023, by email through counsel, the appellant submitted its Motion to Reconsider. The attorney argues that the additional documentation was timely sent to PTAB via FedEx on 11/01/2022. The appellant provided an affidavit from counsel's employee, Scott Klingler, averring he timely filed the additional evidence with PTAB, which was completed on 10/28/2022 and delivered to PTAB via FedEx on 11/01/2022. The appellant also submitted a shipment receipt from FedEx, tracking number 770344813921, with a ship date of 10/28/2022 and a delivery date of 11/01/2022. The appellant also submitted the "missing" documentation, a revised Commercial Appeal, and a revised addendum that were purportedly shipped.

The appellant requests the case be reinstated, and a 30-day extension is granted to resubmit their additional information.

e. Pangea Equity Partners: #21-30336.001-C-1 (Cook) (West Chicago)

Appellant's Motion to Reconsider

This appeal involves the property tax assessment of commercial real estate, which was timely filed by postmark of 08/18/2022 and included an appraisal.

On 10/20/2022, the PTAB confirmed receipt of the appellant's petition for appeal and noted that the appellant's claims for land plus improvement did not add up to the assessment requested, with a due date of 11/19/2022.

On 01/19/2023, the PTAB dismissed the appeal for failure to respond to the Incomplete Checklist timely.

On 02/10/2023, the appellant submitted its Motion to Reconsider. The attorney argues that the additional documentation was timely sent to PTAB via FedEx on 11/01/2022. The appellant provided an affidavit from counsel's employee, Scott Klingler, averring he timely filed the additional evidence with PTAB, which was completed on 10/28/2022 and delivered to PTAB via FedEx on 11/01/2022. The appellant also submitted a shipment receipt from FedEx, tracking number 770344813921, with a ship date of 10/28/2022 and a delivery date of 11/01/2022. The appellant also submitted the "missing" documentation, a revised Commercial Appeal where the land and improvement claims add to the stated total that was purportedly shipped.

The appellant requests the case be reinstated, and a 30-day extension is granted to resubmit their additional information.

f. James Zespy: #21-30298.001-R-1 (Cook) (West Chicago)

Appellant's Motion to Reconsider

This appeal involves a residential property that was timely filed on 08/18/2022, but a basis for the appeal was not provided; however, an appraisal was included.

On 10/20/2022, the PTAB confirmed receipt of the appellant's petition for appeal and requested additional information concerning the basis of the appeal, with a due date of 11/19/2022.

On 01/19/2023, the PTAB dismissed the appeal for failure to respond to the Incomplete Checklist timely.

On 02/10/2023, the appellant submitted its Motion to Reconsider. The appellant argues that the additional documentation was timely sent to PTAB via FedEx on 11/01/2022. The appellant provided an affidavit from counsel's employee, Scott Klingler, averring he timely filed the additional evidence with PTAB, which was completed on 10/28/2022 and delivered to PTAB via FedEx on 11/01/2022. The appellant also submitted a shipment receipt from FedEx, tracking number 770344813921, with a ship date of 10/28/2022 and a delivery date of 11/01/2022. The appellant also submitted the "missing" documentation, a Residential Appeal with recent appraisal as the basis, that was purportedly shipped.

The appellant is requesting the case be reinstated and a 30-day extension to resubmit their additional information.

g. Winterset III Phase 2 Condo: #21-23346.001 thru .005-C-1(Cook) (Orland)

Motion to Vacate the Dismissal

This appeal initially involved a commercial property composed of 5 condo units in Winterset III Phase 2 Condo, which was timely filed by postmark of 06/24/2022, with the basis as a recent appraisal, which does not provide an individual breakdown of the market value of each condominium unit. The appellant determined a total assessed value of the five subject properties based on the aggregate market value obtained from the appraisal.

On 08/04/2022, the PTAB confirmed receipt of the appellant's petition with an Incomplete Checklist with a due date of 09/03/2022, noting that the appraisal submitted valued seven condo units, two of which were not appealed. The appellant was granted 30 days to submit evidence concerning only the parcels on appeal.

On 10/06/2022, the PTAB dismissed the appeal for failing to respond to the Incomplete Checklist on time.

On 12/15/2022, the appellant filed its Motion to Vacate the Dismissal with the PTAB. The appellant avers the following regarding this appeal:

- The appellant, through counsel, filed a timely appeal on the above reference property on 06/24/2022, requesting a reduced assessed valuation from \$287,875 to \$245,485 based on an appraisal of seven units by using a per-square-foot market value from the report.
- The appellant submitted an appraisal dated 07/31/2021 completed by Brian T. McNamara, MAI, and State Certified General Real Estate Appraiser, valuing seven condominium units and setting forth an aggregate opinion of value as of 01/01/2021, which was included in the appeal and argues this should be considered sufficient evidence to go forward.

The appellant requests that the PTAB reinstate the appeal.
