This is a commercial appeal of 5 condo units in Winterset III Phase 2 Condo, which was timely filed by postmark of 06/24/2022, with the basis as a recent appraisal. The appraisal does not, on its face, provide an individual breakdown of the market value of each condominium unit. Based on the appraisal, the appellant filed a brief and argued for an identical per-square-foot assessment for each of the five subject properties.

On 08/04/2022, the PTAB confirmed receipt of the appellant's petition with an Incomplete Checklist with a due date of 09/03/2022, noting that the appraisal submitted values seven (7) condo units, two of which were not on appeal. The appellant was granted 30 days to submit evidence concerning only the parcels on appeal and was advised that failure to respond would result in the dismissal of the appeal.

The PTAB dismissed the appeal for failure to respond to the incomplete checklist on 10/06/2022.

On 12/15/2022, the appellant filed its Motion to Vacate the Dismissal with the PTAB. The appellant avers the following regarding this appeal:

- The appellant reiterated that a timely appeal was filed on 06/24/2022 with an appraisal.
- As part of reinstatement, the appellant did not acknowledge the issuance of an incomplete checklist.

Wherefore, the appellant requests that the PTAB reinstate the above-referenced appeal.

**b. WRB Refining LP: 22-03099.001 thru .009-I-3 (Madison)**

**Appellant's Request for a Stay of the Matter**

This is a timely e-filed industrial appeal of WRB Refining LP, a large petroleum refinery, along with a Motion requesting an extension of time to file its evidence "90 days following the conclusion of the 2021 appeal" in Docket No. 21-06497.

- The basis for the stay request is that two legal issues raised in the 2021 appeal will dictate what evidence needs to be filed in the 2022 case. The appellant argues those issues should be resolved before evidence is filed in the 2022 case. The issues are: (1) what improvements are real property subject to taxation and what are personal property, and (2) how to deduct the value of certified pollution control facilities at the property per 35 ILCS 200/11-20. Furthermore, the appellant contends that resolving these issues in the 2021 appeal will increase the odds of settling the 2022 appeal and subsequent years.

- The appellant further argues that the 2021 case is enormous and should be resolved as soon as possible. The magnitude of the 2021 case requires a prompt resolution, and that will be best achieved if the 2021 case proceeds without waiting for the 2022 case to be developed. Experience has shown that it takes longer to bring the cases to trial when multiple years of appeals in very complex cases are consolidated for trial. Moreover, in prior cases, PTAB has granted parties' requests to hold subsequent year cases in abeyance until the first year has been resolved and any appeal therefrom finalized.

Therefore, the appellant requests that the filing of evidence and conclusions of law be stayed until 90 days following the 2021 decision.

- c. Coal City (CC) CUSD 1, CC Fire Protection District, CC Public Library District, & Grundy County Board: 21-05709.001-I-3 (Grundy)

#### Multi-Appellant Taxing Districts' Request for Subpoena Duces Tecum

This case involves a timely filed undervaluation appeal by multiple taxing districts regarding the General Electric Property Tax Dept. 201 / GE-Hitachi Nuclear Energy Americas, LLC, industrial property improved as an NRC-licensed Independent Spent Fuel Storage Installation (ISFSI) facility providing wet storage for 3,217 spent nuclear fuel assemblies from nuclear power stations from several states (known as the GE-Hitachi Morris Operation). The appellants request the assessment be increased from \$6,131,868 to \$81,828,520.

Since 03/03/2022, the appellants were given a series of extensions to submit evidence, with a final extension issued on 08/25/2022 with a due date of 10/24/2022. Appellants timely submitted their evidence, including an appraisal, postmarked on 10/20/2022.

On 12/15/2022, the PTAB notified the Grundy County Board of Review, with a due date of 03/15/2023, to submit its evidence. On 12/15/2022, the PTAB notified the owner General Electric of the above appeal, with a due date of 01/14/2023, to intervene.

By a postmark date of 01/03/2023, owner General Electric, through counsel, submitted its request to intervene along with a 90-day extension request to receive and review the submitted evidence and prepare the owner's documentary evidence.

On 01/19/2023, PTAB named General Electric as an interested party in the above appeal and granted an extension with a due date of 04/19/2023 to submit evidence.

By postmark date of 03/14/2023, the appellants filed their 55-page Motion to Issue a Subpoena Duces Tecum requesting that General Electric disclose the records identified within its request within 30 days of issuance, pursuant to Section 16-170 and 16-175

of the Property Tax Code and Sections 1910.68 and 1910.79 of the Board's procedural rules.

In summary, the appellants are requesting the PTAB issue a subpoena duces tecum requiring General Electric to produce records regarding its income and expenses at the GEH Morris Operation, especially records relating to the storage of the spent nuclear fuel assemblies. The proposed two-page Subpoena requests any and all documents concerning:

- Revenue, income, rents, storage fees, expenses, and expense reimbursements from 2018 to the present;
- Financial statements and reports, including monthly financials and year-end financials;
- Variance reports and re-stated financials;
- The rent charged for the storage of spent nuclear fuel from 2018 to the present;
- Capital expenditures from 2018 to present;
- Repair, maintenance, or remediation from 2018 to present;
- Reimbursement from the federal government; and
- All Nuclear Fuel Storage Contracts and any other agreements concerning or referencing the storage of spent nuclear fuel stored at the property.

The requests are further supported by an argument that the appellants' appraiser relied upon an income approach in preparing the appraisal using publicly available information on base rent, expense escalator revenues for labor, and expense escalator revenues for equipment between 1998 and 2005. The appellants' appraiser made extraordinary assumptions concerning rents and expense escalator revenues for multiple facilities. The appellants argue that while it is reasonable for its appraiser to make extraordinary assumptions, it is the policy of PTAB to obtain full disclosure and all relevant and material facts before the hearing. 86 Ill. Admin Code 1910.79.

Furthermore, the appellants have used due diligence and best efforts to obtain publicly available information to determine the rents paid for the storage of spent nuclear fuel from multiple facilities; the appellants document numerous efforts to get the documents by agreement which have been unsuccessful. According to the appellants, counsel for General Electric asked the appellants for the legal authority that obligates a property owner to provide this information. In response, appellants cite the PTAB's subpoena powers as the authority and believe that further informal efforts would be futile. Additionally, the appellants documented how they used alternate sources to obtain the information, including issuing more than one FOIA request to the US Department of Energy and follow-up requests. As the US DoE has yet to provide any public records in response to the second FOIA request, the appellants assert no other reasonable means to access the requested documents.

Appellants contend that PTAB has the authority to require the production of these records and request the issuance of the subpoena duces tecum. Appellants further contend that since the owner intervenor is a party to this appeal, it is best positioned to access and provide the requested documents and information. Thus, the appellants request the PTAB enter an order issuing the subpoena duces tecum and direct the intervenor to produce referenced documents.

In the alternative, the appellants request that if PTAB does not grant the request for a subpoena duces tecum, the PTAB bar General Electric, the owner intervenor, from presenting for consideration any testimony, objection, motion, appraisal critique, or other evidentiary material to refute, discredit, or disprove evidence offered by the appellants regarding the income and expenses applicable to the Morris operation.

General Electric, the intervenor, filed a Motion to Strike and Deny the Appellant's Request for Subpoena Duces Tecum. The intervenor argued, in summary, that the materials sought are unnecessary as the appellant has already filed an appraisal that opined on the FMV of the property; therefore, the requested documents are unnecessary. The intervenor also objected to the subpoena's scope and argued that it is overly broad.

**d. Jon Hirschtritt: 20-47746.001-R-1 (Cook) (North Chicago)**

Appellant's Motion to Vacate

This matter involves a timely filed residential appeal by Jon Hirschtritt based on a lack of assessment equity. The appellant requested a hearing and a reduction in their assessment from \$276,113 to \$189,455.

The PTAB notified the Cook County BOR of the above petition, and Cook County BOR submitted its evidence on time. Next, the PTAB notified the appellant that the filing period for submission of evidence was closed and provided 30 days to provide rebuttal evidence.

On 03/21/2023, without scheduling a hearing, the PTAB decided the appeal based on the written record and issued a "no change" decision.

On 03/24/2023, the appellant filed a Motion to Vacate the Board's decision noting that the appellant requested a hearing on this appeal.

#### Intervenor(s)' Requests To Accept Untimely Evidence Due to Clerical Error

In each of the above-listed residential appeals located in New Trier Township, Cook County, one or more intervening taxing districts became a party to the appeal as an intervenor and are each represented by the same law firm.

On the postmarked date of 03/23/2023, the intervening taxing district(s) in each of these appeals submitted a Motion to File Untimely Evidence Due to Clerical Mailbox Error as follows:

- The intervenors argue that on 3/17/2023, they timely mailed their evidence, brief, and response to the taxpayers' evidence via UPS Overnight Mail (tracking number 1ZFA53188799886315). According to the intervenors, they timely mailed their evidence before the deadline, Saturday, 03/18/2023
- . (The PTAB will note that the deadline would, by law, be extended to 3/20/2023. When a deadline falls on a Saturday, Sunday, or Legal State Holiday, the mailing must be postmarked by the next business day of the State of Illinois; in these appeals, that would be 03/20/2023 [86 Ill.Admin.Code Sec. 1910.25] However, this is not an issue in these matters).
- On 03/23/2023, the intervenors discovered a clerical error with the UPS label on the package containing the evidence. The intervenor's filings were mailed to the law firm, not the PTAB. UPS delivered the package to the mailing address on the label - the intervenors' law firm.
- The intervenors aver they intended to comply with the PTAB's rules and instructions regarding the submission of evidence, notwithstanding the clerical error on the UPS label. Therefore, the PTAB should accept the intervenor(s)' evidence in each case.
- According to the motion, there is no prejudice to any party by granting the intervenor(s)' motion. However, the intervenor(s) contend that failing to grant the motion would cause substantial prejudice to the involved taxing districts.



The intervenors request that the PTAB accept their untimely filed evidence into these respective records.

Docket No. 21-07851 was postmarked on 02/24/2023, along with copies of favorable PTAB decisions issued on 09/17/2019, 08/18/2020, and 08/23/2022 for tax years 2017, 2018, and 2020, respectively. On 04/06/2023, the PTAB dismissed this 2021 appeal as it was not timely filed within 30 days of any favorable PTAB decision.

Docket No. 22-02864 was postmarked on 02/24/2023, along with copies of favorable PTAB decisions issued on 09/17/2019, 08/18/2020, and 08/23/2022 for tax years 2017, 2018, and 2020, respectively. On 04/06/2023, the PTAB dismissed this 2022 appeal

as it was not timely filed within 30 days any favorable PTAB decision nor filed within 30 days of a decision issued by the Will County Board of Review for the tax year 2022.
