 - a. Global Material Tech, Inc.: #21-30948.001 thru .002-C-3(Cook) (West Chicago)

Motion to Reinstate and 60-day Extension to Submit Evidence

This case involves the timely filed commercial property tax assessment appeal of Global Materials Tech, Inc, which the taxpayer's attorney subsequently filed a motion to withdraw.

On 01/19/2023, the PTAB granted the appellant's motion to withdraw.

On 03/23/2023, the appellant, through a second attorney, James A. Field, submitted a Motion to Reinstate Appellant's Erroneously Withdrawn 2021 Appeal and grant a 60-day extension to submit evidence. Additionally, the appellant filed a motion to substitute James A. Field as counsel of record and served it upon the PTAB and the Cook County Board of Review.

On 03/28/2023, the PTAB electronically served the newly filed pleadings upon attorney Robert Rosenfeld.

On 03/29/2023, an agreed Motion to Substitute was filed.

On 04/03/2023, the PTAB granted the appellant's substitution request and entered James A. Field as counsel for the appellant.

The appellant's motion to reinstate the 2021 tax year appeal, along with a requested 60-day extension to provide evidence, is based upon the following assertions:

- On 12/21/2022, without the knowledge and permission of the appellant, attorney Rosenfeld inappropriately withdrew the pending appeal with the PTAB.
- Since 11/19/2021, when Rosenfeld was initially engaged, the appellant contends that there has been no communication with Rosenfeld or anyone else associated with his office since the initial engagement. Despite multiple attempts, the appellant has been unable to locate or communicate with the attorney.
- The appellant's complaint was withdrawn through no fault of the appellant, and the appellant will suffer substantial hardship if the appeal is not reinstated.
- The appellant has engaged Field and Goldberg, LLC, to contest the assessed value with PTAB, and counsel was just made aware that the 2021 case was withdrawn.
- The appellant wishes to reinstate the 2021 Complaint and pursue relief from the PTAB.
- The appellant believes there will be no prejudice or undue hardship to any party by allowing the appeal to be reinstated.

The appellant requests that PTAB reinstate the 2021 appeal that was "erroneously" withdrawn and grant a 60-day extension to file evidence.

- b. Marklund Children's Home: #18-51277.001 thru .002-C-3 (Cook) (Hanover)
Marklund Children's Home: #19-55093.001 thru .002-C-3 (Cook) (Hanover)
Marklund Children's Home: #20-48709.001 thru .002-C-3 (Cook) (Hanover)

Motion to [Extend] Stay of the Appeal Pending Certificate of Error Adjudication.

These appeals involve the omitted property tax assessment of the Marklund Children's Home for the assessment of multiple parcels (2 PINS) for the tax years 2018 - 2020. The appellant requested the subject's total combined assessment be reduced to \$0 for each year. Marklund Children's Home filed appeals from the board of review decision with a basis of recent appraisal and contention of law.

On 10/11/2022, the Cook County Assessor confirmed to the appellant's counsel that a Certificate of Error for the subject property was being issued. On 12/14/2022, Marklund Children's Home requested an extension to submit documentary evidence or a stay of the appeal proceeding until after the Cook County Assessor's Certificate of Error is adjudicated. On 01/10/2023, the PTAB voted to grant the appellant a stay of 90 days or until April 10, 2023.

On 04/06/2023, the appellant filed an update and request for an additional extension of the Stay. On 04/05/2023, the appellant received the Certificate of Error-Hand Bills from the Cook County Assessor's Office. However, those certificates state that the Certificate of Error becomes final only after the Cook County Assessor's Office or the Circuit Court approves. The Cook County Assessor's Office has informed the appellant that this Certificate of Error will be sent to the County Treasurer within 30 days. Accordingly, the Certificate of Error is not final. Therefore, the appellant requests an additional extension of the Stay until the Certificate of Error is adjudicated.

c. William Von Holdt: #22-20347.001 (Cook) (Niles)

Appellant's Motion to Reinstate

William Von Holdt filed a residential assessment appeal on 03/10/2023 using the e-filing portal with a basis of Recent Appraisal. With this filing, the appellant failed to provide a copy of the Cook County Board of Review 2022 Final Decision. Instead, the appellant submitted a copy of the 02/16/2023 decision of the Cook County Assessor's Office, which instructed that an appeal may be filed with the Cook County Board of Review.

On 03/23/2023, the PTAB sent a letter informing the appellant that he filed a 2022 assessment appeal before pursuing an appeal before the Cook County Board of Review. He was further informed that his appeal to PTAB was premature and dismissed.

On the postmark date of 03/28/2023 and again on 04/10/23, the appellant submitted requests to PTAB to reinstate his appeal as the appellant filed his appeal with the Cook County Assessor on 11/16/2022 and received a response from them on 02/16/2023.

- d. RMW Streeterville LLC: #18-46479.001 thru .026 (Cook) (North Chicago)
RMW Streeterville LLC: #18-47574.001 thru .026 (Cook) (North Chicago)
RMW Streeterville LLC: #18-47631.001 thru .025 (Cook) (North Chicago)

Motion to Vacate Decision & Reissue Decision Commensurate with Stipulations

These cases involve the property tax assessments of RMW Streeterville LLC. The property, which is the subject of this appeal, is comprised of 103 parcels. Each parcel is a parking space for the tenants of 505 McClurg Court. The appellant filed four separate appeals for the 103 parking spaces "for administrative purposes." (App. Mot. ¶3) One of the four appeals (18-46244) was resolved by a stipulated decision issued on 01/17/2023. Case number 18-46244 is not part of this motion.

On 11/22/2022, the PTAB issued a "no change" decision for each remaining matter (18-46479, 18-47574, and 18-47631). Neither party requested a hearing, and these matters were decided on the evidence submitted.

On 02/03/2023, counsel representing the appellant sent an email to an ALJ referring to the previous stipulation in docket 18-46244 and providing signed stipulations for each of these appeals. Counsel asserted that before the parties finalized stipulations on the other associated cases, PTAB entered decisions on the evidence in the record and confirmed these assessments. Despite these decisions, the parties to the appeals continued to discuss the remaining three cases and came to an overall settlement. Therefore, the appellant requests that PTAB reissue its decisions based on the three stipulations filed in these appeals.

On 02/13/2023, the appellant filed this Motion to Vacate and Reissue Decisions based upon the parties' stipulation.

The appellant's motion contends that PTAB issued a stipulated decision reducing the assessments of the pins in docket 18-46244, and as the appellant and the CCBOR have agreed to stipulate to the remaining pins as evidenced by the signed stipulations, no party is prejudiced if the original decisions for 18-46479, 18-47574, and 18-47631 are vacated and reissued based on these negotiated stipulations. Thus, the appellant requests an order vacating the originally issued decisions and reissuing the decisions entered in 18-46479, 18-47574, and 18-47631 based on the parties' stipulations.

In its motion, the appellant acknowledges that the PTAB issued the "no change" decision in three cases on 11/22/2023 (App. Mot. ¶ 5) and goes on to state:

Despite these decisions, the Appellant and the Board of Review continued to discuss and negotiate the remaining three cases and finally came to an overall settlement represented by the attached signed stipulations.

Id at ¶6

A total of 83 passed between the time the date the decisions were issue and the date the appellant filed this motion.

- e. Joseph Riggio: #21-38620.001 thru .005-C-1 (Cook) (Worth)
Chicago Title and Trust, As Trustee: #21-38621.001 (Cook) (Hyde Park)

Appellants' Motions to Reinstate

21-38620

The appellant filed this commercial appeal timely but needed to include the Final Decision of the Cook County Board of Review for the parcels being appealed. On 12/29/2022, PTAB confirmed the receipt of the appeal and requested a copy of the Board of Review's original decision for the subject property stating in the Incomplete Checklist: "BOR decision is not for subject property [sic]." PTAB provided the appellant with a due date of 01/28/2023. On 03/30/2023, PTAB dismissed the appellant's appeal for failure to submit the requested documentation per PTAB rules 1910.30(k) and 1910.69(a).

21-38621

The Chicago Title and Trust commercial appeal was timely filed with a basis of recent appraisal and a 45-day extension request to submit evidence. On 12/29/2022, PTAB confirmed the receipt of the appeal and, with an Incomplete Checklist, requested additional information, with a due date of 01/28/2023, seeking the appellant's claims and granting 30 days to submit evidence. On 03/30/2023, PTAB dismissed the appellant's appeal for failure to comply with PTAB rules 1910.30(k) and 1910.69(a) by not responding to the Board as required.

On the postmark date of 04/17/2023, the appellants, through counsel Rieff Schramm Kanter & Guttman submitted motions for reinstatement for these two appeals for the following reasons:

- On or about 01/25/2023, the appellants filed completed appeals, including amended appeal forms and supporting documentation, consisting of briefs and appraisals prepared by Property Valuation Services on 12/29/2022.
- The appellants provided a USPS receipt which shows the package containing the completed appeals and supporting documentation as mailed on 01/25/2023. An affidavit from Kathleen McMahon-Ortiz avers that on 01/25/2023, she mailed the requested documentation via Certified Mail and that their office

received acknowledgment of PTAB's receipt through a signature form signed by a PTAB employee. A copy of the USPS Certified mailing receipt and returned "green card" acknowledging the package was received by PTAB is included.

- The appellants assert the revised appeals and supporting documentation were never reviewed or decided by PTAB. The appellants believe dismissing the complaints to be an error without merit and will prevent the taxpayers' right to a decision on the evidence.

Therefore, the appellants move for the Board to grant the Motions for Reinstatement, as the appellants filed an amended their appeals along with submitting supporting evidence within 30 days and before the deadline of 01/28/2023 per Section 1910-25, Computing Time Limits.
