Appellee's (CCBOR) Motion to Vacate Order of Defaults & Accept Evidence Submitted by ZIP files (120)

Summary: The Cook County Board of Review (BOR) moves to vacate the finding of default that was entered against it on June 1, 2023. The finding of default was issued because the board of review failed to submit its evidence or seek an extension before the due date. The board of review contends that it attempted to submit its evidence timely, but due to a transmission error, its evidence was not timely filed.

Statement of Facts: On 11/03/2022, PTAB informed the Cook County BOR of the above 120 petitions. BOR was given until 02/01/2023 to submit evidence or seek an extension of time to do so. On 12/06/2022, BOR filed its extension request. On 12/06/2022, the BOR was granted a final extension with a **5/02/2023 due date**. On 06/01/2023, CCBOR was found in default for these appeals for failure to provide evidence or timely seek an additional extension of time.

On 06/23/2023, the BOR filed this Motion to Vacate Defaults. The BOR asserts that it "attempted to timely submit" its (1) documentary evidence in support of its position, (2) Notes on Appeal with an indication that BOR would stipulate, or (3) a fully executed stipulation for the above appeals.


The motion asserts that the BOR's computer system exports, every night, the corresponding evidence with the docket number, primary PIN, whether the BOR is requesting a hearing and its Notes on Appeal, and that the system time and date stamps the electronic file for each docket. However, due to transmission errors with PTAB, from March 2022 to December 2022, the CCBOR was unable to establish a connection with the PTAB's remote server on random dockets. To correct the issue, the BOR

began sending monthly zip files which contained PDFs of evidence and the text file for the above dockets.

The BOR contends it timely sent to the PTAB server on 05/02/2023, in a zip file, all evidence for all the above-defaulted dockets.

For example it shows in our system that we transmitted the evidence on 3.31.2023 for 2021-28459 which had a due date of 4.4.2023.

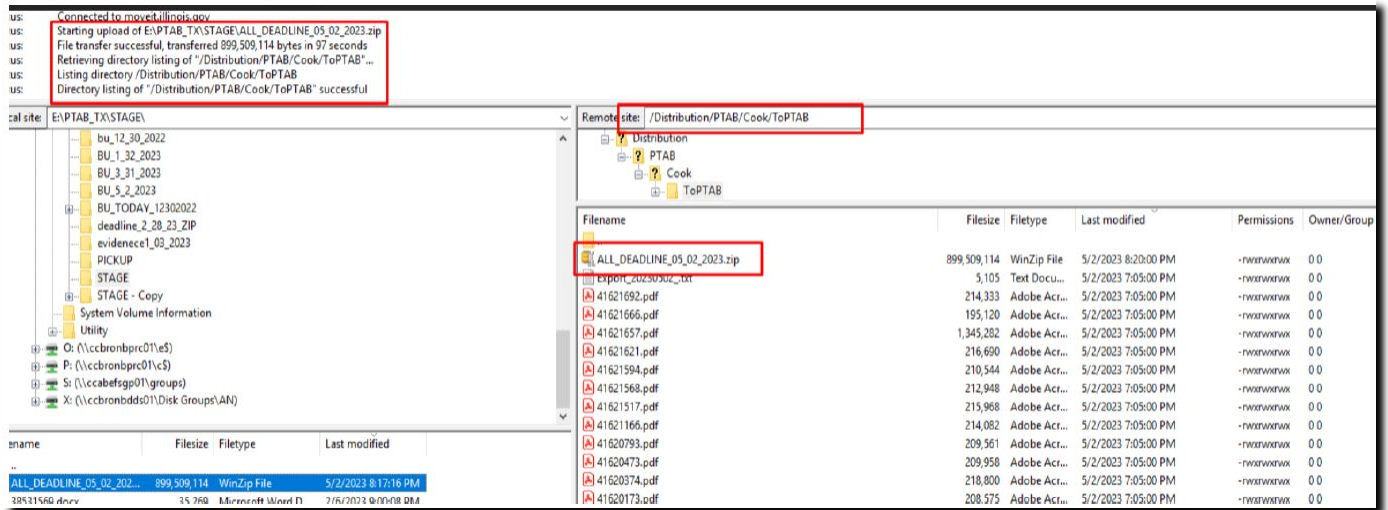

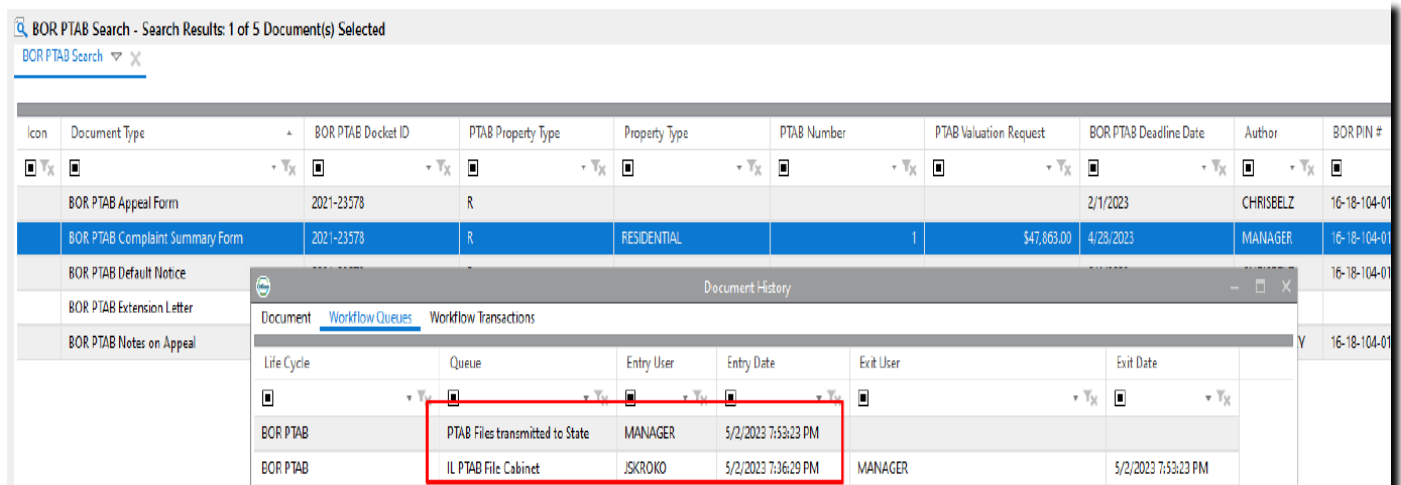

Exhibit B: The BOR argues the exhibit shows that the ZIP files containing the evidence, including the defaulted files, were placed on the PTAB server on 05/02/2023 and "was received by the PTAB."



Additionally, the BOR's internal OnBase system shows that the evidence for each defaulted file that evidence was placed into a file to be transmitted to the PTAB server on 05/02/2023. See Exhibit C for an example that corresponds to Docket 21-23578:



The BOR prays that PTAB vacates its findings of default; makes the BOR submission(s) part of the respective records; amends its dockets to indicate the BOR timely submitted evidence; and sets these matters for hearings on the merits, where requested. Or, in the alternative, the BOR requests hearings on the Motion to Vacate Default.

One of the appellants, as noted above, has no objection to the Board of Review's Motion to Vacate Default and the parties stipulated in another appeal.

Additional Facts not Plead in the Motion: According to PTAB's IT staff, initially, the BOR wanted PTAB IT staff to retrieve data from the BOR's server. PTAB declined to participate in that procedure. IT reports that the BOR unilaterally changed the electronic transmission format that was in place without consulting with PTAB IT staff first. Instead of sending transmissions daily as was standard practice, the BOR commenced at the end of the month sending a ZIP file which included both erroneous submission dates and duplicative materials that had been previously filed timely, including from many months earlier. And although the BOR Notes on Appeal and evidence for the above dockets were included in the ZIP files, in several e-mails, IT staff informed the BOR that PTAB could not accept or upload ZIP file data. PTAB IT staff also reports that PTAB servers have worked normally throughout the relevant timeframe.

Cook County Board of Review's Motion to Vacate Order of Defaults (59)

Summary: The Cook County Board of Review (BOR) moves to vacate the finding of default that was entered against it on June 1, 2023, because the board of review failed to submit its evidence or seek an extension before the due date. The board of review contends that it attempted to submit its evidence timely, but due to a transmission error, its evidence was not timely filed.

Statement of Facts: On 02/02/2023, PTAB informed the Cook County Board of Review (BOR) of the above 59 petitions. BOR was given until 05/03/2023 to submit evidence or seek an extension of time to do so. On 06/01/2023, BOR was found in default for these appeals for failure to provide evidence or timely seek an extension of time.

On 06/30/2023, BOR filed this Motion to Vacate Defaults. BOR asserts that it "attempted to timely submit" substantive documentary evidence in support of its position, the Notes on Appeal, with an indication that BOR would stipulate or a fully executed stipulation for the above appeals.

The motion asserts that the BOR computer system stamps the electronic file for each docket with a date; a timer begins to initiate every night at 8:00 p.m. that exports the corresponding evidence to a folder; the docket, primary pin, hearing requested (Yes or No), and the Notes sent date is stamped in a text file, and each subsequent docket is appended with the same field to the daily text file.

However, reportedly due to "transmission errors" on February 22, 2023, and February 23, 2023, the BOR was unable to establish a connection with the PTAB's remote server on random dockets.

The BOR driving database was shown to have completed the appropriate evidence and exported the files. Exhibit A, page 1, depicts a single computer record for 19-55373:

The BOR reports that the files were not moved to the PTAB server since a connection could not be made. The BOR will send the same evidence to the PTAB server instantly if the motion is granted.

Wherefore, the BOR prays that PTAB vacates its findings of default; makes the BOR submission(s) part of the respective records; amends its dockets to indicate the BOR timely submitted evidence; and set these matters for hearings on the merits [where requested]. Or, in the alternative, the BOR requests hearings on the instant Motion to Vacate Default.

Two of the appellants, as noted above, have each set forth no objection to the Board of Review's Motion to Vacate Default.

Additional Facts not Plead in the Motion: According to PTAB's IT staff, initially, BOR wanted PTAB IT staff to retrieve data from the BOR server. PTAB declined to participate in that procedure. IT reports that the BOR unilaterally changed the electronic transmission format that was in place without consulting with PTAB IT staff first. Besides daily sending transmissions as was standard practice, BOR commenced sending a ZIP file at the end of the month, which included both erroneous submission dates and duplicative materials that had been filed timely previously, including from many months earlier. In several e-mails, IT staff informed BOR that PTAB could not accept and upload this ZIP file data. PTAB IT staff also reports that PTAB servers have been working normally throughout the relevant timeframe and while records of ZIP file data have been kept in a spreadsheet, none of these 59 appeals appear in any of those unacceptable ZIP file transmissions.

- c. Teri Ross: #19-50699.001-R-1 (Cook) (North Chicago)

Agreed Stipulation to replace Final Administrative Decision issued 6/27/2023

The subject property was the subject matter of a favorable decision based upon a stipulation for the 2018 tax year in Docket No. 18-46833, reducing the assessment to \$108,811. Before the issuance of the decision on the 2018 tax year, the appellant filed an appeal for the subject property for the 2019 tax year.

After a PTAB decision was issued in the subsequent tax year, known as Docket No. 19-50699, making no change in the assessment, the parties to the appeal both agreed that the subject property was entitled to a reduced assessment in accordance with Section 16-185 of the Property Tax Code (35 ILCS 200/16-185) for an owner-occupied property when a reduction in the assessment was issued by PTAB within the same general assessment cycle ("rollover").

Per that agreement, the parties have presented a fully signed stipulation for the issuance of an Amended Decision reducing the assessment to \$108,811 for the tax year 2019, identical to the assessment agreement for the 2018 tax year.

- d. Menard, Inc.: #22-03200.001-C-3 (St. Clair)

Appellant's Motion to Reconsider Finding of Default

The appellant filed this motion to reconsider the Board's finding of default, which was issued during the June 2023 Board meeting.

Statement of Relevant Facts

June 2023 Board Meeting:

The appellant filed a Motion to Accept Evidence which was placed on the June 2023 agenda. The summary of this matter was presented to the Board as follows:

- k. Menard, Inc: #2203200.001-C-3 (St. Clair)

Appellant's Motion to Accept Evidence

This matter involves the timely filed commercial appeal of Menard, Inc. The appellant requested a change in assessment from \$6,061,740 to \$2,233,110, with a basis of a recent appraisal, and requested a 60-day extension to submit evidence. On 04/06/2023, PTAB granted the appellant an extension with a due date of 06/05/2023.

By e-mail and the e-filing portal on 06/08/2023, the appellant submitted its Motion to Reinstate and avers due to a calendaring error, the appellant's counsel did not become aware that the extension deadline of 06/05/2023 had expired until 06/08/2023. Immediately upon becoming aware that the deadline had passed, the appellant's counsel promptly e-filed this motion, the appellant's brief, and the completed 2022 appraisal on 06/08/2023. Counsel further contends that no party will be prejudiced by proceeding with the subject case, further claiming that the appellant has significant and valid claims of overassessment relating to its 2022 valuation. Therefore, any dismissal of the appeal before the hearing would result in substantial harm to the appellant.

Wherefore, the appellant requests PTAB reinstate/accept the late-filed evidence *instanter*.

The appellant missed the filing deadline, which led to the initial finding of default because of a "calendaring error." (Appl. Mot. Filed June 8, 2023 ¶6; Appl. Mot. filed June 27, 2023 ¶5; Affidavit of Steven J. Field ("[D]ue to internal docketing error, our

firm's calendar ... inadvertently omitted the June 5 deadline.")). During the discussion of the motion, the Board asked why the appellant missed the June 6 filing deadline. The Board was informed of the calendaring error. The Board voted to deny the appellant's request to accept the untimely filed evidence. By letter issued on 06/21/2023 (June 21 Letter), the appellant's counsel was informed of the Board's decision and that the appeal was dismissed. The June 21 Letter did not state that the decision was final and appealable.

Motion to Reconsider:

The appellant filed this motion and a Memorandum in Support of Jurisdiction, which asserted, among other matters, that the June 21 Letter did not divest the Board of jurisdiction as it did not include the terms that the decision was a final and appealable ruling (735 ILCS 5/3-101 et seq. and Section 16-195 of the Property Tax Code).

As such, since the Board has not been divested of its authority in this matter, the appellant seeks for the Board to utilize its equitable authority and consider factors such as the history of the appeal, the length of time that has elapsed since the last action taken in the appeal, and/or the contesting party's compliance with any Board or Hearing Officer requests or orders. (86 Ill.Admin.Code Sec. 1910.69(e)) Given the foregoing arguments, the appellant requests that PTAB exercise its jurisdiction and reinstate this appeal with the appraisal evidence that was submitted three days late.

The appellant puts forth the following arguments:

1. "Extreme" Prejudice to Appellant.
2. Lack of Prejudice to Other Litigants.
3. "NON-Final extension deadline.
4. Good Faith Efforts to Comply.
5. History of Compliance. (History of the appellant's law firm of compliance and good faith dealings at PTAB).
6. Inadvertent Error.
7. PTAB has granted other parties extensions under similar circumstances.

The appellant also filed a memorandum of law arguing that PTAB's denial of the motion to reinstate resulted in the denial of the appellant's procedural due process and that it was an error for PTAB not to consider the other unrelated cases.

- e. Polk Tech Partners, LLC: 21-29278.001-I-3 (Cook) (West Chicago)

Intervenor's Request for an Extension

This appeal involves an industrial appeal of Polk Tech Partners, LLC, from a Cook County Board of Review (CCBOR) final decision. The basis of the appeal is a recent appraisal. The appellant seeks a reduction in assessment from \$4,790,635 to \$2,875,000. CCBOR certified that copies of the above petition were mailed to all taxing districts on 10/18/2022.

- On 12/19/2022, the City of Chicago submitted its request to intervene in the above matter and was added as an interested party on 12/29/2022. The City was given until 03/29/2023 to submit evidence or request an extension.
- On 03/28/2023, the City of Chicago submitted an extension request to submit documentary evidence and submitted its rebuttal evidence.
- On 04/13/2023, PTAB granted the City of Chicago a FINAL 90-day extension with a due date of 07/12/2023.
- On 07/11/2023, the City of Chicago submitted its Motion for an Extension. The City's attorney prepared an affidavit in support of its request. According to the affidavit:

As early as March 24, 2023, the City of Chicago retained Kathleen Dart, MAI, of KMD Valuation Group, LLC, to prepare the City's appraisal evidence in this matter. As of July 5, 2023, due to a family health emergency, Ms. Dart requires an extension to complete the appraisal and will be unable to complete the work by July 12. Ms. Dart has "done significant work on the appraisal."

The extension motion was served upon both the BOR and the appellant's counsel of record. In conclusion, the City of Chicago requests PTAB grant an additional final extension to submit its evidence.

The intervenor City of Chicago, has already had 180 days to submit its evidence.

- f. Menards, Inc: #22-03013.001-C-3

Motion Requesting Leave to Intervene

This appeal involves a commercial appeal of Menard, Inc, from a Kendall County Board of Review final decision, the basis of which is a recent appraisal. The appellant seeks a reduction in assessment from \$2,247,250 to \$1,733,160. The BOR certified that copies of the above petition were mailed to all taxing districts on 04/21/2023.

On 07/14/2023, the Community Unit School District 308 (CUSD 308) requested PTAB grant leave to intervene for the following reasons:

KCBOR notified the applicable taxing districts of the 2022 appeal electronically. CUSD 308's Director of Technology asserts Google provides the e-mail server, and it establishes the filtering protocol. The server diverted the Notice E-mail to a spam folder, where it was later automatically deleted under the Google cybersecurity protocol and was not delivered to the inbox of the intended recipient of CUSD 308. Exhibit A:

- CUSD 308 has now added the domain "kendallcountyil.gov" to the "allow" list in order to minimize the likelihood that this issue will reoccur.
- On 07/06/2023, counsel for CUSD 308 learned that the 2022 appeal had been filed, and a notice appeared to have been sent to CUSD 308. Upon becoming aware of the appeal, CUSD 308 acted diligently. KCBOR had not yet filed its evidence in the 2022 appeal.
- CUSD 308 contends that it did not have actual notice of the 2022 appeal until 07/06/2023. Despite CUSD 308's due diligence to address all assessment matters in a timely manner, their request to intervene is not filed within 60 days

of the postmark on the notice sent by e-mail, but it is filed within approximately one week of their actual notice of the 2022 appeal.

- Due to the substantial reduction requested by the appellant and in the interest of judicial efficiency, CUSD 308 has already authorized the completion of an appraisal and engaged an appraiser so that only an initial extension upon being granted leave to intervene would be required. It is the CUSD 308 understanding that such a timeline would be consistent with the KCBOR's anticipated final evidence deadline and would cause no additional delay.
- CUSD 308 believes the interests of substantial justice and fairness support its request for leave to intervene. The window for filing evidence has not closed and allowing CUSD 308 to intervene would cause no delay and will provide valuable evidence in this appeal.

Therefore, the CUSD 308 requests leave to file its request to intervene and request PTAB grant said request to intervene along with a 90-day extension to file its evidence.

Tax Code and Administrative Rules:

Section 16-180 of the Property Tax Code (35 ILCS 200/16-180) provides in pertinent part: In all cases where a change in assessed valuation of \$100,000 or more is sought, the board of review shall serve a copy of the petition on all taxing districts as shown on the last available tax bill.

Procedural rules of the PTAB are specific as to intervening by a taxing district at 86 Ill.Admin.Code Sec. 1910.60(d): Any taxing body that has a revenue interest in an appeal before the Property Tax Appeal Board may become an intervening party by filing in triplicate with the Clerk of the Property Tax Appeal Board a Request to Intervene through legal counsel in accordance with Section 1910.70(c). The Request to Intervene must be filed within the later to occur of:

- A) 60 days after the postmark date of the notice of the Board to the State's Attorney of the filing of an appeal; or
- B) within 60 days after the postmark of the board of review service as required in Section 16-180 of the Property Tax Code.

- g. Ursa Farmers Co-Operative Co.: #21-02981.001-C-3 (Adams)

Appellant's Motion for Request for Subpoena *Duces Tecum*

This appeal involves the timely filed commercial appeal of Ursa Farmers Co-Operative Co. from an Adams County Board of Review (BOR) final decision, with a basis of contention of law and assessment equity. The appellant seeks a reduction in assessment from \$3,895,720 to \$1,503,400.

On 07/21/2023, the appellant filed its Motion for Subpoena *Duces Tecum*, and requested that the Property Tax Appeal Board issue a subpoena *duces tecum* to the BOR to appear and testify at the hearing scheduled on 08/17/2023 for the following:

- The Board of Review submitted evidence that contained the "characteristics" regarding the assessments of other Grain Elevator facilities located in Adams and Hancock Counties.
- The BOR's evidence demonstrates that similar grain bins are being assessed in a different manner and at a significantly lower value per bushel of grain bin capacity than the grain bins on the subject property.
- The BOR evidence submitted to PTAB contained Exhibit D consisting of 66 pages which noted the "characteristics" of the comparable grain elevator facilities and also contained the county-prepared Property Record Card (PRC) for each property. The first page of Exhibit D contains a summary chart of the Subject Property and 8 comparable facilities.
- The BOR Chart for **Comp #5** which is the Dearwester Liberty facility shows "2 bins age '20 & '21." The PRC submitted for PIN 14-0-0324-000-00 shows a new 2021 improvement assessment of 107,310 for a parcel that had **no 2020** improvement assessment. The PRC identifies a "Lg bin" with an assessment of 33,070 and a line item for "bin" with an assessment of 46,160. Adding those two assessments together results in an assessment of 79,230 which equates to a market value of \$237,714. The BOR also submitted a Grain Bin Capacity Chart for Comp #5 showing a capacity for this property of 249,769 bushels. The Grain Bin Capacity Chart shows the 2 new bins having bushel capacities of 141,446 and 94,943, making the total capacity of the two new bins 236,389 bushels. The newly added assessment for these new bins is therefore based on a market value of approximately \$1.00 per bushel. The PRC for the Subject Property reveals that 2 of the Taxpayer's bins are being assessed at a market value of \$8.12 per bushel, and two bins are assessed at a market value of \$3.51 per bushel. The BOR should explain this very wide disparity.
- The BOR Chart for **Comp # 1**, the Dearwester LaPrairie/Chatton facility, shows "1 bin age 2021." The PRCs for this property do not show any change in the assessment for this property other than the annual Township multiplier. The Grain Bin Capacity Chart that the BOR submitted shows a capacity for Section

K of 213,971 bushels. The taxpayer filed a FOIA request to the Illinois Department of Agriculture, and the taxpayer obtained the Grain Bin Capacity Chart for this facility. The public record we received shows a capacity for Section K of 482,297. Dearwester's website has a video of small bins being demolished in 2018 and a new BIN being constructed. Section "K" on the FOIA request shows a new BIN with a 384,494-bushel capacity. The bins for this property are located on PIN 04-0-0111-000-00. There are no changes in the improvement assessment on that PIN other than the annual multiplier for many years. It is clear from Exhibit D that the Adams County Assessment officials knew about the new 384,494-bushel bin age 2021. The BOR should provide an explanation for why the County added new assessments for the Subject Property's BINs in 2021 and did not add a new assessment for the Dearwester LaPrairie / Chatton facility's new bin.

- The BOR had information regarding the assessment of a property in Hancock County. The BOR should testify as to why they have this information and where it was obtained.
- The PRC submitted by the BOR for the subject property had a very detailed listing of the bin capacity. None of the other PRCs submitted by the ACBOR have this information. The per bushel bin capacity is the predominant unit of measure used to compare grain elevators. The ACBOR should testify as to why the Adams County assessing officials are treating the subject property differently.
- The ACBOR Chart did not list a figure for Licensed Bushels for Comp # 8, which is the ADM Quincy facility on Gardner Expressway. The BOR evidence did not contain a Grain Bin Capacity Chart for the ADM plant either. The BOR had a Grain Bin Capacity chart for the other grain elevator facilities. The fact that the BOR has these charts for other facilities shows that the BOR knows how to obtain them. The BOR even had a chart for a property in Hancock County. The appellant filed a FOIA request to the Illinois Department of Agriculture, and the taxpayer obtained the Grain Bin Capacity Chart for the ADM Gardner Expressway facility. The BOR should explain why Comp #8, on the BOR Chart, has an improvement assessment of only \$1.21 per bushel capacity as compared to the much higher assessment of the Subject Property.
- The appellant requested the subject property PRC from the Adams County assessing officials. The PRC submitted to PTAB in its evidence was the PRC supplied by Adams County. Why is the PRC supplied to the taxpayer through FOIA different than the PRC submitted to the PTAB by the BOR? The BOR should explain this difference.

The taxpayer requests that the PTAB issue a Subpoena *duces tecum* requiring the Adams County Board of Review to provide testimony of the person(s) who prepared the documentation submitted to the PTAB and testimony regarding the disparate assessment treatment between the Subject Property and the comparable properties.

On July 27, 2023, the Adams County Board of Review filed a written objection to issuing the requested subpoena. The BOR argues that the subpoena is defective because it does not comply with 1910.68(a). The BOR also contends that the information sought in the subpoena will not facilitate the determination of the correct assessment.

The appellant responded to the BOR's objection. The appellant argues that the subpoena is appropriate because it will help facilitate why the comparable properties were treated differently than the subject property. The appellant also states that they did not comply with 1910.68(a) to show deference to the BOR.

On August 10, 2023, the intervenor filed an objection to the issuance of a subpoena. The intervenor argues that the request is late under section 1910.68(b) in that the request was filed after the July board meeting, so it will not be issued until two days before the scheduled hearing.

Procedural rules provide that a subpoena shall be served reasonably in advance of its return date. "The party requesting the subpoena shall serve the subpoena **on any witness at least 7 days before the scheduled hearing date** before the Board." (86 Ill.Admin.Code Sec. 1910.68(b)).

- h. Stanley Mozdzen: #21-57609.001-R-1 (Cook)

Appellant's Motion to Reinstate

This appeal was originally filed on 6/2/2023. The basis of this 2021 tax year residential appeal is a direct appeal based on, according to the petition, a favorable decision of the Property Tax Appeal Board that was issued for this property on 09/20/2022 - Docket No. 20-44140. The "direct appeal" was filed on 06/02/2023, not within 30 days of 09/20/2022. The appeal was dismissed by PTAB as untimely on 06/22/2023. The appeal was not filed within 30 days of the favorable decision issued by PTAB.

On 07/19/2023 by e-mail, counsel submitted the appellant's Motion to Reinstate, contending that the 2021 tax year appeal to PTAB was timely filed based on a Cook County Board of Review decision for **tax year 2022**, which was issued on 05/03/2023.

The Property Tax Code provides a party may file an appeal with PTAB (1) within 30 days of a final decision of a county board of review; (2) within 30 days of a notice of

equalization issued by a county board of review; and (3) within 30 days of a favorable PTAB decision for the subsequent year or years of the general assessment cycle, if the board of review is closed at the time of filing.

- i. Garden Building LLC: 21-33736.001-C-2 (Cook) (Hyde Park)

Intervenor's Request for an Extension

This is a timely filed commercial appeal by Garden Building LLC from a Cook County Board of Review (BOR) final decision. The basis of the appeal is a recent appraisal. The appellant is seeking a reduction in assessment from \$357,947 to \$62,500. On 12/01/2022, PTAB notified the BOR of the above appeal. On 12/13/2022, the BOR-certified copies of the above petition were mailed to all taxing districts.

- On 01/13/2023, the Chicago Board of Education (CBOE) entered its request to intervene in the above matter. PTAB accepted CBOE as an intervenor on 01/26/2023 and granted a 90-day extension to submit evidence by 04/26/2023.
- On 04/06/2023, the intervenor requested an additional 90-day extension; on 04/27/2023, PTAB granted a *final* 90-day extension with a due date of 07/26/2023.
- On 07/26/2023, the intervenor requested an additional 90-day extension to submit evidence by merely citing Section 1910.60(f).

The request did not set forth good cause.

- j. Michael J. & Susan L. Aurand: 22-03294.001-R-1 (Stephenson)

Board of Review's Request for an Extension

This timely residential appeal was filed by Michael J. & Susan L. Aurand from a Stephenson County Board of Review (BOR) final decision, with a basis of comparable sales. The appellants request a reduction in assessment from \$18,635 to \$13,333. On 04/27/2023, PTAB informed BOR of the above appeal and provided a due date of 07/26/2023 to submit evidence or a request for an extension of time to submit evidence.

On 08/07/2023, BOR submitted its request for an extension averring the original e-mail from PTAB was lost in a host of other e-mails sent to the Clerk of the Board of Review. Additionally, when the e-mail was discovered before the deadline to submit evidence, it was not able to be retrieved via the link in the original e-mail.

Therefore, SCBOR requests an extension to submit its evidence.
