 - a. Menard, Inc.: #22-01199.001 thru .002-C-3 (Adams)

Intervenor's Motion to Vacate Default & Adopt Evidence [of BOR] *Instanter*

This matter is a commercial appeal consisting of 2 parcels of Menard, Inc., filed from an Adams County Board of Review (ACBOR) Decision. Menard is seeking a reduction from \$3,016,760 to \$2,033,130, and the basis of its appeal is an appraisal.

Timeline:

- 02/09/2023 – PTAB accepted the appellant's petition as sufficient. On 02/16/2023 – ACBOR certified that copies of this petition were mailed to all taxing districts.
- 04/06/2023 – Quincy School District #172 submitted its request to intervene.
- 04/27/2023 – The PTAB added them as an interested party (intervenor) along with an extension of time to file evidence or request an additional extension by **07/26/2023**.
- **08/15/2023** – The PTAB **defaulted** the intervenor for failure to submit evidence.

On 08/22/2023, Quincy School District #172 filed this Motion to Vacate [the] Order of Default and Request to Adopt Evidence Submitted *Instanter* as follows:

- The intervenor has been involved in multiple proceedings before PTAB as Intervenor in conjunction with appeals of ACBOR decisions and counsel has not had any issue with the receipt of communications from PTAB, specifically electronic correspondence, until this instance.
- Upon notice of default, counsel contacted PTAB to determine what happened. The appellant states that PTAB emailed a letter to counsel on 04/27/2023, which contained deadlines to submit evidence.
- Counsel for the intervenor does not recall receiving the 4/27/2023 letter or email, which contained a link to the letter, although PTAB does show the email was sent, which included a link to the letter. Counsel submits that it can find no record where the 04/27/2023 email or letter was opened or accessed by counsel for the intervenor. However, the email was discovered by counsel's IT department, who determined it was held up in the firm's security system since it contained an unfamiliar link.
- Counsel has made sure that email addresses from PTAB are now on the approved email contacts so they will not be held up again in the firm's email security system.
- The intervenor avers the error in communication is the reason the motion to adopt evidence was not submitted prior to the 07/26/2023 deadline. The intervenor does not intend to file additional evidence but only requests to adopt the evidence of Adams County as its own.
- Vacating the default and allowing the intervenor's motion to adopt the evidence of Adams County *instanter* does not prejudice any party in this case. This motion is brought at the earliest opportunity since receiving the PTAB notice of default.

Therefore, the intervenor requests that the default be vacated and to adopt the evidence previously submitted by Adams County as its own *instanter* be granted.

- b. Highgate Partners: #22-27948.001 thru .002-C-2 (Cook) (Elk Grove)

Appellant's Motion for an Extension

This commercial appeal of 2 parcels by the appellant, Highgate Partners, was filed on 05/13/2023. Based on an appraisal, the appellant is seeking a reduction assessment

from \$711,188 to \$500,000. The initial appeal requested a 90-day extension. On 06/08/2023, PTAB granted the appellant a 90-day extension with a due date of 09/06/2023. On 09/05/2023, the appellant filed this motion “respectfully request[ing] an additional extension of time to file evidence while an appraisal is completed.”

The initial extension letter of the PTAB states, in part, “if further time is needed, a written request must be submitted indicating **good cause** why the Board should grant the additional extension.”

- c. Timothy Johnson: #22-27138.001-R-1 (Cook) (New Trier)

Appellant’s Motion for an Extension

This is a timely residential appeal of Timothy Johnson from a Cook County Board of Review (CCBOR) decision. The appeal was filed on 5/10/2023, along with a request for 30 days for the appellant to submit its evidence. The appellant seeks a reduction in assessment from \$232,814 to \$165,000 and indicated that the basis of the appeal is to be a recent appraisal.

- On 06/08/2023, PTAB granted the appellant a 60-day extension due to 08/07/2023.
- On 08/07/2023, the appellant requested a 30-day extension to prepare the supporting documentation.
- On 08/17/2023, PTAB granted an additional 30-day extension with a new due date of 09/16/2023.
- On 09/16/2023, the appellant requested another 30-day extension to prepare the supporting documentation.

- d. Lynne Swieton: #21-07844.001-R-2 (Lake)

Appellant’s Motion to Reconsider (reinstate dismissed appeal)

This residential appeal was timely filed as a direct appeal from a 20-05411 favorable PTAB decision. The appellant submitted two separate appraisals with this appeal. The appellant seeks a reduction in assessment from \$245,400 to \$108,323.

Incomplete Checklist: On 04/20/2023, PTAB issued the appellant an incomplete checklist with a due date of 05/20/2023, requesting the appellant indicate which of two submitted appraisals the appellant wishes to use in support of the subject assessment. The PTAB also asked the appellant to provide a breakdown between land and building

assessment for the subject property as there appear to be improvements in place based on the appraisal reports submitted. On 09/14/2023, the appeal was dismissed for failure to respond to the incomplete checklist.

On 09/25/2023, the appellant submitted its Motion to Reconsider dismissal and reinstate the above appeal as the initial appeal was clear and correct on its face. In response to the incomplete checklist, the appellant submits:

- In reference to the request to provide a breakdown between land and building assessment for the subject property, the appellant avers the original petition requested an assessed value of \$108,000 (market value of \$325,000) for land and \$0 for building. The \$0 request for the building value is based on the two appraisals provided. The first appraisal provided as of 01/01/2021, Joseph Raymond Herchenbach CIAO, which is the main appraisal supporting the \$325,000 market value states:

“Subject was not heated/occupied at site visit and is not currently habitable.” and “The subject and all sales had limited value attributed to their improvements due to poor overall condition.” The appraisal also states: “The cost approach is not applicable due to the subject being an older residence that is nearing the end of it’s [sic] economic life with nearly complete depreciation.”

Additionally, Harrison & Associates appraisal as of 10/25/2022 indicates, “for valuation purposes in this assignment, I have assumed that the residence is non-contributory to value, and in conjunction with achieving the highest and best use of the land, it should be demolished.”

In response to the request to indicate which appraisal the appellant wishes to use, the appellant responds:

- As stated in the brief filed with PTAB appeal, "Please see the attached appraisal with a valuation date of 01/01/2021, with an opinion of value of \$325,000." This language in the brief makes it abundantly clear the appraisal the appellant wishes to use in support of the subject assessment is the first (Herchenbach) appraisal provided. In contrast, the Harrison & Associates appraisal states, “as of 10/25/2022,” and clearly states the appraisal is for a market value of \$328,000. The Harrison & Associates’ appraisal was filed as additional evidence to support the appellant’s claim.

No parties are prejudiced by the inclusion of two appraisals that reach the same conclusion within \$3,000 of each other.

Due to the fact the initial appeal was clear and correct on its face, the appellant requests the Board reconsider its dismissal of the above matter and reinstate the appeal as originally filed. PTAB should not have drawn a conclusion against the appellant because the evidentiary record was in some fashion deficient or incomplete on its face. The initial filing was complete.

e. Kevin Keeley: #22-03701.001-R-1 (St. Clair)

Appellant's Motion to Reinstate

On 04/04/2023, Kevin Keeley untimely submitted a residential appeal with a basis of comparable sales from the St. Clair County Board of Review equalization decision dated 02-24-2023.

The appellant submitted a letter of personal hardship and requested PTAB accept the appeal of his current 2022 assessment, as the appellant recently went to the courthouse in Belleville and was advised that he could only appeal his taxes once the tax bill came out. The appellant also requested that PTAB determine if the appellant could receive exemptions for his 2022 taxes, as he is a senior citizen and is disabled. The appellant stated there were extenuating issues that caused the delay in getting the petition to PTAB.

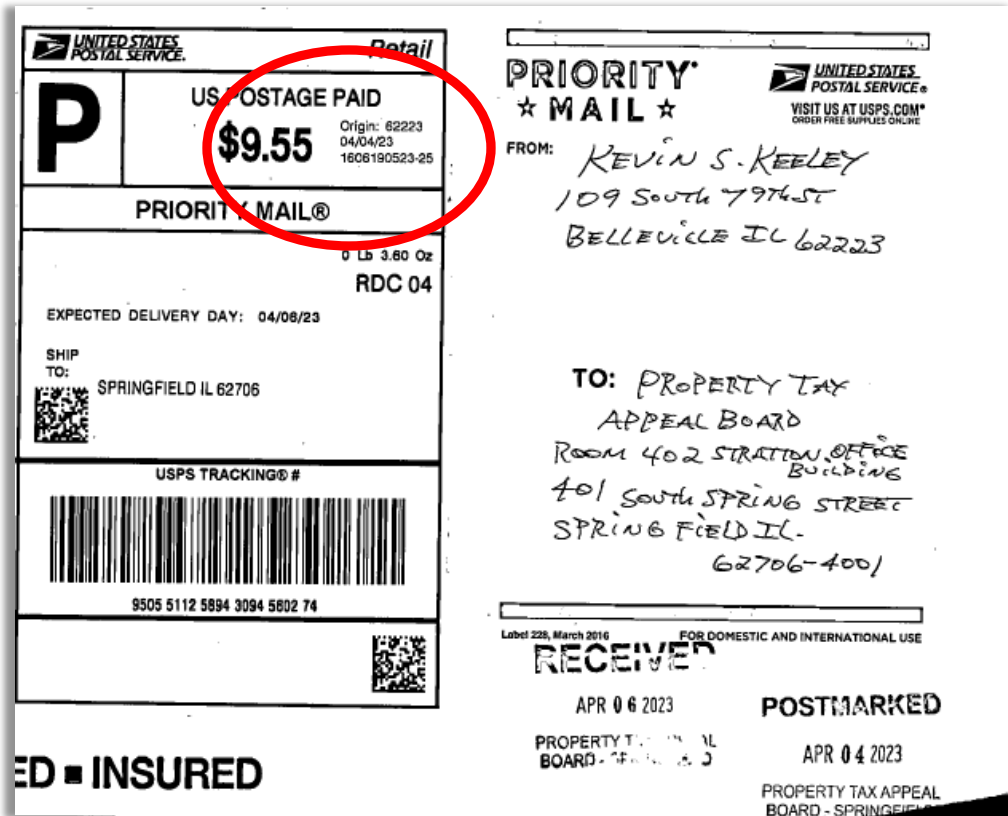

On 04/13/2023, the appellant sent a second petition for the above property, requesting a 30-day extension to provide additional evidence. The appellant again requested PTAB grant assessment exemptions.

On 05/11/2023, PTAB sent the appellant an incomplete notice requesting the appellant provide additional information to complete the appeal process, with a due date of 06/10/2023.

On 06/08/2023, the appellant submitted an amended appeal form with BOR assessment information that did not match the BOR decision letter and an incomplete comparable sales/assessment grid analysis.

On the postmark date of 06/17/2023, in a letter, the appellant stated he did not prepare his appeal sooner because of a medical issue this past year, and he was not aware he missed the deadline. The appellant averred it was not his job or obligation to know PTAB's process or St. Clair County dates. The appellant requested an extension to work with a realtor to complete the appeal. The appellant also requested that PTAB

submit his exemption paperwork to the correct office, the Illinois Department of Revenue.

On 07/13/2023, PTAB granted the appellant a final 60-day extension to submit evidence, with a due date of 09/11/2023.

On the postmark date of 09/06/2023, the appellant provided additional evidence that included an amended appeal form.

On the postmark date of 09/08/2023, by letter, the appellant requested PTAB consider the following extenuating circumstances:

- The appellant asserted that 24 months ago, the St. Clair Assessor, Jennifer Gomic, should have advised him to put his inherited property in his name and granted four exemptions to which the appellant avers he is entitled.
- The appellant was informed he has a medical condition that left him weak.
- The appellant averred he was led to believe he was going to receive lower taxes and exemptions which were untrue.

On 09/28/2023, PTAB issued the appellant a Letter of Dismissal for failure to provide substantive documentary evidence or legal argument sufficient to challenge the assessment of the subject property.

On the postmark date of 09/27/2023, the appellant submitted his Motion for Reinstatement, with proof his evidence was mailed to PTAB on 9/06/2023 and 09/08/2023. The appellant resubmitted his amended appeal form.

On the postmark date of 09/28/2023, the appellant mailed another amended appeal form with a cover letter.

On 09/29/2023, by email to the PTA.Clerk, the appellant submitted a complete amended appeal form requesting a reduction in assessment from \$45,101 to \$23,500.
