 - a. Grand Tower Energy Center LLC: #22-02860.001 thru .010-I-3 (Jackson)
There are two motions for the Board's consideration.
 - 1. Board of Review Amended Motion to Allow Discovery & Extend Deadline, Response & Reply.**
 - 2. Appellant's Motion to Default Couty of Jackson and Dismiss Request for Subpoena (Filed 10/3/2023).**

This timely industrial appeal comprises ten parcels by Grand Tower Energy Center LLC from a Jackson County Board of Review (JCBOR) decision. Grand Tower Energy Center LLC is asking for a change in assessment from \$12,952,313 to \$583,058; the basis is appraisal.

The board of review's motion was originally filed in June, but PTAB ordered a prehearing conference to attempt to narrow the issues. Subsequently, the motion was narrowed by an amended filing on 09/20/2023. The board's current deadline for submission of evidence was 09/20/2023, which the board of review seeks to extend by its motion.

Timeline

- 03/09/2023 – PTAB accepted the appellant’s petition, and JCBOR was notified.
- 06/01/2023 – JCBOR submitted its Motion for Request for Discovery and to Stay Deadline for Respondent’s Notes on Appeal.
- 06/02/2023 – JCBOR requested an extension.
- 06/13/2023 – Grand Tower Energy Center LLC responded to JCBOR’s Motion to Allow Discovery and to Stay Deadline for Respondent’s Notes on Appeal.
- 06/22/2023 – PTAB granted JCBOR’s extension request with a due date of 09/20/2023.
- 06/27/2023 – JCBOR replied to the appellant’s response dated 06/13/2023.
- 08/18/2023 – The PTAB conducted a prehearing conference on the pending motion with the parties. **The parties reported they would request to stay this motion** to allow time to amend the same and narrow the requests.

On 09/20/2023, JCBOR filed an Amended Motion to Allow Discovery and to Stay Deadline for Respondent’s Notice of Appeal as follows:

- Appellant submitted an Appraisal Report dated August 4, 2021, with an opinion of the subject’s fair cash value as of January 1, 2020. Said Appraisal Report described damage to the subject property caused by mechanical failure and fire.
- JCBOR requests the opportunity to conduct limited discovery into the following topics:
 - Financial statements, appraisals, application of funds, UCC filings, and disbursements from Main Line Generation, LLC to the taxpayer pursuant to the First Amendment to Mortgage and Security Agreement dated March 4, 2021, recorded as Jackson County document 2021R001370 which memorialized the increase in the line of credit extended to the taxpayer (as borrower) from Main Line Generation, LLC (as lender) from Twenty Million Dollars in February 2017 to Thirty-Five Million Dollars.
 - Insurance claims, settlement statements, and documentation of use of insurance claim proceeds for replacement or repair of subject property following the mechanical failure and fire described in the taxpayer’s appeal.
- JCBOR bases this request on the 2002 Ameren Grand Tower Station Settlement Agreement, which established that improvements at the generating station, whether completed or to be constructed in the future, shall be classified and assessed as follows: 50% of the improvements shall be considered real property for purposes of taxation, and 50% shall be considered personal property and not subject to taxation. A copy of the agreement is attached to this Motion in

Exhibit 1. This agreement has been submitted as evidence in previous PTAB proceedings concerning the subject property by the taxpayer, including PTAB case 21-05950.

Wherefore, JCBOR requests:

- PTAB grants JCBOR leave to propound interrogatories and submit requests for documents to the taxpayer.
- PTAB stays the deadline for submission of Notes on Appeal until the respondent's discovery request has been either granted or denied. If granted, adequate time has been allowed to propound discovery as authorized.

On 09/25/2023, Acting Chief Administrative Law Judge (ALJ) Carol Kirbach sent an email to all parties involved in the above matter. ALJ Kirbach confirmed that JCBOR submitted their amended Motion on pending discovery issues on 09/20/2023, the same deadline for the evidence to be submitted, and advised the pending Amended Motion will be considered by PTAB and may or may not retroactively extend the deadline for submission of evidence from JCBOR.

On 10/03/2023, Appellant, Grand Tower Energy Center, LLC submitted its Motion to Default Jackson County Board of Review and Dismiss Request for Subpoena and avers the following:

- The JCBOR's second deadline to submit evidence in the matter was 9/20/2023. The JCBOR's first deadline was 06/15/23, and the BOR timely filed a request for an extension to file on 06/12/23, which was granted until 09/15/2023.
- The appellant avers Acting Chief ALJ Kirbach's email to all parties regarding this matter points out the deadline was 09/20/2023 for the JCBOR to file a third request for an extension to submit its evidence, and the deadline to file an extension has passed.
- In 40 years of practice before PTAB, it has never retroactively extended the deadline to submit evidence for a party once the deadline has passed without a timely request for an extension. And PTAB never expressly waived the filing requirement in this matter.
- The JCBOR is technically in default for failure to file evidence in this matter timely and cannot cure this default.
- The deadline to request a third extension to file evidence passed and JCBOR filed an amended motion for discovery on 09/20/2023.
- The appellant believes any response to the amended discovery motion should be stayed until PTAB rules on the appellant's Motion to Default JCBOR as JCBOR currently is not in compliance with PTAB rules.

- JCBOR will not be fatally harmed by the granting of this Motion for Default as there are two intervening taxing bodies who still have time to submit evidence in this matter.

The appellant requests PTAB find JCBOR in default for failure to file evidence timely, and the appellant requests JCBOR's Motion for Subpoena be denied.

- b. The Rail Bar: #21-40412.001-C-1 (Cook) (Lakeview)
Viorel Lung: #21-40400.001-C-1 (Cook) (Lakeview)

Appellants' Motions to Reinstate

These matters are commercial appeals by The Rail Bar and Viorel Lung from Cook County Board of Review (CCBOR) decisions.

- The Rail Bar is seeking a change in assessment from \$193,608 to \$110,000.
- Viorel Lung is seeking a change in assessment from \$48,735 to \$25,000.

Both appellants requested 30-day extensions with their initial filing. The basis of their appeals is contention of law and assessment equity.

Timeline

- 01/12/2023 - PTAB granted final extensions for both appeals with due dates of 03/13/2023.
- 03/07/2023 - Viorel Lung submitted its evidence.
- 03/13/2023 - The Rail Bar submitted its evidence.
- 05/11/2023 - PTAB issued both appellants incomplete checklists with requests for additional evidence with a due date of 06/10/2023.

- 9/21/2023 – In the absence of data responsive to the incomplete checklists, PTAB dismissed both above appeals for to complete the Section V grid analysis of equity comparables in the e-filing portal rather than a self-prepared chart of comparable properties.

On 10/04/2023, the appellants submitted their Motions to Reinstate the above appeals as follows:

- The attorney of record for the above appeals avers their office was not made aware these two appeals received incomplete checklists and therefore did not know anything was due for the files.
- The attorney agrees checklists were received for six other dockets with the PTAB letter dated 05/11/2023, and those checklists were returned on 06/10/2023. However, the above appeals were not among the checklists received.
- There would have been no reason they would have purposely not sent back the requested checklist requests to PTAB.

Therefore, the appellants request that PTAB reconsider the above decisions to dismiss and reinstate the appeals. The appellants are willing to submit all information needed to complete the above appeals upon the granting of this motion to reinstate the appeals.

- c. Tatiana Boitchouck: #20-28382.001-C-1 (Cook) (West Chicago)

Appellant's Motion to Reinstate [Vacate Decision] and Withdraw Petition

This appeal involves the commercial appeal of Tatiana Boitchouck, filed from a Cook County Board of Review (CCBOR) decision requesting a reduction in assessment from \$80,701 to \$55,000. The basis of the appeal was a recent appraisal and assessment equity.

Timeline

- 09/02/2021 - PTAB accepted the appellant's petition and notified the CCBOR of the appeal.
- 06/02/2023 - The appellant submitted a proposed Stipulation of Assessment, agreeing to a change in assessment to \$93,000.
- 07/06/2023 - PTAB forwarded the appellant's proposed Stipulation of Assessment, agreeing to a change to \$93,000 to CCBOR.
- 09/19/2023 - PTAB issued a final administrative decision per the appellant's proposed stipulated assessment of \$93,000, as the CCBOR did not respond to the offer.

On 10/11/2023, the appellant submitted its Motion to Reinstate Appeal [Vacate Decision] and Withdraw the appeal for the following reasons:

- The appellant's counsel incorrectly filed a proposed stipulation instead of withdrawing the above appeal, as the CCBOR had given a reduction that year.
- The appellant's attorney accidentally overlooked the assessment reduction of the 2020 tax year.
- As the decision stands, the taxpayer's assessment will be raised from \$80,701 to \$93,000, resulting in a tax bill of \$2,400 being sent to the taxpayer.

The appellant's attorney apologizes for the error, which was only just noticed, as they are catching up with the deadlines. The attorney also apologizes for the oversight and the inconvenience. The appellant respectfully requests to have the error corrected.

CCBOR does not object to the motion.

- d. Pui Moy: #21-39735.001 thru .009-C-3 (Cook) (South Chicago)

Intervenor's Motion for an Extension

This matter involves the timely filed commercial appeal comprising nine parcels by Pui Moy from a Cook County Board of Review (CCBOR) decision seeking a change in assessment from \$918,309 to \$237,500. The basis of the appeal is a recent appraisal.

Timeline

- 01/05/2023 - PTAB accepted the petition, and CCBOR was notified of the appeal.
- 01/17/2023 - CCCBOR certified that copies of this petition were mailed to all taxing districts.

- 02/15/2023 - The Chicago Board of Education (CBOE) submitted its request to intervene.
- 03/09/2023 - PTAB added CBOE as an interested party (intervenor) and granted an extension of time to file evidence or request an additional extension by 06/07/2023.
- 06/07/2023 - CBOE requested an additional 90-day extension.
- 06/29/2023 - PTAB granted CBOE a final extension with a due date of 09/27/2023.

On 09/26/2023, CBOE requested an additional 60-day extension to submit evidence, as the intervenor's counsel advises that it "retained an appraiser, but after such retainer, a conflict arose with that appraiser relative to the subject property. Accordingly, a new appraiser needed to be retained" and "CBOE now requests additional time to complete the appraisal."

- e. Michael & Mary Ann Sullivan: #20-48781.001-R-1 (Cook) (South Chicago)

Appellant's Motion to Vacate Decision & Withdraw Appeal

This rollover residential appeal of Michael and Mary Ann Sullivan was filed from a favorable PTAB Decision and requested a reduction in assessment from \$104,500 to \$99,000, with a basis of appeal of contention of law.

Timeline

- 01/05/2023 - PTAB accepted the petition, and CCBOR was notified of the appeal.
- 01/27/2023 - CCBOR agreed to stipulate to the appellant's rollover request with an assessment of \$99,000.
- 05/16/2023 - PTAB issued a final administrative decision in agreement with the appellant's requested assessment of \$99,000, as the CCBOR agreed with the appellant's assessment conclusion.

On 10/05/2023, Michael and Mary Ann Sullivan submitted their Motion to Vacate Decision and Withdraw Appeal as follows:

- The appellants timely filed a request to rollover their 2018 decision to the 2019 and 2020 tax year on 09/15/2022 and requested a reduction from \$104,500 to \$99,000 for 2019 and 2020.
- The appellant inadvertently did not account for the 2020 Assessor-initiated "COVID reduction" that was intended to account for the effects of the COVID-19 pandemic.

- The correct 2020 assessment after the Assessor's COVID reduction was \$96,140.
- The appellant's 2020 rollover appeal unintentionally requested an increase to the 2020 assessment to \$99,000.
- CCBOR agreed to the 2020 rollover request on 01/27/2023 but has not yet agreed to the 2019 rollover request as of the date of the motion.
- A 2020 open item tax bill was issued by the Cook County Treasurer's Office on 09/11/2023 and was received by appellants approximately two weeks later.
- The appellants first became aware of the error on the 2020 complaint when the Treasurer issued the open item tax bill.
- Had the appellants been aware of the Assessor's COVID reduction at the time of filing, the appellants would not have appealed the 2020 assessment to PTAB.
- The appellants did not intend to increase the 2020 assessment, as evidenced by the 2020 complaint's request to reduce the valuation from \$104,500.
- The appellants request the PTAB vacate the 2020 decision and dismiss the appeal.
- No party would be prejudiced should PTAB grant this Motion, which is submitted in good faith to correct an unintentional error.

The appellants respectfully move PTAB to vacate the 2020 decision and dismiss the 2020 appeal or otherwise provide leave to the appellants to withdraw the 2020 appeal.

CCBOR does not object to the motion.

- f. Frep 79th & Western LLC: #17-40999.001 thru .009-C-1 (Cook) (Lake)

Appellant's Motion to Amend Decision (Error in Settlement)

This matter involved the timely filed commercial appeal comprising nine parcels by Frep 79th & Western LLC, from a Cook County Board of Review (CCBOR) decision. The appeal sought a change in assessment from \$162,500 to \$65,000. The basis of the appeal was a recent sale.

Timeline

- 12/06/2018 - PTAB accepted the petition, and CCBOR was notified of the appeal.
- 01/18/2023 - The appellant and CCBOR agreed to stipulate an assessment of \$75,000.
- 09/19/2023 - PTAB issued a final administrative decision in agreement with the parties' proposed stipulated agreement.

On 10/17/2023, the appellant submitted its Motion to Amend Settlement under Section 1910.55 of the procedural rules of the PTAB and requested an amendment to the stipulation as follows:

- On 01/18/2023, the appellant and appellee entered a stipulation referencing the above subject property to a revised assessed value of \$75,000.
- The total stipulated assessed value of \$75,000 is correct. However, the appellant erroneously changed PIN 20-31-104-011-000 to have an assessed value of \$13,640, which resulted in an increase to the Board of Review certified assessed value of \$12,758.
- Amending PIN 20-31-104-011-0000 to the correct assessed value requires amending all the subject property PINs as follows:
 - 20-31-104-001-0000: Land \$6,500 + Improvement \$6,500 = \$13,000
 - 20-31-104-002-0000: Land \$4,100 + Improvement \$8,900 = \$13,000
 - 20-31-104-003-0000: Land \$4,100 + Improvement \$5,900 = \$10,000
 - 20-31-104-004-0000: Land \$4,100 + Improvement \$5,900 = \$10,000
 - 20-31-104-005-0000: Land \$5,000 + Improvement \$40 = \$ 5,040
 - 20-31-104-011-0000: Land \$5,000 + Improvement \$250 = \$5,250
 - 20-31-104-012-0000: Land \$5,000 + Improvement \$250 = \$5,250
 - 20-31-104-013-0000: Land \$5,000 + Improvement \$250 = \$5,250
 - 20-31-104-014-0000: Land \$5,000 + Improvement \$250 = \$5,250

Wherefore, Frep 79th & Western LLC, by its attorneys, Liston & Tsantilis, P.C., pursuant to Section 1910.55 of the Rules of the Property Tax Appeal Board requests PTAB adopt the stipulation as stated herein and amend the decision accordingly.

The CCBOR has no objection to the request for an amended decision.

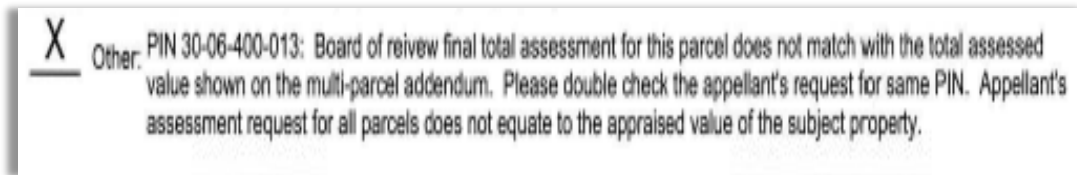
- g. Commonwealth Edison: #22-28110.001 thru .005-I-3 (Cook) (Thornton)

Appellant's Motion to Reinstate

This matter involves the timely filed industrial appeal comprising five parcels by Commonwealth Edison, from a Cook County Board of Review (CCBOR) decision. The appellant seeks a change in assessment from \$572,977 to \$139,523. The basis of the appeal is a recent appraisal.

Timeline

- 06/15/2023 - PTAB issued Commonwealth Edison an incomplete checklist with a request for additional evidence with a due date of 07/15/2023.



- 9/21/2023 - PTAB dismissed the above appeal for failure to provide substantive documentary evidence.

On 10/12/2023, Commonwealth Edison submitted its Motion to Reinstate:

- Upon receipt of the incomplete letter from PTAB showing deficiency of the incorrect BOR totals, the attorney's paralegal logged into the portal, changed the numbers on the screen, and hit "submit."
- According to the appellant, something of a technical nature occurred at that time where the numbers were not amended or saved in the system.
- This was only the second PTAB filing counsel had made using the new portal system. The procedures and processes, especially for revisions and amendments were not fully clear. Also, how changes were to be made and notices sent was also not fully clear.
- At the time, counsel was unsure if they were required to mail in a new form or change the information on the portal itself.
- Counsel states that when the corrected numbers were accepted on the form on the portal, staff believed it was corrected. And since it was a minor deficiency and one where the figures were duplicated on the then attached Board of Review result form, they believed it was rectified.
- Additionally, they did not receive a rejection or notification as to the rejection of the amendment made on 06/17/2023. The appellant argues that they did not have a way of knowing their timely response and correction of the file was not recognized and logged into the system.

Therefore, Commonwealth Edison submits this Motion to Reinstate based on the above referenced facts.

According to IT staff, PTAB's DocuSign system does not show the appellant starting a returned appeal in the e-filing system and the only filing shown for the subject's PIN is the original filing.

- h. Chris Carollo: #18-26298.001-R-1 (Cook) (Lyons)

Motion to Amend Final Administrative Decision

This matter involved the timely filed residential appeal by Chris Carollo, from a Cook County Board of Review (CCBOR) decision seeking a change in assessment from \$33,133 to \$28,070. The basis of the appeal was comparable sales.

Timeline

- 07/03/2019 - PTAB accepted the petition and CCBOR was notified of the appeal.
- 03/15/2022 – Appellant issued a final administrative decision from PTAB, which granted a reduction in the assessment of the property and determined the correct assessed valuation of the property was \$31,300.

On 10/17/2023, the appellant filed its Motion to Amend Final Administrative Action for docket # 18-26298, pursuant to Section 1910.50(d) of the Regulations on Practice and Procedure before the PTAB 86 Ill. Adm. Code § 1910.50(d), and formally requests the decision concerning the above matter be amended to reflect the correct PIN as follows:

- Section 1910.50(d) of the Regulations for Practice and Procedure for Appeals before the PTAB provides that the Board may revise and / or correct a decision upon its own initiative at any time prior to the expiration of the administrative review filing period as provided in Section 16-195 of the Property Tax Code if a mistake in the calculation of an assessment or other clerical error is discovered. In the event the Board shall issue an amended decision.
- On 05/15/2019, the appellant timely submitted its appeal where a reduction in the assessed valuation was sought for property located at 4016 Grand Ave., Western Springs, IL 60558 and PIN 18-06-211-016-0000. The appeal included the PTAB Residential Appeal Form, CCBOR decision dated 01/04/2019 and a lack of uniformity analysis.
- As a result of a scrivener’s error the PIN (18-03-211-016-0000) on the appeal form was wrong and did not match the PIN on the CCBOR decision. The appellant nor PTAB realized the error and the appeal proceeded to review and final adjudication. When the case was reviewed by the ALJ all evidence was for the subject PIN (18-06-211-016-0000), however the final administrative decision was issued for the incorrect PIN listed on the appeal form (18-03-211-

016-0000). Even though the decision was indicative of a reduction in the assessed value for the subject PIN, there was an increase on the assessed value of the erroneous PIN. And due to the final decision seeming correct on its face, no correction was sought by the appellant when the decision was originally issued.

- Consequently, this resulted in an increase of the assessed value of PIN (18-03-211-016-0000) and the Cook County Treasurer's Office notified the taxpayer of said PIN on 09/11/2023, that as a result of a PTAB decision the appellant is liable for additional taxes due in the amount of \$6,791.80.

The appellant respectfully requests that PTAB issue an amended decision to reflect the correct PIN. Issuing an amended decision will correct the record and prohibit the unjust and unfair increase in the tax liability for a third party, the taxpayer of PIN (18-03-211-016-0000).

CCBOR does not object to the motion.

- i. Maria Bauer: #22-33861.001-R-1 (Cook) (Maine)

Appellant's Motion to Reinstate

This matter involved the timely filed residential appeal by Maria Bauer through an attorney from a Cook County Board of Review (CCBOR) decision. However, the appellant did not include a CCBOR decision letter for the subject PIN (09-35-317-009-0000) with her filing. Instead, the appellant attached 200 CCBOR decision letters for unrelated properties. The appellant was seeking a change in assessment from \$58,114 to \$47,765. The basis of the appeal was assessment equity.

Timeline

- 07/11/2023 - Maria Bauer submitted a residential appeal using the e-filing portal.
- 08/10/2023 - PTAB issued an incomplete letter, requested the CCBOR decision for the subject PIN, and gave a due date of 09/09/2023.
- 09/08/2023 - Maria Bauer resubmitted a residential appeal using the e-filing portal, but again, the appellant did not include a CCBOR decision letter for the subject PIN (09-35-317-009-0000). Instead, the appellant filed 201 unrelated CCBOR decision letters.
- 09/28/2023 – The PTAB dismissed the above appeal for failure to provide the final decision for the PIN which is needed to establish jurisdiction.

On 10/26/2023, the appellant submitted its Motion to Reinstate with the correct supporting final decision as follows:

- On 7/11/2023, the appellant submitted its appeal, which included an attachment containing multiple CCBOR decision letters for properties not related to this appeal. On 08/10/2023, PTAB returned the appeal as incomplete, requested a copy of the CCBOR final decision letter, and granted a 30-day extension. The extension was not marked as final.
- On 09/08/2023, in response to the incomplete checklist, the document in the electronic file, which was erroneously saved as the result letter for the subject was again uploaded onto the e-filing portal. On 09/28/2023, PTAB dismissed this appeal.
- The appellant's evidence inadvertently failed to include the Board of Review's final decision letter establishing the Board's jurisdiction over this appeal.
- It is requested that the attached CCBOR final decision letter be accepted, added to the file, and reviewed by the Board before rendering a decision in this matter. This motion was brought within 30 days of the dismissal decision, and granting of the motion does not prejudice the parties.

Therefore, the appellant requests the PTAB issue an order reinstating this appeal and granting the appellant an opportunity to present evidence.

- j. Bruce & Deborah Sandlow: #20-47133.001-R-1 (Cook) (Northfield)

Appellant's Motion to Reinstate and Withdrawal Appeal

This matter involved the timely filed residential appeal by Bruce & Deborah Sandlow from a Cook County Board of Review (CCBOR) decision. The appellant is seeking a change in assessment from \$48,606 to \$36,000. The appellant seeks relief based on assessment equity, comparable sales, and contention of law.

Timeline

02/03/2022 - PTAB accepted and notified CCBOR of the above appeal.

07/24/2023 - Parties involved in the above appeal reached a stipulation.

10/17/2023 - PTAB issued a decision based on the parties reaching an agreement to the correct assessment of the subject property and determined the correct assessed valuation of the property was \$50,000.

On 10/26/2023, the appellant through attorney Marie Mactal, Law Offices of Terrence Kennedy, Jr. submitted its Motion to Reinstate and Withdraw the above appeal. Ingrid Luna, Supervisor at Law Offices of Terrence Kennedy, Jr informed by email of the following:

- Luna came across a decision that was incorrectly entered as stipulation when in fact it should have been withdrawn, because CCBOR issued a reduction that year. When the attorney was making settlement offers with the CCBOR, the attorney accidentally overlooked the assessment reduction of the 2020 tax year and she meant to have the 2020 docket withdrawn.
- As the decision stands it will cause the appellant's assessment to be raised from \$48,6060 to \$50,000, resulting in a tax bill of roughly \$350, being sent to the appellant.

Therefore, the appellant requests the docket be withdrawn, and the decision reversed.
