 - a. Ankur Singhal: #21-33802.001-C-3 (Cook) (Leyden)
Intervenor Veterans Park District's Motion to Vacate Default & Motion for an Extension to File Evidence

This timely commercial appeal by Ankur Singhal from a Cook County Board of Review (CCBOR) Final Decision initially requested a 90-day extension to submit evidence. After extension, the appellant timely submitted its appraisal and recent sale evidence requesting a change in assessment from \$331,250 to \$250,000.

Timeline

- 05/04/2023 - PTAB accepted the appeal as sufficient and notified CCBOR with a due date of 08/02/2023.
- 05/22/2023 - CCBOR certified that copies of the above petitions were mailed to all affected taxing districts.
- 06/02/2023 - Veterans Park District timely submitted its request to intervene.

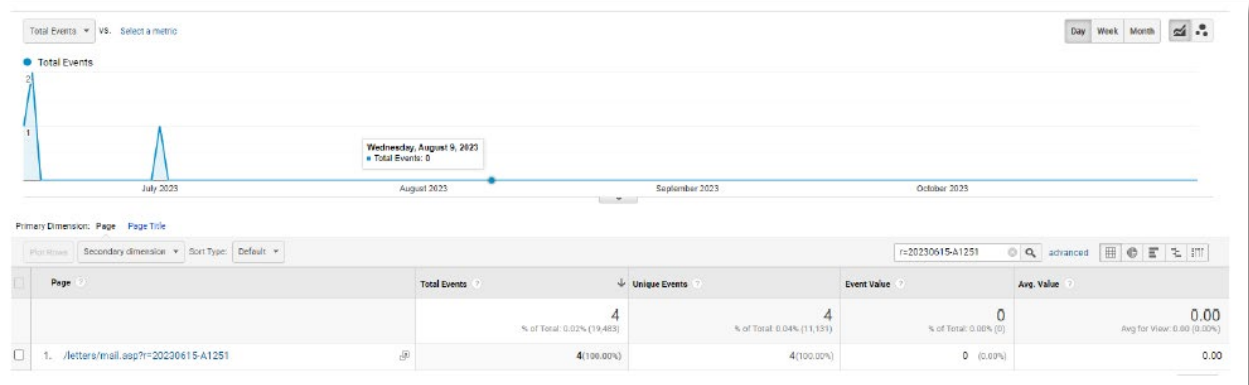
- 06/15/2023 - PTAB added Intervenor, Veterans Park District, as an interested party and issued a due date of 09/13/2023 to submit all evidence or request an additional time extension.
- 10/16/2023 - PTAB defaulted Intervenor, Veterans Park District, for failure to submit evidence or timely seek an extension to do so.

On 10/24/2023, Intervenor Veterans Park District submitted its Motion to Vacate Default and Motion for an Extension to File Evidence:

- The motion provides that on 06/08/2023, PTAB *purportedly* sent an initial evidence extension notice to Veterans Park District granting the standard 90-day evidence extension for the filing of intervenor’s evidence. Evidence in this matter was therefore due 09/13/2023.
- Veterans Park District contends it did not receive PTAB’s 06/08/2023 electronic correspondence.
- Veterans Park District asserts it became aware of the due date for filing evidence on 10/23/2023 after receipt of mailed correspondence from PTAB notifying Veterans Park District of a default finding.
- Intervenor contends that no pre-hearing conferences have been held concerning this appeal, and the granting of this motion would prejudice no party.

Therefore, Veterans Park District requests that PTAB vacate the default judgment entered against the intervenor in this appeal and allow the intervenor to adopt the evidence submitted by Leyden CHSD #212 as its evidence in the instant appeal.

PTAB staff responded to the Veterans Park District Motion by email on 11/01/2023, confirming receipt of the motion from counsel and noting that contrary to the assertion, the electronically delivered letter of 06/08/2023 was successfully delivered with the email having been opened on three separate occasions according to email analytics - twice on 06/16/2023 and again on 07/01/2023. (See below).



b. Forest Park Plaza: #21-48138.001 thru .002-C-3 (Cook) (Proviso)
Village of Forest Park's Motion to Vacate Default & Motion for an Extension to File Evidence

This timely multi-parceled (2) commercial appeal by Forest Park Plaza from a Cook County Board of Review (CCBOR) Final Decision sought a change in assessment from \$3,355,790 to \$3,025,000, with a basis of recent appraisal.

Timeline

- 04/06/2023 - PTAB accepted the appeal as sufficient and notified CCBOR with a due date of 07/05/2023.
- 05/02/2023 - CCBOR certified that copies of the above petitions were mailed to all affected taxing districts.
- 06/02/2023 - The Village of Forest Park submitted its request to intervene in a timely manner.
- 06/15/2023 - PTAB added Intervenor, Village of Forest Park, as an interested party and issued a due date of 09/13/2023 to submit all evidence or request an extension.
- 10/17/2023 - PTAB defaulted Intervenor, Village of Forest Park, for failure to submit evidence or timely seek an extension to do so.

On 10/30/2023, Intervenor Village of Forest Park submitted its Motion to Vacate Default and Motion for an Extension to File Evidence:

- The motion provides that on 06/08/2023, PTAB *purportedly* sent an initial evidence extension notice to the Village of Forest Park, granting the standard 90-day evidence extension for filing the intervenor's evidence. Evidence in this matter was therefore due 09/13/2023.
- Village of Forest Park contends it did not receive PTAB's 06/08/2023 electronic correspondence.
- Village of Forest Park asserts it became aware of the due date for filing evidence on 10/23/2023 after receipt of mailed correspondence from PTAB notifying Village of Forest Park of a default finding.
- The subject property was also the subject of an appeal in the 2020 tax year, docket # 20-43187. In 20-43187, the Village of Forest Park submitted an appraisal report of the subject property with a valuation date of 01/01/2020, and it was the intention of the Village of Forest Park to file this appraisal as its evidence in this instant appeal as well.
- Intervenor contends that no pre-hearing conferences have been held with respect to this appeal, and no party would be prejudiced by the granting of this motion.

The Village of Forest Park requests that PTAB vacate the default judgment entered against the intervenor in this appeal and that the intervenor be granted leave to file the enclosed appraisal report.

PTAB's IT staff confirmed the electronically delivered letter of 06/08/2023 was successfully delivered, with the email having been opened on two separate occasions according to email analytics on 06/18/2023 and 06/19/2023.

- c. Tiffany Batko: #22-39046.001-R-1 (Cook) (Palatine)

Appellant's Motion to Amend Appeal

This timely filed residential appeal of Tiffany Batko from a Cook County Board of Review (CCBOR) Final Decision seeks a change in assessment from \$153,335 to \$113,695, and the basis of the appeal is assessment equity. On 11/09/2023, PTAB deemed the appeal sufficient and notified CCBOR. The CCBOR was given a deadline of 01/31/2024 to file its evidence or seek an extension. No CCBOR evidence has been filed as of the preparation of this agenda.

On 11/09/2023, the appellant submitted its Motion to Amend the appellant's assessment claim within section II, 2c, 2 as follows:

The appellant's reasoning for the requested amendment:

- On 10/19/2023, the appellant received the tax year 2023 Corrected Land Assessment Notice from the Cook County Assessor's Office (CCAO), which is within the Palatine Township triennial cycle (2022, 2023, & 2024). This tax year 2022 appeal is pending before PTAB.
- Reportedly, in October 2023, CCAO Corrected Land Notices lowered the appellant's unusable marshland detention easement land value to \$.50 per SF and made all nine contiguous neighbors' land values uniform in value.

Therefore, the appellant requests that PTAB amend the appellant's requested land AV to \$37,147 and building AV to \$62,460 for a total AV of \$99,607.

- d. Tseghai Berhe: #22-44180.001-R-1 (Cook) (Lakeview)

Appellant's Motion to Amend Appeal

This timely filed residential appeal of Tseghai Berhe from a Cook County Board of Review (CCBOR) Final Decision seeks a change in assessment from \$218,000 to \$206,294, and the basis for the petition is assessment equity.

When the appeal was filed on 08/07/2023, the appellant made no request for an extension, and counsel checked the box certifying that "this completed form along with enclosed evidence completes my appeal filing."

On 11/02/2023, PTAB deemed the appeal sufficient to notify CCBOR, and the PTAB issued a deadline for submission of evidence or an extension for 01/31/2024.

Motion to Amend:

Postmarked on 11/02/2023, the appellant submitted its Motion to Amend the appeal under Section II, 2c, 2 and the basis for appeal under Section II, 2d to recent appraisal and included an appraisal for the subject property with an opinion of value as of 01/01/2022:

- Counsel contends the appraisal was received on 08/08/2023, a day after the original appeal had been filed.
- The appellant respectfully requests, in accordance with this appraisal, a correction of the basis for appeal under Section II, 2d to the recent appraisal.
- The appellant respectfully requests, in accord with the appraisal, an assessment of land AV of \$61,875, building AV of \$100,625, and total AV of \$162,500.
- The appellant's motion was not served on the CCBOR as required by the procedural rules (1910.64(c)).

Therefore, the appellant requests that PTAB amend the appellant's assessment request to a total AV of \$162,500 and change the basis to a recent appraisal.

e. Craig Horwitz: #22-53009.001-R-1 (Cook) (Wheeling)

Motion to Reinstate Untimely Filed Appeal

This *pro se* residential appeal by Craig Horwitz from a Cook County Board of Review (CCBOR) Final Decision was hand-delivered on 09/07/2023 seeking a change in assessment from \$32,000 to \$25,000, with bases of comparable sales and assessment equity.

On 11/02/2023, the Property Tax Appeal Board issued a letter to the appellant dismissing this appeal as being untimely filed.

The appellant in the motion acknowledged “I have made a ‘day count error of 1 day” since the CCBOR transmission was dated 08/07/2023 and the appellant hand-delivered the appeal to the Des Plaines office on 09/07/23, noting this was at day 31. “I miscounted, BUT, really think this was an ‘honest mistake”” noting further that some months have 31 days, some months have 30 days and then February has 28 days.

Based on the preceding, the appellant seeks to reinstate this appeal based on the appellant’s honest mistake.

For tax year 2022, the published data for Wheeling Township is:

Wheeling* | **7/24/2023** | **7/26/2023** | **7/28/2023** | **8/7/2023**

The final transmission date for Wheeling was 08/07/2023. As August has 31 days, the final filing date for 2022 tax year appeals from Wheeling Township was 09/06/2023; this appeal was untimely filed by hand-delivery one day late on 09/07/2023.

The jurisdiction given to the Property Tax Appeal Board under the provisions of the Property Tax Code (35 ILCS 200/16-160) is clearly established: In counties with 3,000,000 or more inhabitants, . . . , any taxpayer dissatisfied with the decision of a board of review or board of appeals as such decision pertains to the assessment of his or her property for taxation purposes, . . . , may, . . . (ii) in assessment year 1999 and thereafter in counties with 3,000,000 or more inhabitants **within 30 days** after the date . . . that the board of review transmits to the county assessor pursuant to Section 16-125 its final action on the township in which the property is located, whichever is later, appeal the decision to the Property Tax Appeal Board for review. [Emphasis added.]

- f. Aberdeen of River West (Cook) (West)
Matthew Dunne (Cook) (South)

Appellant’s [oral] Motion to Accept Appeals

These appeals do not have case numbers because they were incorrectly filed (mail v. e-filing) and are now untimely. Therefore, staff has not docketed the appeals.

On 11/14/2023, Attorney Patrick Turner with Tabangay & Turner, LLC mailed three residential “rollover” appeal petitions to PTAB by mail in violation of PTAB’s e-filing requirement for attorneys.

Aberdeen of River West

The first two petitions were for tax years 2019 and 2020 for appellant Aberdeen of River West, contending the subject consists of owner-occupied residential real estate. There are eight parcels on appeal. The appeals were submitted based on a favorable PTAB decision dated 10/17/2023. These proposed appeal petitions request a change in total assessment from \$367,336 to \$330,224 with a basis of contention of law for tax years 2019 and 2020.

In a brief, accompanying the Aberdeen of River West appeals, counsel reports that the subject is an eight-unit condominium building. Other than the petition, there is no affirmative statement that each condominium unit is an owner-occupied dwelling.

Matthew Dunne

The third petition was for tax year 2020 for appellant Matthew Dunne and contends the subject is an owner-occupied residence. The appeal was submitted based upon a favorable PTAB decision dated 10/17/2023, and a change in assessment was requested from \$72,204 to \$56,541 with a basis of contention of law. Other than the petition, there is no affirmative statement the subject property is owner-occupied.

On 11/17/2023 and 11/28/2028, respectively, PTAB notified the appellants' attorney that as of July 1, 2023, an appellant represented by an attorney must file their appeal through PTAB's e-filing portal and that these three appeals that were filed by US mail did not comply with PTAB's rule. 86 Ill. Admin. Code § 1910.30. Counsel was further advised that he could appear before the Board and request that the Board accept the appeals which were mailed.

- g. Jeffrey Patton: #22-02713.001-C-1 (DeKalb)
- Jeffrey Patton: #22-02714.001-C-1 (DeKalb)
- Jeffrey Patton: #22-02715.001-C-1 (DeKalb)

Motion to Withdraw Appeals

This matter involves the timely *pro se* commercial appeals of Jeffrey Patton from DeKalb County Board of Review (DCBOR) Final Decision letters, where the appellant requested reductions in assessment with a basis of assessment equity.

Timeline

- 04/20/2023 - PTAB accepted the three appeals and notified DCBOR of the above appeals.

- 06/07/2023 – DCBOR submitted its evidence for the three appeals.
- 11/22/2023, the appellant submitted requests to withdraw the three appeals via PTAB's e-filing portal, contending in part that the appellant had mailed withdrawal requests on 09/09/2023 to PTAB's Springfield office. The PTAB does not have a record of such submissions.
- On 11/27/2023, PTAB notified DCBOR of the subject's e-filed withdrawal requests.
- Sometime after this appeal was filed and

On 11/27/2023, DCBOR objected to the appellant's withdrawal requests as follows:

- Upon the appellant filing these cases, the DCBOR duly filed its notes on appeal and has expended considerable time and effort compiling evidence for these dockets.
- DCBOR contends the cases should be allowed to move forward as presented and not force DCBOR to start anew in the Circuit Courts.
- DCBOR avers the present attempts to change the venue of these cases after evidence submission, which is undeniably an attempt at forum shopping and improper.
- According to the DCBOR, the appellant is not being forthright as he has neglected to inform that after evidence was submitted, he filed his case in the circuit court, where there is a motion to dismiss pending due to this activity. That motion is on file and expected to result in his case being dismissed by the court.

Therefore, the DCBOR respectfully requests that PTAB deny the appellant's withdrawal requests for the above dockets.

On 11/27/2023, by email, the appellant countered by asserting:

- The appellant initially attempted to dismiss these appeals on 09/09/2023 before filing his tax objection suit. The request was sent via US mail and done in the same manner as the appeals. However, the request was either not received or not seen.
- The appellant was unaware of this until he received a Motion to Dismiss from DeKalb County. The appellant then contacted PTAB to ask about the status of the withdrawal and discovered that it had not been completed.
- The appellant avers DeKalb County's request to block the withdrawal is solely for the sake of trying to get the appellant's case dismissed from the circuit court.

- The appellant contends that if his request had been received prior to filing the suit, they would have certainly granted it.

The appellant is asking PTAB to accept his request to withdraw the above appeals so the appellant can seek relief through the circuit court.

The Property Tax Code provides in 35 ILCS 200/16-160, in pertinent part, that “If a petition is filed by a taxpayer, **the taxpayer is precluded from filing objections based upon valuation**, as may otherwise be permitted by Sections 21-175 and 23-5. However, any taxpayer not satisfied with the decision of the board of review or board of appeals as such decision pertains to the assessment of his or her property need not appeal the decision to the Property Tax Appeal Board before seeking relief in the courts.” [Emphasis added.]

The appellant contends that 09/09/2023 was a date before the circuit court tax objection proceeding was filed.
