- a. Highland Park CVS, LLC: #21-52891.001-C-2 (Cook) (Proviso)

Intervenor Village of Brookfield's Motion to Vacate Default & Motion for an Extension to File Evidence

This timely commercial appeal by Highland Park CVS, LLC from a Cook County Board of Review (CCBOR) Final Decision sought a change in assessment from \$442,239 to \$337,500, with a basis of recent appraisal.

Timeline

- 04/06/2023 - PTAB accepted the appeal as sufficient and notified CCBOR with a due date of 07/05/2023.
- 05/02/2023 - CCBOR certified that copies of the above petitions were mailed to all affected taxing districts.
- 06/02/2023 – Village of Brookfield timely submitted its request to intervene.

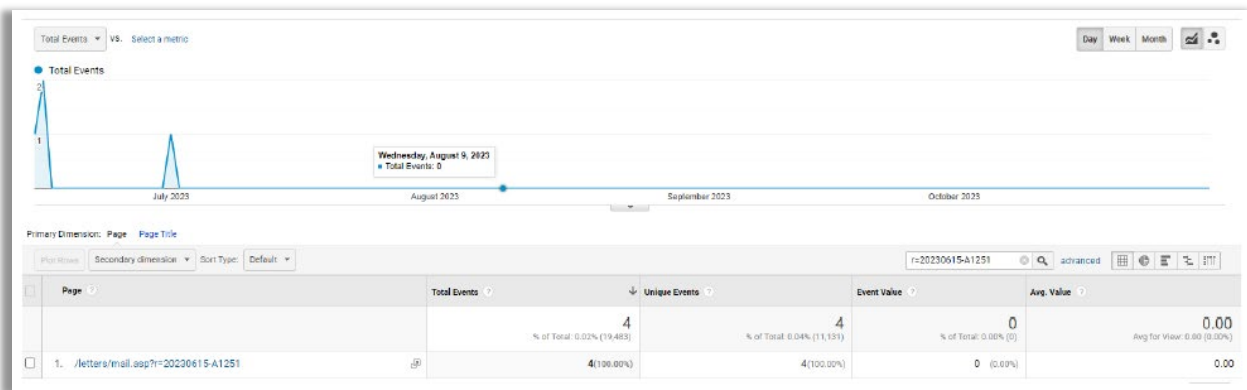
- 06/15/2023 - PTAB added Intervenor, Village of Brookfield, as an interested party and issued a due date of 09/13/2023 to submit all evidence or request an additional extension.
- 10/05/2023 - PTAB defaulted Intervenor, Village of Brookfield, for failure to submit evidence or timely seek an extension to do so.

On 10/17/2023, Intervenor Village of Brookfield submitted its Motion to Vacate Default and Motion for an Extension to File Evidence:

- The motion provides that on 06/15/2023, PTAB *purportedly* sent an initial evidence extension notice to the Village of Brookfield granting the standard 90-day evidence extension for the filing of intervenor's evidence. The intervenor asserts that their evidence in this matter was due 10/04/2023.
- Village of Brookfield contends it did not receive PTAB's 06/15/2023 electronic correspondence.
- Village of Brookfield asserts it became aware of the due date for filing evidence on 10/10/2023 after receipt of mailed correspondence from PTAB notifying Village of Brookfield of a default finding.
- Intervenor contends that no pre-hearing conferences have been held with respect to this appeal, and the granting of this motion would prejudice no party.

Therefore, the Village of Brookfield requests that PTAB vacate the default judgment entered against the intervenor in this appeal and grant an additional 30-day extension to file evidence in this appeal.

PTAB IT staff noted, contrary to the assertion, the electronically delivered letter of 06/15/2023 was successfully delivered with the email having been opened on three separate occasions (twice on 06/16/2023 and again on 07/01/2023) according to email analytics:



- b. Stanislaw Drazba: #22-20432.001-R-1 (Cook) (Norwood Park)

Appellant's Motion to Reinstate

This is a timely filed *pro se* residential appeal by Stanislaw Drazba from a Cook County Board of Review (CCBOR) Final Decision seeking a change in [total] assessment from \$43,000 to \$34,400, with bases of comparable sales and assessment equity.

Timeline

- On 04/20/2023, PTAB sent the appellant an incomplete letter requesting additional information on the land, plus an improvement assessment for both the assessment and the appellant's claim, with a due date of 05/20/2023.

- 05/09/2023, the appellant provided some documents but failed to provide the requested information. On 07/20/2023, PTAB sent the appellant a second incomplete letter with a request for specific information, with a due date of 08/19/2023.
- On 08/14/2023, the appellant provided additional evidence but failed to provide the requested information.
- On 09/21/2023, PTAB sent the appellant a **third** incomplete letter with a request for specific information with a due date of 10/21/2023 where the incomplete checklist stated, in pertinent part, **"This is your last opportunity to fully complete the appeal form or your appeal will be dismissed."** The incomplete letter also instructed the appellant to file the requested information in the Springfield office.

- 10/21/2023, the appellant did not file any evidence or information responsive to the incomplete checklist.
- 11/03/2023 [*corrected date stamp*], the appellant delivered the requested assessment and claim information by hand.
- 11/16/2023, PTAB defaulted the appellant for failure to provide substantive documentary evidence or legal argument sufficient to challenge the correctness of the assessment of the subject property or timely seek an extension to do so.

On 12/01/2023, the appellant submitted his Motion to Reinstate, asserting:

- On 11/01/2023, the appellant submitted a response to the notice of incomplete in-person at the Des Plaines Office to complete the missing information and avers “to the satisfaction of that office.”

Therefore, the appellant requests PTAB reopen his case on the basis that evidence was submitted in completion per the Suburban North Regional Office.

The appellant has not provided an explanation or attempted to articulate good cause for why the data was not submitted by the deadline of 10/21/2023.

- c. Kenneth & Audrey Karrels: #22-04273.001-R-1 (Boone)

Appellant’s Motion to Reconsider

This timely filed residential appeal of Kenneth & Audrey Karrels from a favorable decision of PTAB sought a change in assessment from \$89,363 to \$82,637, with a basis of contention of law.

Timeline

- On 08/10/2023, PTAB issued the appellants an incomplete letter and requested specific information with a due date of 09/09/2023.
- On 11/09/2023, PTAB defaulted the appellants for failure to provide the requested information or timely seek an extension of time to do so.

On 12/04/2023, the appellants submitted their Motion to Reconsider as follows:

- The appellants submitted this appeal as a request to rollover the 2021 assessment to the 2022 assessment year, and the initial filing indicated the appeal was made from a favorable PTAB decision dated 07/18/2023, with a basis of contention of law. The 07/18/2023 decision was attached to the filing; however, the filing did not contain a legal brief setting forth the contention of law.
- PTAB sent the appellants’ counsel correspondence advising that the petition was incomplete. Appellants’ counsel was in the process of filing complaints with the Winnebago County Supervisor of Assessments office for 2023, which were due 09/09/2023. As a result, the appellant's counsel did not file the necessary information.

- On or about 11/27/2023, appellants' counsel sent correspondence to PTAB setting forth the legal basis for the rollover request, being a rollover request for the 2021 assessment to be carried forward to the subsequent tax year (2022) per Section 16-185 of the Property Tax Code, subject to equalization and that the property is an owner-occupied residence, and this year is in the same general assessment period.
- The appellant's failure to file the necessary information was an oversight and mistake by their counsel. In the interest of justice and equity, appellants should be allowed to have the 2021 value carried forward as provided by the Property Tax Code.

Therefore, the appellants are requesting that the PTAB reconsider the dismissal of this matter and reinstate this matter so that the interests of justice prevail.

The Board's website information tab has long included specific instructions for pursuing a "rollover" appeal from a favorable decision of the Property Tax Appeal Board, which, in pertinent part, provides:

Submit copy(s) of Property Tax Appeal Board's decision showing a reduction in the assessment was granted as instructed on the appeal form.

- Submit copy(s) of a cover letter stating in part:
"I would like my [YEAR #] assessment to be carried forward to the subsequent tax year [YEAR#] per Section 16-185 of the Property Tax Code, subject only to equalization. The property is an owner occupied residence and this tax year is in the same general assessment period."

A "rollover" appeal MUST be filed within 30 days from the date the clerk of the Property Tax Appeal Board signed your decision.

- d. Jordan Dods & Kara Werner: #22-38693.001-R-1 (Cook) (Lakeview)

Appellant's Motion to Reinstate Appeal

This timely filed residential appeal of Jordan Dods & Kara Werner from a Cook County Board of Review final decision seeks a change in assessment from \$79,456 to \$69,900, with a basis of recent sale and supporting documentation of a recorded Warranty Deed (Ex. B), a printout from the Recorder's Office concerning the Warranty Deed (Ex. C),

and an internet printout from Coldwell Banker offering the subject property for sale for \$699,000 with an original asking price of \$749,000 (Ex. D).

The Residential Appeal petition in Sec. IV – Recent Sale provides, in pertinent part:

SUBMIT DOCUMENTATION of the actual sales price (*submit copies of all that are available*) including a sales contract, Real Estate Transfer Declaration, listing data sheet, listing history, and Settlement Statement.

Timeline

- On 08/31/2023, PTAB issued an incomplete letter to the appellants requesting a copy of the settlement statement or PTAX-203 Real Estate Transfer Declaration with a due date of 09/30/2023.
- On 11/09/2023, PTAB defaulted the appellants for failure to provide the requested information or timely seek an extension of time to do so.

On 12/11/2023, the appellants submitted their Motion to Reinstate as follows:

- At the time of filing, the appellants' counsel submitted all that had been made available:
 - a recorded copy of the Warranty Deed (Cook County Document No. 2025207342 reflects Illinois Tax Stamp paid of \$699.00);
 - proof of Recording in the Cook County Recorder's Office, and proof of listing on MLS (No. 10711498); and,
 - Section IV – Recent Sales Data on page 2 of the appeal form was also completed.

Therefore, the appellants believe they complied with Section 1910.65 (c)(3).

- After receiving PTAB's 08/31/2023 letter, counsel requested a copy of the Settlement Statement from the owners, but the appellants could not locate a copy of the document until about 11/30/2023. A copy of the Settlement Statement has been submitted with this motion.
- The appellants were not attempting to delay, protract, or hinder prosecution of this case, nor prejudice the Board of Review in any way. Counsel does not believe the Board of Review is prejudiced in its ability to defend the appeal due to this slight delay. Additionally, the appellants have a solid, if not irrefutable, case for overvaluation, which is further buttressed by this additional documentation.

- The previous appeal (2021) concerning the same property based on the same data has already been received and docketed. Tax year 2022 is the second year of the triennial reassessment period.

Therefore, in the dual interests of fairness and equity to the taxpayers, counsel requests this appeal be reinstated so that the appellants can pursue this request for relief, which is more than amply supported by the evidence submitted.

- e. Marharishi Hospitality Inc: #20-30905.001-C-1 (Cook) (Maine)

Appellant's Motion to Vacate Decision & Reinstate Corrected Stipulation

This timely filed commercial appeal of Marharishi Hospitality, Inc. from a Cook County Board of Review (CCBOR) final decision sought a change in assessment from \$391,898 to \$347,380, with bases of contention of law and recent appraisal.

Timeline

- On 07/01/2021, PTAB accepted the above appeal and notified the CCBOR.
- On 11/21/2023, PTAB found that the agreement of the parties was proper, and the correct assessed valuation of the property was issued for \$548,000.

On 12/20/2023, the appellant submitted its Motion to Vacate the 2020 Decision and Reinstate Corrected Stipulation as follows:

- The above reference docket was one of many cases set for hearing over the past few months. As part of the settlement process, the appellant's counsel and the CCBOR successfully settled PTAB dockets that were scheduled for hearing. In resolving these matters, they participated in a mass stipulation exercise. To increase efficiency and decrease the docket backlog, many dockets within the same triennial were settled along with related matters set for hearing. Counsel inadvertently submitted a stipulation for the subject that was separate from the mass settlement agreement with the BOR.
- The 2020 decision, dated 11/21/2023, would cause substantial prejudice to the appellant as the decision for that year was not intended by the involved parties and *increases* the certified assessment. The increase was not requested by any party. The parties have since discussed the 2020 appeal and reached an agreement to settle. The appellant submits this Motion to Vacate the decision dated 11/21/2023 and requests that the Board enter an order to reinstate the

appeal and issue a decision based upon the corrected, fully executed stipulation of \$370,000.

Wherefore, the appellant prays PTAB to vacate the appellant's 2020 decision and reinstate the appeal with the issuance of a decision based upon the corrected stipulation agreement of the parties.

- f. Marharishi Hospitality Inc: #21-33244.001-C-2 (Cook) (Maine)

Appellant's Motion to Vacate Decision & Reinstate Corrected Stipulation

This timely filed commercial appeal of Marharishi Hospitality, Inc. from a Cook County Board of Review (CCBOR) final decision sought a change in assessment from \$483,000 to \$292,500, with a basis of recent appraisal.

Timeline

- On 12/01/2023, PTAB accepted the above appeal and notified the CCBOR.
- On 11/21/2023, PTAB found that the agreement of the parties was proper, and by decision, the correct assessed valuation of the property was \$548,000.
- However, PTAB failed to recognize that the intervenor did not execute the stipulation. Therefore, this decision that was issued should be deemed void.

On 12/20/2023, the appellant submitted its Motion to Vacate 2021 Decision and Reinstate [*proposed*] Corrected Stipulation as follows:

- The above reference document was one of many cases set for hearing over the past few months. As part of the settlement process, the appellant's counsel and the CCBOR successfully settled PTAB dockets that were scheduled for hearing. In resolving these matters, they participated in a mass stipulation exercise. To increase efficiency and decrease the docket backlog, many dockets within the same triennial were settled along with related matters set for hearing. Counsel inadvertently submitted a stipulation for the subject that was not part of the mass settlement agreement with the BOR. (Docket 19-28492 had been set for hearing on 07/24/2023 and successfully settled).
- The 2021 decision, dated 11/21/2023, would cause substantial prejudice to the appellant as the decision for that year was not intended by the involved parties and *increases* the certified assessment to \$548,000. The increase was not requested by any party. The parties [appellant and CCBOR] have since

discussed the 2021 appeal and reached an agreement to settle [pending authorization by the two represented intervenors]. The appellant submits this Motion to Vacate the decision dated 11/21/2023 and requests that the Board enter an order to reinstate the appeal.

Wherefore, the appellant prays PTAB to vacate the appellant's 2021 stipulation and reinstate the appeal pending either a new stipulation or a decision on the merits given the involvement of intervenors, which the appellant failed to serve previously.

- g. Colette & Rodon Hornoff: #22-42025.001 thru .003-I-1 (Cook) (West Chicago)

Appellant's Motion for an Extension

This industrial appeal of three parcels for Colette & Rodon Hornoff was filed on 07/31/2023 from a Cook County Board of Review (CCBOR) final decision with a basis of recent appraisal. Neither the CCBOR assessment nor the appellant's assessment claims were provided as required. The appellant requested a 90-day extension to submit evidence.

Although done in error, on 09/21/2023, PTAB granted the appellant an extension, with a due date of 12/20/2023, without returning the appeal as incomplete under proper procedures.

On 12/20/2023, the appellant, through counsel, requested a second 90-day extension to submit evidence and averred the file is "still in the process of being transferred from my previous law firm to my current establishment." Once the file is received, counsel will submit the requisite evidence to complete the filing. Therefore, the appellant requests an additional 90-day extension.

Thus, the assessments of the respective parcels and the appellant's claims for each parcel have yet to be provided by counsel in the Addendum. Furthermore, the basis of the appeal was a recent appraisal, which has not been presented to the PTAB. Finally, the appeal was filed by counsel using the same firm name and address contained in the latest extension request such that there is no indication on the record that the attorney has changed law firm practices.

- h. 1440 W North Ave., LLC: #22-48384.001 thru .010-C-3 (Cook) (Proviso)

Appellant's Motion to Reinstate

This timely filed commercial appeal of ten parcels for 1440 W North Ave., LLC from a Cook County Board of Review (CCBOR) final decision has a basis of recent appraisal. The appellant requested a change in assessment from \$892,762 to \$506,250.

On 10/12/2023, PTAB sent the appellant an incomplete letter requesting the correct Board of Review assessment placed on the respective parcels, with a due date of 11/11/2023 [one of the parcels set forth a total assessment that did not match the final decision].

On 12/14/2023, PTAB dismissed the above appeal for failure to respond to the incomplete checklist and thus correct the erroneous assessment information.

On 12/18/2023, the appellant submitted its Motion to Reinstate and corrected evidence and correspondence as follows:

On 08/17/2023, the appellant, through its attorney, filed an appeal complete with evidence supporting the changes in the assessments with the PTAB. Evidence included an appraisal, vacancy affidavit, and a supplemental memorandum explaining the reasoning for the requested relief. The appeal was submitted online through the PTAB portal.

The appellant received a letter from PTAB on or about 10/12/2023 requesting a correction to the complaint. On or about that date, counsel had discussions with the appellant, requesting the attorney to cease working on their appeals. As such, no further action was taken to correct the minor inconsistencies between the BOR decision and assessment amounts listed in the complaint. The appellant subsequently clarified that counsel was to cease working on the 2023 matter and matters going forward but wished counsel to continue with the tax year 2021 and 2022 PTAB appeals.

Therefore, the appellant requests the above-referenced appeal to be reinstated. The entire appeal submission, including all corrections, correspondence, and receipts, is included for review and consideration. Furthermore, counsel argues substantive, documentary evidence or legal argument sufficient to challenge the correctness of the assessment of the property had been submitted. Alternatively, the appellant requests that the appeal be withdrawn instead of a dismissal being rendered.
