 - a. Gems Americas: #21-49845.001-C-3 (Cook) (South)

Intervenor's Request for an Extension of Deadline to File Appraisal and Rebuttal Evidence

This timely multi-parceled commercial appeal by Gems Americas from a Cook County Board of Review (CCBOR) Notice of Final Decision seeks a change in assessment from \$4,100,499 to \$3,080,000, with a basis of recent appraisal.

Timeline

- 04/06/2023 - PTAB accepted the appeal as sufficient and notified CCBOR with a due date of 07/05/2023.
- 05/02/2023 - CCBOR certified that it mailed copies of the petition to all taxing districts.
- 06/29/2023 - the City of Chicago submitted its request to intervene in the above matters, and on 07/20/2023, PTAB named Chicago as an interested party in the appeal with a due date of 10/18/2023.

- 10/17/2023— Chicago requested a 90-day extension to submit appraisal evidence. On 11/02/2023, PTAB granted a final 90-day extension with a due date of 01/31/2024.

On 01/31/2024, the intervenor submitted its motion for an additional extension of 30 days to submit its appraisal and rebuttal evidence as follows:

- The parties have agreed to a settlement agreement but have yet to obtain all necessary signatures for the stipulations.
- If the PTAB rejects the settlement agreement, the intervenor would like the opportunity to file both appraisal evidence and rebuttal evidence.

Therefore, the intervenor requests an additional 30-day extension.

- b. Fausto Natali: #20-46760.001 thru .002-R-1 (Cook) (Northfield)

Appellant's Motion to Reinstate

This timely multi-parceled non-owner-occupied residential appeal by *pro se* appellant Fausto Natali from a Cook County Board of Review (CCBOR) Notice of Final Decision seeks a change in assessment from \$55,628 to \$48,918, with a basis of assessment equity. On 10/14/2021, PTAB found the appellant's petition incomplete and provided a due date of 11/13/2021 to submit the requested information. On 03/17/2022, PTAB dismissed the above appeal as the appellant failed to provide the substantive documentary evidence sufficient to challenge the correctness of the appeal by failing to respond to the incomplete checklist and provide the required addendum for this multi-parcelled property.

On 01/22/2024, the appellant submitted this Motion to Reinstate as follows:

- The appellant averred he learned earlier this month that the above appeal was dismissed for incomplete filing.
- The appellant contended that he never received the incomplete checklist and believes it may have been delivered to another address and not forwarded to him. The appellant informed the PTAB that this had occurred previously with other mail and that the appellant had complained about the Post Office.

- Given the time, effort, importance, and potential impact of the appeal, the appellant would have replied with the requested minor correction had the incomplete appeal checklist been received. The appellant claimed he would not have forgotten or ignored it, especially given the minor correction.
- The appellant asserted that not knowing this case had been dismissed, he reached a settlement with the Board of Review before the hearing. The appellant stated he was sent a stipulation for signature from the CCBOR, which was then forwarded to PTAB, reflected in \$51,000, and is in the docket file. The appellant submitted two copies of the purported stipulation, neither containing any CCBOR signatures.
- The appellant has submitted the requested addendum to this motion.

The appellant requests that PTAB grant its Motion to Reinstate.

Appellant's Motion to Reinstate

These above untimely residential appeals by *pro se* appellant Fausto Natali were e-filed on 11/17/2023 from the Cook County Board of Review (CCBOR) Notice of Final Decision, which had a transmittal date of 08/24/2023. On 12/14/2023, PTAB found the above appeals were filed 85 days late and, therefore, not timely. The PTAB dismissed the appeals as PTAB lacks jurisdiction.

On the postmarked date of 02/02/2024, the appellant submitted a Motion to Reinstate the above appeals as follows:

- The appellant claims he was delayed in appealing due to a protracted recovery from a Long COVID-related illness.
- The appellant contends he still needs to receive the final decision on his complaints from the CCBOR and had believed this was a normal delay. On 11/17/2023, the appellant checked with the CCBOR to determine why he had not yet received the decisions and was informed that they had been mailed on 08/21/2023. The appellant told the CCBOR he had yet to receive the decisions and was informed they could do nothing.
- This is not a matter of overlooking or ignoring the CCBOR decision letters or chronology for the filing dates with PTAB.
- The appellant was waiting for the CCBOR Notice of Final Decision letters, which never came in the mail. Receipt of the decisions would have been the trigger prompting the appellant to file with PTAB immediately. Lacking the decisions caused the resulting delay.
- When the appellant realized the timing issue on 11/17/2023, he asked his son to complete the appeals online.
- The appellant speculates that not receiving the decision letters was due to the misdelivery of the mailings. Numerous instances of mail have been addressed to others in the area but delivered to the appellant's mailbox. The appellant understands other neighbors in **Park Ridge** have occasionally had similar issues with misdirected mail, along with the appellant, and they have complained to the Park Ridge Post Office.

The appellant contends that, in view of the time, effort, importance, and potential impact of his appeals, he would have certainly filed them in a timely manner and would

not have forgotten the filing deadline. Therefore, the appellant requests that PTAB grant his Motion to Reinstate the above appeals.

- d. 2140 North Racine Condominium Association: #19-51712.001 thru .003-R-1 (Cook) (North)

Appellant's Motion to Vacate Decision and Correct Assessment

This timely multi-parceled residential appeal by 2140 North Racine Condominium Association from a Cook County Board of Review (CCBOR) Notice of Final Decision sought a change in assessment from \$190,537 to \$109,027, with a basis of assessment equity and comparable sales.

Timeline

- 01/07/2021 - PTAB accepted the appeal as sufficient and notified CCBOR with a due date of 04/07/2021.
- 02/16/2024 - PTAB found that no change in the property assessment was warranted.

On 02/14/2024, the appellant, through counsel, submitted its Motion to Vacate the Decision dated 02/20/2024 and issue a corrected decision. The appellant argues :

- The appellant's 2018 case involved the same owner-occupied property as the 2019 case. Revised assessments were granted for the 2018 case because of a settlement negotiated between the appellant and CCBOR.
- The evidence submitted in the 2019 appeal was identical to the documentation submitted supporting the 2018 appeal. On 10/20/2020, PTAB issued a decision reducing the 2018 assessment of the subject property.
- Under Section 16-185 of the Property Tax Code (35 ILCS 200/16-185), an assessment reduction granted by the PTAB shall remain in effect for the duration of the assessment period, which in this case was 2018 through 2020. The statute states in pertinent part:
 - If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel on which a residence occupied by the owner is situated, such reduced assessment, subject to equalization, shall remain in effect for the remainder of the general assessment period...
- The subject property was reassessed in 2018 and again in 2021. The units, at least parcels -1001 and -1003, are owner-occupied residential properties, as verified by the Cook County Treasurer's website.

- The appellant did not file a request for this rollover treatment, which was not included in the 2019 appeal because a decision concerning the 2018 case had not been issued when the appeal was filed. However, before the 2019 decision was issued, the 2018 decision was of record and available for review in the PTAB docketing system. This decision existed to inform subsequent year determinations concerning this class 2-99 property.
- Given the decision was of record, and considering the statutory directive, the appellant requests PTAB employ its authority in equity and correct the 2019 decision to bring the assessment in line with the PTAB's 2018 decision. Decisions by the PTAB are to be "based upon equity and the weight of evidence." It is with this authority that the 2019 decision should be corrected to achieve the result mandated by statute for the appellant.

e. Leo & Soula Souflakis: #20-41027.001-R-1 (Cook) (Maine)

Appellant's Motion to Vacate Decision and Withdraw Appeal

This timely residential appeal by Leo & Soula Souflakis from a Cook County Board of Review (CCBOR) Notice of Final Decision sought a change in assessment from \$22,920 to \$20,594, with a basis of assessment equity.

Timeline

- 10/07/2021 - PTAB accepted the appeal as sufficient and notified CCBOR with a due date of 01/05/2022.
- 02/12/2024 - The appellant submitted a request to withdraw the appeal.
- 02/20/2024 - PTAB found that an increase in the assessment of the property was warranted.

On 02/22/2023, the appellant submitted this Motion to Vacate Decision and to Allow Withdrawal following the appellant's request submitted on 12/5/2023, as follows:

- On 12/01/23, counsel received an email from PTAB notifying counsel about Standing Order No. 3 and recommending the dismissal of Docket Numbers 20-41004, 21-41027, and 20-41298.
- On 12/05/2023, counsel submitted the appellant's requests to withdraw all said matters via the online portal.
- Due to a typo, the request for Docket No. 20-41027 was inadvertently filed under Docket No. 21-41027. Unfortunately, the case with Docket No. 21-41027 (a case not filed by counsel) was unintentionally withdrawn. In the

withdrawal request, the correct docket was referenced in the letter, indicating counsel's intent to withdraw Docket No. 20-41027.

- On 02/12/2024, counsel submitted a second request to withdraw Docket No. 20-41027 via the online portal.
- The appellant requests that PTAB issue a decision vacating the decision issued for said matter on 02/20/2024 and permit its withdrawal, which will not unduly prejudice any of the parties.

Wherefore, the appellants request PTAB enter an order to allow:

- Vacating the 02/20/2024, decision of the PTAB and
- Withdrawal of Docket No. 20-41027.

f. HGCK 4306 LLC: #20-36134.001 thru .008-I-1 (Cook) (Jefferson)

Appellant's Motion to Amend Decision

This timely multi-parceled industrial appeal by HGCK 4306 LLC from a Cook County Board of Review (CCBOR) Notice of Final Decision sought a change in assessment from \$140,316 to \$98,750, with a basis of recent appraisal.

Timeline

- 08/05/2021 - PTAB accepted the appeal as sufficient and notified CCBOR with a due date of 11/03/2021.
- 02/20/2024 - PTAB found that the parties' agreement was proper and the correct assessment to be \$121,610.

On 03/11/2024, the appellant submitted its Motion to Amend Decision under Section 1910.10 and 1910.64 of the rules of the Property Tax Appeal Board (86 Ill. Admin. Code § 1910.10 and 1910.64), and moves this honorable Board to amend its decision in the above matter as follows:

- On 02/20/2024, PTAB rendered a decision in this matter and in processing the PTAB Decision, a scrivener's error was discovered. The subject property comprises of 8 PINs. The total assessed value as stipulated by the parties is correct, however, the allocation of the total assessed value among the eight PINs causes an increase to one PIN's total assessment.
- This will result in the Treasurer's Office having to issue an Open Item Tax Bill.

- This motion is brought to effectuate the interests of the appellants, CCBOR, and PTAB and in the interests of judicial economy.
- The appellant requests a change in the total assessment for the following PINs as reflected in the enclosed fully executed Stipulation:
 - 2020-36134.006, from \$19,070 to \$15,000.
 - 2020-36134.007, from \$ 3,612 to \$5,647.
 - 2020-36134.008, from \$ 3,612 to \$5,647.

The appellant requests that PTAB amend the instant decision for such other and further relief as the Board deems lawful and proper.

g. James Jenness: 19-45422.001-R-1 (Cook) (North)

Appellant's Motion to Vacate Decision

This timely residential appeal by James Jenness from a Cook County Board of Review (CCBOR) Notice of Final Decision sought a change in assessment from \$300,300 to \$215,455, with a basis of assessment equity.

Timeline

- 12/03/2020 - PTAB accepted the appeal as sufficient and notified CCBOR with a due date of 03/03/2021.
- 02/18/2021 - The appellant requests that the PTAB set the above matter for hearing.
- 02/20/2024 – Without conducting a hearing, which PTAB's Rules required, the PTAB issued a decision that no change in the property's assessment was warranted.

On 02/20/2024, the appellant, through counsel, submitted its Motion to Vacate the Decision Dated 02/20/2024 and issue a decision that comports with the stipulation that was submitted by the parties prior to the decision or, in the alternative, amend the 02/20/2024 decision to that effect as follows:

- On 02/01/2024, the appellant and respondent tendered to the PTAB a signed stipulation in this matter. The stipulation established an agreement to resolve this case at a revised assessment of \$257,524. A stipulation for the 2020 case (Docket 20-42556) was submitted along with the 2019 stipulation and agreed to the same revised assessment. PTAB's website showed the signed 2019 stipulation was received from the county on 02/01/2024. But on 02/20/2024,

PTAB issued a decision in the instant case finding a no change to the 2019 assessment was warranted.

- Rule 1910.50(d) states the PTAB may revise and / or correct a decision upon its own initiative at any time prior to the expiration of the administrative review filing period as provided in Section 16-195 of the Property Tax Code if a mistake in calculation of an assessment or other clerical error is discovered. (86 Ill. Admin. Code § 1910.50(d))
- In this instance PTAB received the signed stipulation of the parties prior to the issuance of its decision yet rendered a decision contrary to the agreement of the parties. The decision does not reference the stipulation and was likely prepared without the knowledge that a stipulation was received.
- In practice PTAB has shown itself to be largely supportive of and favorable towards agreements between the litigants. In this instance the litigants have presented an executed stipulation to the PTAB to set a mutually agreeable assessment of \$257,524 prior to the issuance of the decision.
- The appellant requests PTAB vacate the 02/20/2024 decision and issue a new decision that comports with the stipulation of the parties, or in the alternative, exercise its statutory authority to amend the 02/20/2024 decision to set the 2019 assessment at the stipulated assessment. As the decision was issued on 02/20/2024, the relevant time for filing an administrative review of the decision has not passed. (86 Ill. Admin. Code § 1910.50(d)).
- The appellant makes this request pursuant to PTAB's rules and to arrive at an outcome that was agreed to by the parties, which will conform with substantial justice. *1411 North State Condo Assoc. v PTAB*, 2016 IL App (1st) 143757, ¶ 43.

The appellant respectfully requests PTAB vacate the 02/20/2024 decision and issue a new decision that sets a revised 2019 assessment based upon the stipulation of the parties at an assessment of \$257,254 or, in the alternative, amend the 02/20/2024 decision to comport with the stipulated 2019 assessment of \$257,254 or for any further relief that the PTAB deems just in this circumstance.
