 - a. Ylondia Hudson: #19-54430.001 thru .002-R-1 (Cook) (Bremen)

Appellant's Motion to Reinstate and Request for Hearing

This timely multi-parceled appeal of *pro se* appellant Ylondia Hudson comprises two parcels from a Cook County Board of Review (CCBOR) Final Decision Letter. Based on a recent appraisal, the appellant is seeking a change in assessment from \$35,501 to \$17,000. The appellant also requested a hearing.

Timeline

- 03/10/2022 - PTAB sent the appellant an incomplete checklist requesting the appellant complete an Addendum to Petition for this multi-parceled appeal with a due date of 04/09/2022.
- 05/09/2022—The appellant provided the requested addendum to the Petition; however, the addendum was not completed. The appellant also included a note from her doctor's office stating that she was seen on 03/02/2022 and was advised to be off work until 04/24/2022 due to an illness.

- On 05/26/2022 - The appellant was sent a second incomplete notice requesting a completed Addendum to Petition, with a due date of 06/25/2022.
- 06/24/2022 - The appellant provided a completed Addendum to the Petition.
- 07/07/2022 - PTAB accepted the appellant's appeal and notified the Cook County Board of Review (CCBOR).
- 03/22/2023 – PTAB scheduled the above appeal for a virtual hearing on 05/11/2023 at 10:15 a.m.
- 02/01/2024 – PTAB defaulted the appellant for failure to appear at the above-scheduled hearing and dismissed the appeal.

On 03/12/2024, the appellant submitted a Motion to Reinstate and Request for Hearing as follows:

- The appellant avers she could not appear at the hearing on 05/11/2023 due to "...fact that my [sic] and I were both in the hospital."
- The appellant requests that the PTAB grant another hearing, as she needs the PTAB to review her property taxes.

Request: The appellant requests that PTAB reinstate the above appeal and requests the opportunity for a hearing.

- b. Zeller: #22-48096.001 thru .002-C-3 (Cook) (Niles)

Appellant's Motion for an Extension

The multi-parceled appeal of Zeller comprises two parcels from a Cook County Board of Review (CCBOR) Final Decision Letter, which was timely submitted and seeks a change in assessment from \$9,766,214 to \$1,145,085. The appellant has submitted an appraisal completed by Real Estate Analysis Corporation. The appellant indicated a basis for the recent appraisal and requested a 90-day extension to submit evidence.

Timeline

- 08/22/2023 – The appellant filed this appeal.
- 10/12/2023 – PTAB issued the appellant an incomplete checklist and requested the appellant complete sections II, 2c, 2d, and III of the commercial appeal form, with a due date of 11/11/2023.
- 11/10/2023—The appellant responded to the incomplete checklist and requested another 90-day extension. The appellant stated that the property is complex, with over 500,000 square feet, extreme vacancy, and significant deferred maintenance.

- 11/30/2023 – PTAB granted a **final** 60-day extension to comply with the incomplete checklist with a due date of 01/29/2024.
- 01/29/2024—The appellant provided documentation, including an appraisal, and received an incomplete checklist requesting corrected information due on 03/09/2024.

On 03/08/2024, the appellant provided additional information and requested a 90-day extension to submit additional evidence. The appellant contends that the office market is in flux, and its appraisers are analyzing a large amount of data to create a report that accurately reflects the subject property's market value on the valuation date.

Therefore, the appellant requests an additional 90-day extension to receive, review, and submit the appraisal to PTAB.

- c. Steven DiVito: #22-52853.001-R-1 (Cook) (Northfield)

Motion to Substitute and Request for an Extension

The timely filed appeal of Steven DiVito from a Cook County Board of Review (CCBOR) Final Decision Letter seeks a change in assessment from \$82,250 to \$65,597. The appellant indicated a basis of contention of law and requested a 90-day extension to submit evidence.

Timeline

- 11/02/2023 – PTAB grants a final 60-day extension of time to submit evidence, with a due date of 01/01/2024.
- 12/15/2023 – the appellant submitted its evidence, and on 03/07/2024, PTAB notified CCBOR of the above appeal and provided a due date of 06/05/2024.
- 03/12/2024 - PTAB granted the appellant's motion to substitute counsel, and Steven B. Pearlman & Associates entered its appearance as counsel for the appellant instant.

On 03/14/2024, the appellant submitted a Motion to Substitute and Leave for Appellant's New Counsel to File Evidence Untimely, 60-day Extension and requested PTAB:

- Enter an order to allow the withdrawal of Elliott & Associates, PLLC and the substitution of Steven B. Pearlman & Associates as appellant's legal counsel.

- Grant the appellant's new counsel an extension (60 days) to submit new evidence.

Request: The appellant requests a 60-day extension to file evidence.

- d. Krispy Kreme: #21-49124.001-C-2 (Cook) (Proviso)

Intervenors' Motion to Vacate Default

The timely appeal of Krispy Kreme #247/1302 from a Cook County Board of Review (CCBOR) Final Decision Letter seeks a change in assessment from \$289,572 to \$105,000, with a basis of recent appraisal.

Timeline

- 08/03/2023 -The PTAB accepted the appellant's appeal and notified CCBOR.
- 08/18/2023 – The CCBOR certified copies of the above petition was sent to all taxing districts.
- 10/16/2023 – The Board of Education of Township High School District No. 209 (Dist. 209), Village of Hillside (Hillside) and Board of Education of Hillside School District No. 93 (Dist. 93) moved to intervene.
- 10/26/2023 - PTAB added Dist. 209, Hillside, and District No. 93 as interested parties in the appeal with a due date of 01/24/2024 to file evidence or request an extension.
- 01/24/2024 - The Village of Hillside submitted its evidence.
- 02/22/2024 - PTAB defaulted Dist. 209 and Dist. 93 for failure to submit evidence.





On 03/18/2024, Dist. 209 and Dist. 93 submitted this Motion to Vacate Default as the intervenors. The districts claim that they did timely file their evidence, and they state as follows:

- On 01/24/2024, the districts sent a correspondence to the PTAB adopting the evidence filed by the CCBOR via FedEx overnight delivery to PTAB, which should have been delivered by 01/25/2024.
- The intervenors claim FedEx has yet to deliver the intervenors' correspondence.
- The intervenors contend that according to the FedEx timestamp tracking, they did in fact timely submit correspondence with evidence, but something has gone wrong with the FedEx delivery and PTAB has not received the correspondence.


The intervenors provided the following evidence in support of its motion:

- The intervenors mailed a letter to PTAB dated 01/24/2024 requesting that it adopt the evidence filed by CCBOR.
- Proof of transmittal via FedEx, including the FedEx shipping label for the package showing counsel sent the package to PTAB on 01/24/2024 for delivery on 01/25/2024, with tracking number 2701 6177 5780.
- FedEx tracking report for tracking number 2701 6177 5780 showing that the intervenors' package has been misdirected and inexplicably delayed by FedEx.

- e. Coal City Community Unit School District #1, Coal City Fire Protection District, Coal City Public Library District, & Grundy County: #23-04107.001-I-3 (Grundy)

Motion for Stay of Proceedings

This timely undervaluation appeal was filed by Coal City CUSD 1, Coal City Fire Protection District, Coal City Public Library District, & Grundy County from a decision of the Grundy County Board of Review (GCBOR). The taxing district appellants seek a change in assessment from \$6,131,868 to \$217,633,275, based on a recent appraisal for one parcel owned by General Electric Company / Nuclear Fuel Holding Co. Inc and improved with the GE-Hitachi Morris Operation. The appellants also requested a 90-day extension to submit evidence. On 03/28/2024, PTAB granted the appellants an extension with a due date of 06/26/2024.

On 03/28/2024, the appellants submitted this Motion for Stay of Proceedings and states as follows:

- The appellants aver the GE-Hitachi Morris Operations is an NRC-licensed independent spent fuel storage installation (ISFSI) that provides wet storage of spent nuclear fuel assemblies from nuclear power stations in Connecticut, California, Minnesota, Nebraska, and Illinois. It is the only away-from-reactor commercial ISFSI in the entire country.
- Two appeals are pending before the PTAB regarding the GE-Hitachi Morris Operations for the 2021 and 2022 assessment years. There are several first impressions presented for the PTAB's determination in the 2021 or 2022 assessment appeals that may be subject to further review by the Appellate and Supreme Courts. Resolution of these issues in the 2021 and 2022 appeals could significantly limit the magnitude, complexity, and costs of the evidentiary filings for the tax year 2023 and subsequent years.
- A stay in the 2023 and subsequent appeals pending final resolution of the 2021 and 2022 appeals and determined issues would streamline the evidence and trial of the 2023 and subsequent appeals, thereby allowing the parties and PTAB to avoid considerable expense without detriment to any party.

The appellants request that PTAB grant this Motion for Stay of Proceeding in this matter until 90 days following the final resolution of the 2021 and 2022 appeals (21-05709 and 22-02867), either through settlement or final order of PTAB or a court of appeal.
