

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Dimitrios Mellos, the appellant, by attorney Spiro G. Zarkos, of Verros Berkshire, P.C. in Oakbrook Terrace; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$6,696
IMPR.:	\$33,780
TOTAL:	\$40,476

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story, multi-family building of masonry exterior construction with 3,817 square feet of building area. The building is approximately 95 years old and has a basement finished with an apartment. The property has a 3,720 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four comparables located within the same neighborhood code as the subject and within 1.2 miles of the subject. The comparables are improved with two-story or three-story, class 2-11, multi-family buildings of masonry exterior construction ranging in size from 4,329 to 4,486 square feet of building area. The buildings range in age from 78 to 94 years old and have basements, two of which are

finished with a recreational room or an apartment. One comparable has central air conditioning, and each comparable has either a two-car or a three-car garage. The comparables have improvement assessments ranging from \$19,246 to \$33,539 or from \$4.40 to \$7.71 per square foot of building area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced to \$25,650 or \$6.72 per square foot of building area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$40,476. The subject property has an improvement assessment of \$33,780 or \$8.85 per square foot of building area. In support of its contention of the correct assessment, the board of review submitted information on four comparables located within the same neighborhood code, block and street as the subject property. The comparables are improved with two-story, class 2-11, multi-family buildings of masonry exterior construction ranging in size from 2,376 to 3,522 square feet of building area. The buildings are either 93 or 95 years old and have basements, one of which is finished with a recreational room, and a two-car garage. The comparables have improvement assessments ranging from \$27,205 to \$39,396 or from \$10.54 to \$12.23 per square foot of building area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight suggested comparables for the Board's consideration, all of which have a garage, which is not a feature of the subject. The Board gives less weight to the appellant's comparables #1 and #2 which are located more than a mile away from the subject and the board of review comparables #1 and #4 which are less similar to the subject in building size than the other comparables in this record.

The Board finds the best evidence of assessment equity to be the parties' remaining comparables. These comparables are more similar to the subject in location, building size, age, and some features. However, each of the comparables require varying upward and downward adjustments to make them more equivalent to the subject for differences in building size and/or garage amenity. These four comparables have improvement assessments ranging from \$33,136 to \$39,396 or from \$7.65 to \$12.23 per square foot of building area. The subject's improvement assessment of \$33,780 or \$8.85 per square foot of building area falls within the range established by the best comparables in this record. Based on this record and after considering adjustments to the best comparables for differences when compared to the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
