

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Dale Salzman, the appellant, by attorney Ellen G. Berkshire, of Verros Berkshire in Oakbrook Terrace; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$8,721 **IMPR.:** \$38,461 **TOTAL:** \$47,182

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2019 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of masonry exterior construction with 1,924 square feet of living area. The dwelling is approximately 79 years old. Features of the home include an unfinished basement, a fireplace, and a 1-car garage. The property has a 6,460 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject dwelling is classified as a Class 2-05 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four comparables located within the same neighborhood code as the subject and within 1.4 miles of the subject. The comparables are improved with class 2-05 dwellings of masonry or frame and masonry exterior construction ranging in size from 1,791 to 2,106 square feet of living area. The

dwellings range in age from 68 to 72 years old. Each comparable has a basement with two having finished area and from a 1-car to a 2-car garage. Three comparables each have central air conditioning, and three comparables have either one or two fireplaces. The comparables have improvement assessments ranging from \$27,558 to \$33,254 or from \$13.86 to \$15.81 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced to \$29,437 or \$15.30 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$47,182. The subject property has an improvement assessment of \$38,461 or \$19.99 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four comparables located within the same neighborhood code as the subject property. The board of review reported the furthest comparable is about .25 of a mile from the subject. The comparables are improved with class 2-05, two-story dwellings of masonry exterior construction ranging in size from 1,550 to 1,834 square feet of living area. The dwellings range in age from 69 to 78 years old. Each comparable has an unfinished basement, one or two fireplaces, and from a 1-car to a 2.5-car garage. Three comparables each have central air conditioning. The comparables have improvement assessments ranging from \$36,146 to \$45,271 or from \$21.01 to \$24.68 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

#### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin. Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of eight comparables for the Board's consideration. The Board gives less weight to the appellant's comparables which are less proximate in location to the subject and/or have a basement finish when compared to the subject. The Board also gives less weight to the board of review comparable #1 which differs in dwelling size to the subject.

The Board finds the best evidence of assessment equity to be the board of review's comparables #2 through #4. These comparables are similar to the subject in dwelling size, age, and have an unfinished basement area, but have varying degrees of similarity in other features. These three comparables have improvement assessments ranging from \$37,461 to \$45,271 or from \$21.01 to \$24.68 per square foot of living area. The subject's improvement assessment of \$38,461 or \$19.99 per square foot of living area falls within the range established by the best comparables in this record on an overall improvement assessment basis and below on a per square foot basis. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence

that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
