



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Kevin White

The parties of record before the Property Tax Appeal Board are Kevin White, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$151,950  
**IMPR.:** \$141,940  
**TOTAL:** \$293,890

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a 2.5-story dwelling of wood siding exterior construction with 2,595 square feet of living area. The dwelling was constructed in 1959, is approximately 62 years old, and has a reported effective age of 1968.<sup>1</sup> Features of the home include a basement with finished area, a fireplace, and a 506 square foot garage. The property has a 34,678 square foot site and is located in Lake Forest, Shields Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales located from 1.05 to 1.69 miles from the subject. The parcels range in size from 5,758 to 11,813 square feet of land area and are improved with 2-story homes of wood siding exterior construction ranging in size from 2,208 to

2,726 square feet of living area. The dwellings range in age from 27 to 99 years old. Each home has a basement, three of which have finished area, central air conditioning, and a garage ranging in size from 414 to 672 square feet of building area. Three homes each have one or three fireplaces. The comparables sold from August 2020 to August 2021 for prices ranging from \$645,000 to \$799,000 or from \$291.64 to \$306.01 per square foot of living area, including land.

Based on this evidence the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$293,890. The subject's assessment reflects a market value of \$883,880 or \$340.61 per square foot of living area, land included, when using the 2021 three year average median level of assessment for Lake County of 33.25% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales located from 0.91 of a mile to 1.77 miles from the subject. The parcels range in size from 6,440 to 42,020 square feet of land area and are improved with 1.5-story or 2-story homes of brick or wood siding exterior construction ranging in size from 2,288 to 2,668 square feet of living area. The dwellings were built from 1951 to 1977. Three homes each have a basement, two of which have finished area, and one home has a concrete slab foundation. Each home has central air conditioning and a garage ranging in size from 484 to 1,272 square feet of building area. Three homes each have one or two fireplaces. Comparable #1 has an inground swimming pool and a greenhouse. The comparables sold from September 2020 to October 2021 for prices ranging from \$750,000 to \$1,600,000 or from \$310.17 to \$599.70 per square foot of living area, including land.

Based on this evidence the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of eight comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparables #1, #3, and #4 and the board of review's comparables #1 and #2, which are less similar to the subject in proximity, age, dwelling size, foundation type, basement finish, garage size, inground swimming pool amenity, and/or greenhouse amenity.

The Board finds the best evidence of market value to be the appellant's comparable #2 and the board of review's comparable #3 and #4, which are more similar to the subject in dwelling size, age, location, and features, although these comparables have smaller lots than the subject, suggesting upward adjustments to these comparables would be needed to make them more

equivalent to the subject. These most similar comparables sold for prices ranging from \$750,000 to \$799,000 or from \$306.01 to \$330.15 per square foot of living area, including land. The subject's assessment reflects a market value of \$883,880 or \$340.61 per square foot of living area, including land, which is above the range established by the best comparable sales in this record, but appears to be justified given the subject's 2.5-story design and larger lot compared to the best comparables. Based on this evidence and after considering appropriate adjustments to the best comparables for differences when compared to the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
