

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Nick Santoro

The parties of record before the Property Tax Appeal Board (PTAB) are Nick Santoro, the appellant, by attorney Joseph G. Kusper of Storino, Ramello & Durkin of Rosemont and the Cook County Board of Review (board).

The subject property consists of a five-year-old, two-story single-family dwelling of masonry construction containing 6,631 square feet of living area and located in Palatine Township, Cook County. The residence contains four full and two half bathrooms, a full finished basement, air conditioning, fireplaces and a four-car garage.

The appellant, through counsel, submitted evidence before the PTAB claiming unequal treatment in the assessment process as the basis of the appeal. In support of this argument, the appellant offered three suggested comparable properties located within a mile and a half of the subject. These properties consist of two-story class 2-08 and 2-09 single-family dwellings of frame and masonry or masonry construction and range in age from six to 65 years. The comparables have three, four or six bathrooms with half-baths and full or partial basements. All homes are air-conditioned and have fireplaces. The comparables have two or three-car garages. The comparables contain between 4,386 and 6,358 square feet of living area and have improvement assessments ranging from \$9,900 to \$58,166 or from \$2.26 to \$10.12 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board submitted its "Board of Review Notes on Appeal" wherein the subject's final improvement assessment of \$112,429, or \$16.96 per square foot of living area, was disclosed. In support of the subject's assessment, the board offered four suggested comparable properties located within the same block as the subject. The comparables consist of two-story single-family dwellings of masonry construction and range in age from seven to eleven years. The comparables contain three or four bathrooms with half bathrooms and full finished basements; all have air conditioning,

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

fireplaces and two, three or four-car garages. The comparables range in size from 5,103 to 5,926 square feet of living area and have improvement assessments of between \$88,646 and \$104,628 or from \$17.37 to \$18.05 per square foot of living area. Based on this evidence, the board requested confirmation of the subject property's assessment.

After reviewing the record and considering the evidence, the PTAB finds that it has jurisdiction over the parties and the subject matter of this appeal. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the PTAB finds the appellant has failed to overcome this burden.

The PTAB finds the board's comparables one, two and three and the appellant's comparable three are the comparables most similar to the subject. These properties have improvement assessments ranging from \$10.12 to \$18.05 per square foot of living area. The subject's per square foot improvement assessment of \$16.96 is within this range of properties. The PTAB gives less weight to the remaining comparables because they are less similar to the subject in age, living area or building classification. After considering the differences in both parties' suggested comparables when compared to the subject property, the PTAB finds the evidence submitted is insufficient to effect a change in the subject's assessment.

As a result of this analysis, the Property Tax Appeal Board finds the appellant failed to adequately demonstrate that the subject dwelling was inequitably assessed by clear and convincing evidence and no reduction is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.



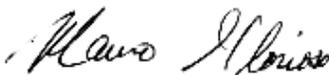

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
