

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Andy Ejzak

The parties of record before the Property Tax Appeal Board are Andy Ejzak the appellant, by attorney Joanne P. Elliott, Des Plaines, and the Cook County Board of Review.

The subject property consists of a six-year-old, two-story, single-family dwelling of frame construction containing 3,963 square feet of living area and located in Palatine Township, Cook County. Amenities include a basement, a fireplace, three bathroom, air conditioning and a garage.

The appellant, through counsel, submitted evidence before the Property Tax Appeal Board claiming unequal treatment in the assessment process as the basis of the appeal. In support of this argument, the appellant offered a spreadsheet detailing three suggested comparable properties located in the same coded assessment neighborhood as the subject.

These properties consist of two-story, single-family dwellings of frame or frame and masonry construction. All of the comparable dwellings contain a garage, one or two fireplaces, three baths and air conditioning. The comparables range in size from 4,009 to 4,376 square feet of living area and have improvement assessments ranging from \$6.94 to \$9.25 per square foot of living area. A copy of the subject's 2004 board of review final decision was also included along with a brief in support of the requested reduction. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final improvement assessment of \$44,267, or \$11.17 per square foot of living area, was disclosed. In support of the subject's assessment, the board of review

offered property characteristic sheets and a spreadsheet detailing four suggested comparable properties located in the same coded assessment neighborhood as the subject. The comparables consist of four-year-old or six-year-old, two-story style single-family dwellings of frame construction. All of the comparables contain two, three or four baths, a basement, a fireplace, central air conditioning and a garage. These properties range in size from 3,111 to 4,641 square feet of living area and have improvement assessments ranging from \$12.06 to \$12.90 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject property's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal.

The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has not overcome this burden.

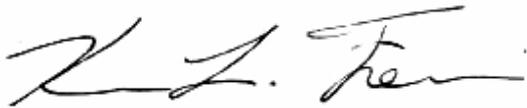
The Board finds that the parties submitted seven properties as comparable to the subject. These properties have improvement assessments ranging from \$6.94 to \$12.90 per square foot of living area. The subject's per square foot improvement assessment of \$11.17 falls within the range established by these properties. Further, the three most similar comparables are the board of review's comparables two, three and four and their range is from \$12.06 to \$12.87 per square foot of living area; the subject falls below this range. Therefore, the Board finds the subject's per square foot improvement assessment is supported by the properties contained in the record.

As a result of this analysis, the Property Tax Appeal Board finds the appellant has not adequately demonstrated that the subject dwelling was inequitably assessed by clear and convincing evidence and a reduction is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the

subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
