

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Pierre Mounsef

The parties of record before the Property Tax Appeal Board are Pierre Mounsef, the appellant, by attorney Terrence Kennedy, Jr. of the Law Offices of Terrence Kennedy, Jr. of Chicago and the Cook County Board of Review.

The subject property consists of a six-year-old, two-story single-family dwelling of masonry construction containing 3,021 square feet of living area and located in Niles Township, Cook County. The residence contains two and one-half bathrooms, a full basement, air conditioning, a fireplace and a two-car garage.

The appellant, through counsel, submitted evidence before the PTAB claiming unequal treatment in the assessment process as the basis of the appeal. In support of this argument, the appellant offered four suggested comparable properties located within a quarter mile of the subject. These properties consist of two-story single-family dwellings of masonry or frame and masonry construction and range in age from one to 16 years. The comparables have two or three bathrooms with some half-baths and full or partial basements, three finished. All homes are air-conditioned and three have fireplaces. The sites each have two or three-car garages. The comparables contain between 2,335 and 3,208 square feet of living area and have improvement assessments ranging from \$34,687 to \$46,424 or from \$13.17 to \$14.86 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board submitted its "Board of Review Notes on Appeal" wherein the subject's final improvement assessment of \$50,687, or \$16.78 per square foot of living area, was disclosed. In support of the subject's assessment, the board offered four suggested comparable properties located within two blocks of the subject. The comparables consist of two-story single-family dwellings of masonry construction and range in age from six to seven years. The comparables contain two or three bathrooms with some half-baths, full basements; all have air conditioning, fireplaces and

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the COOK County Board of Review is warranted. The correct assessed valuation of the property is:

two-car garages. The comparables range in size from 2,420 to 3,066 square feet of living area and have improvement assessments of between \$40,995 and \$51,247 or from \$16.71 to \$17.21 per square foot of living area. Based on this evidence, the board requested confirmation of the subject property's assessment.

After reviewing the record and considering the evidence, the PTAB finds that it has jurisdiction over the parties and the subject matter of this appeal. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the PTAB finds the appellant has failed to overcome this burden.

The PTAB finds the board's comparables one, three and four and the appellant's comparables two, three and four are the comparables most similar to the subject. These properties have improvement assessments ranging from \$13.17 to \$17.21 per square foot of living area. The subject's per square foot improvement assessment of \$16.78 is within this range of properties. The PTAB gives less weight to the appellant's comparable one and the board's comparable two because they are less similar to the subject in building area. After considering the differences in both parties' suggested comparables when compared to the subject property, the PTAB finds the evidence submitted is insufficient to effect a change in the subject's assessment.

As a result of this analysis, the Property Tax Appeal Board finds the appellant failed to adequately demonstrate that the subject dwelling was inequitably assessed by clear and convincing evidence and no reduction is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal

Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
