

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: John and Carol Malatia
DOCKET NO.: 04-25363.001-R-1
PARCEL NO.: 07-28-313-020-0000

The parties of record before the Property Tax Appeal Board are John and Carol Malatia, the appellants, by attorney Julie Realmuto of McCarthy & Duffy, Chicago, Illinois; and the Cook County Board of Review.

The subject property is improved with a 20-year old, one-story dwelling of masonry construction containing 2,131 square feet of living area with a full, unfinished basement, central air-conditioning, a fireplace and a two-car detached garage.

The appellants' appeal is based on unequal treatment in the assessment process. The appellants submitted information on four comparable properties described as one-story frame, masonry or frame and masonry dwellings that are either 27 or 28 years old for consideration. The comparables are located from approximately 1.5 to more than 3.0 miles from the subject. The comparables range in size from 2,443 to 2,643 square feet of living area and have improvement assessments ranging from \$11.59 to \$12.51 per square foot of living area. The subject's improvement assessment is \$14.69 per square foot of living area. Based on this evidence, the appellants requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. The board of review presented descriptions and assessment information on four comparable properties consisting of one-story masonry dwellings that range in age from 15 to 24 years old. The comparables are located within 1.5 blocks of the subject with two properties located on the same street as the subject. The dwellings range in size from 1,678 to 2,043 square feet of living area and have improvement assessments ranging from \$14.81 to \$16.02 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$	7,623
IMPR.:	\$	31,304
TOTAL:	\$	38,927

Subject only to the State multiplier as applicable.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.


The appellants contend unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellants have not met this burden.

The Board finds the board of review's comparables were more similar to the subject in size, design, exterior construction, basement finish, location and/or age. Because of these similarities, these properties were given more weight in the Board's analysis. These most similar comparables had improvement assessments that ranged from \$14.81 to \$16.02 per square foot of living area. The subject's improvement assessment of \$14.69 per square foot of living area is below this range. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's per square foot improvement assessment is supported and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
