

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Frank Mancini

The parties of record before the Property Tax Appeal Board are Frank Mancini, the appellant, by attorney Stephanie Park of Chicago, and the Cook County Board of Review.

The subject property consists of a 6,600 square foot parcel improved with 63-year-old, two-story style single-family dwelling of frame and masonry construction. Containing 1,460 square feet of living area, the subject features one and one-half baths, a full unfinished basement, air conditioning, and a fireplace. The subject is located in Maine Township, Cook County.

The appellant, through counsel, appeared before the Property Tax Appeal Board claiming unequal treatment in the assessment process as the basis of the appeal. In support of this argument, the appellant submitted a spreadsheet detailing 12 suggested comparable properties located in the same coded assessment neighborhood as the subject. These properties consist of two-story style single-family dwellings of frame, masonry or frame and masonry construction from 63 to 145 years old. The comparables range in size from 1,302 to 1,654 square feet of living area and feature one full bath and garages; ten also have half baths; eleven have basements; four have air conditioning; and nine have fireplaces. The comparables have improvement assessments ranging from \$14.78 to \$21.59 per square foot of living area. A copy of the subject's 2004 board of review final decision was also included. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final improvement assessment of \$37,536, or \$25.71 per square foot of living area, was disclosed. In support of the subject's assessment, the board of review submitted property characteristic sheets and a spreadsheet detailing one suggested comparable property located in the same coded assessment neighborhood as the subject. The comparable is a 63-year old, two-story style single-family dwelling of masonry

construction containing 1,302 square feet of living area. The comparable contains one and one-half bath, a full finished basement, air conditioning, two fireplaces, and a two-car garage. This property has an improvement assessment of \$21.59 per square foot of living area. This comparable was also utilized by the appellant. Based on this evidence, the board of review requested confirmation of the subject property's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has overcome this burden.

The Board finds that the parties submitted twelve properties as comparable to the subject. These properties have improvement assessments ranging from \$14.78 to \$21.59 per square foot of living area. The subject's per square foot improvement assessment of \$25.71 is above the range established by all the properties in the record. After considering adjustments and the differences in both parties' suggested comparables when compared to the subject property, the Board finds the subject's per square foot improvement assessment is not supported by the properties contained in the record.

As a result of this analysis, the Property Tax Appeal Board finds the appellant has adequately demonstrated that the subject dwelling was inequitably assessed by clear and convincing evidence and a reduction is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal

Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
