

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: George Watt

The parties of record before the Property Tax Appeal Board are George Watt, the appellant, by attorney Rusty A. Payton of the Law Offices of Rusty A. Payton, P.C., Chicago, Illinois; and the Cook County Board of Review.

The subject property is a 52-year old, one and one-half story frame dwelling containing 1,560 square feet of living area with a crawl-space foundation, and a one and one-half car garage.

The appellant submitted evidence before the Property Tax Appeal Board claiming unequal treatment in the assessment process as the basis of the appeal. In support of the equity argument, the appellant submitted a grid analysis detailing three suggested comparable properties. On the appellant's map, the comparables are located approximately three-quarter mile to one mile from the subject. The comparables are one-story or one and one-half story masonry or frame and masonry dwellings that are one to 52 years old. Two comparable have unfinished basements; one has a full basement; and one has a partial basement. Three comparables have central air conditioning, and one has a fireplace. The dwellings have living areas that contain 1,470 to 1,710 square feet, and their improvement assessments range from \$4.29 to \$8.20 per square foot. The subject property has an improvement assessment of \$12.87 per square foot. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's assessment was disclosed. In support of the subject's assessment, the board of review offered property characteristic sheets and a spreadsheet detailing three suggested comparable properties that are located in close proximity of the subject. The comparables are one and one-half

story frame dwellings that are 52 or 56 years old. Each comparable has a full, unfinished basement and a garage, either one-car or two-car. One comparable has central air conditioning. The dwellings have living areas that contain 1,383 to 1,659 square feet and improvement assessments ranging from \$13.36 to \$14.22 per square foot. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Property Tax Appeal Board further finds that a reduction in the subject's assessment is not warranted. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has not overcome this burden.

Both parties presented assessment data on a total of seven equity comparables. All of the comparables differed in foundation from the subject. The appellant's comparables differed significantly in location from the subject, and comparables one and two differed substantially in age, exterior construction, and design. As a result, the appellant's comparables received reduced weight in the Board's analysis. The board of review's comparables were the most similar to the subject in age, location, and most physical characteristics. These comparables had improvement assessments of \$13.36 to \$14.22 per square foot that support the subject's improvement assessment of \$12.87 per square foot. After considering adjustments and the differences in both parties' suggested comparables when compared to the subject property, the Board finds the subject's per square foot improvement assessment is supported by the most comparable properties contained in the record, and a reduction in the subject's assessment is not warranted.

As a result of this analysis, the Property Tax Appeal Board finds the appellant has not adequately demonstrated that the subject dwelling was inequitably assessed by clear and convincing evidence, and a reduction is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
