

PROPERTY TAX APPEAL BOARD'S DECISION

The parties of record before the Property Tax Appeal Board are Scott Stiffle, the appellant, by attorney Terrence Kennedy, Jr. of Chicago, and the Cook County Board of Review.

The subject property consists of an 88-year-old, two-story style mixed use residential/commercial building of masonry construction containing 2,420 square feet of building and located in Lake View Township, Cook County. The subject improvement contains one living unit and one commercial unit.

The property in this appeal was the subject of an appeal before the Property Tax Appeal Board for the two prior years under **Docket Nos. 03-25683.001-R-1 and 04-23710.001-R-1.** In those appeals, the Property Tax Appeal Board reached decisions based upon equity and the weight of the evidence in the record as presented by the parties to the appeal. Pursuant to the Official Rules of the Property Tax Appeal Board, evidence from both parties in support of their respective opinions of the subject's market value as of the assessment date or equity of the assessment was requested.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Property Tax Appeal Board finds from its analysis of the record that the evidence in this appeal is essentially the same as that of the two prior years. Since no new evidence was presented to warrant a change from the previous year's decision, the Board finds that the assessment as established in the prior year's appeal is appropriate.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds a reduction in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

Subject only to the State multiplier as applicable.



IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

DOCKET NO.: 05-22641.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
