

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Degucz Glucksberg

The parties of record before the Property Tax Appeal Board are Degucz Glucksberg, the appellant, by attorney Rusty A. Payton of the Law Offices of Rusty A. Payton, P.C., Chicago, Illinois; and the Cook County Board of Review.

The subject property is a 92-year old, two-story frame dwelling containing 1,399 square feet of living area. The dwelling has a full unfinished basement.

The appellant submitted evidence before the Property Tax Appeal Board claiming unequal treatment in the assessment process. The appellant submitted four suggested comparable properties located in relative close proximity to the subject. The comparables are described as two-story frame dwellings that are from 83 and 117 years old. Features had varying degrees of similarity when compared to the subject. The comparables contain from 1,325 to 1,740 square feet of living area and have improvement assessments ranging from \$14.76 to \$19.08 per square foot of living area. The subject property has an improvement assessment of \$22.20 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. In support of the subject's assessment, the board of review presented property characteristic sheets and an assessment analysis of four suggested comparables. The comparables consist of two-story frame dwellings that are 96 to 109 years old. Features had varying degrees of similarity when compared to the subject. The dwellings contain from 1,320 to 1,536 square feet of living area and have improvement assessments ranging from \$22.38 to \$25.67 per square foot of living area. Based on this

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not overcome this burden.

The Board finds parties submitted eight suggested comparables for consideration. The Board finds both parties' comparables had varying degrees of similarity when compared to the subject in age, size, design, features and location. The comparables have improvement assessments ranging from \$14.76 to \$25.67 per square foot of living area. The subject's improvement assessment of \$22.20 per square foot of living area falls within this range. After considering adjustments to the comparables for any differences when compared to the subject, the Board finds the subject's improvement assessment is supported and no reduction is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
