The parties of record before the Property Tax Appeal Board (hereinafter PTAB) are Raj Patel, the appellant, by Attorney Anthony M. Farace with the law firm of Amari & Locallo in Chicago; the Cook County Board of Review by Assistant State's Attorney Aaron Bilton with the Cook County State's Attorneys Office in Chicago; and the two intervenors, Arlington Heights Township High School District #214 as well as Elk Grove Community Consolidated School District #59, by Attorney Ares Dalianis with the law firm of Franczek Sullivan PC in Chicago.

Pursuant to Section 1910.73 of the PTAB's official rules, several pre-hearing conferences were held at which time the proper notice having been given the parties were present. As a result of said conferences and prior to the hearing, the parties reached an agreement as to the correct assessment of the subject property.

After considering the evidence and reviewing the record, the PTAB finds that it has jurisdiction over the parties and the subject matter of this appeal. The PTAB further finds that the assessed valuation proposed by the parties is appropriate.

Based on the facts and exhibits presented, the PTAB hereby finds a reduction in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

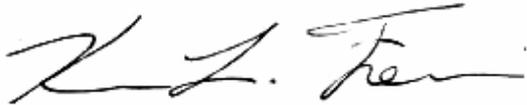

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

DOCKET NO.: 06-21157.001-C-3

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
