

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Paul Leongas

The parties of record before the Property Tax Appeal Board (PTAB) are Paul Leongas, the appellant, by attorney Joseph G. Kusper of Storino, Ramello & Durkin of Rosemont and the Cook County Board of Review (board).

The subject property consists of a 49-year-old, one-story dwelling of frame and masonry construction containing 2,238 square feet of living area and located in Maine Township, Cook County. The subject improvement is prorated over two parcels of land. The residence includes two and one half bathrooms, a partial basement, air conditioning and a two-car garage.

The appellant, through counsel, submitted evidence before the PTAB claiming unequal treatment in the assessment process as the basis of the appeal. In support of this argument, the appellant offered three suggested comparable properties located within two miles of the subject. These properties consist of one or one and part two-story dwellings of masonry or frame and masonry construction, and range in age from 27 to 52 years. The comparables include two or three bathrooms with half baths, two with partial basements, one finished, all with air conditioning and fireplaces. The comparables have two, three or four-car garages. The comparables contain between 2,777 and 4,464 square feet of living area and have improvement assessments ranging from \$25,566 to \$34,227 or from \$7.67 to \$10.29 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final improvement assessment of \$40,580, or \$18.13 per square foot of living area, was disclosed. In support of the subject's assessment, the board of review offered four suggested comparable properties located within two blocks of the subject. The comparables consist of one-story dwellings of frame and masonry or masonry construction. The comparables range in age from 25 to 53 years and have full

basements. The comparables have two and one half bathrooms, all with air conditioning, fireplaces and all have two-car garages. The comparable properties contain between 2,158 and 2,442 square feet of living area with improvement assessments of between \$48,147 and \$54,459 or from \$20.40 to \$22.99 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject property's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has failed to overcome this burden.

The PTAB finds the board's four comparables are similar to the subject in building size but with some differences in construction materials. These properties have improvement assessments ranging from \$20.40 to \$22.99 per square foot of living area. The subject's per square foot improvement assessment of \$18.13 is below this range of properties. The PTAB gives less weight to the appellant's comparables because they are less similar to the subject in living area or construction materials or location. After considering the differences in both parties' suggested comparables when compared to the subject property, the PTAB finds the evidence submitted is insufficient to effect a change in the subject's assessment.

As a result of this analysis, the PTAB finds the appellant did not adequately demonstrate that the subject property was inequitably assessed by clear and convincing evidence and a reduction is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
