

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: John Boler

The parties of record before the Property Tax Appeal Board are John Boler, the appellant, by attorney Joseph G. Kusper of Storino, Ramello & Durkin in Rosemont, and the Cook County Board of Review.

The subject property consists of a 50-year-old, one-story, single-family dwelling of frame construction containing 1,742 square feet of living area. Features of the residence include two and one-half bathroom, air-conditioning, a fireplace and a two-car attached garage. The subject is built with crawl space and located in Palatine Township, Cook County.

The appellant, through counsel, submitted evidence before the Property Tax Appeal Board arguing unequal treatment in the assessment process of the improvement as the basis of the appeal. In support of this claim, the appellant submitted assessment data and descriptive information on three properties suggested as comparable to the subject. The appellant also submitted a two-page brief, photographs and Cook County Assessor's Internet Database sheets for the subject and the suggested comparables and a copy of the board of review's decision. Based on the appellant's documents, the three suggested comparables offered by the appellant consist of two-story, single-family dwellings of frame or masonry construction located within several blocks of the subject. The improvements range in size from 2,193 to 3,282 square feet of living area and range in age from 28 to 38 years. The comparables contain two and one-half or three and one-half bathrooms, air-conditioning, a fireplace, a partial or full-unfinished basement and a two-car garage. The improvement assessments range from \$10.31 to \$12.15 per square foot of living area. Based on the evidence submitted, the appellant requested a reduction in the subject's improvement assessment. The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's total assessment of \$41,813.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 9,806
IMPR.: \$ 32,007
TOTAL: \$ 41,813

Subject only to the State multiplier as applicable.

The subject's improvement assessment is \$32,007 or \$18.37 per square foot of living area. In support of the assessment the board submitted property characteristic printouts and descriptive data on two properties suggested as comparable to the subject. The suggested comparables are improved with one-story, 32 or 51-year-old, single-family dwellings of frame construction with the same neighborhood code as the subject. The improvements contain 1,496 and 1,698 square feet of living area. The comparables contain two or two and one-half bathrooms, a fireplace, a finished or unfinished basement and a two-car attached garage. The improvement assessments are \$20.44 and \$23.31 per square foot of living area, respectively. In addition, the board submitted copies of documentation from the board of review level complaint file. Based on the evidence presented, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review V. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has not overcome this burden.

The Board finds the board's comparables are the only comparables similar to the subject to carry weight. The appellant's comparables differ from the subject in size of living area and/or design and the Board gives these properties less weight. The two similar properties have improvement assessments of \$20.44 and \$23.31 per square foot of living area. The subject's per square foot improvement assessment of \$18.37 is below these properties. After considering adjustments and the differences in both parties' suggested comparables when compared to the subject, the Board finds the evidence submitted is insufficient to effect a change in the subject's assessment.

As a result of this analysis, the Property Tax Appeal Board finds the appellant has failed to adequately demonstrate that the subject dwelling was inequitably assessed by clear and convincing evidence and a reduction is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
