



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Marshall Klein

The parties of record before the Property Tax Appeal Board are Marshall Klein, the appellant, by attorney Timothy C. Jacobs, of Gary H. Smith PC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND: \$ 18,125
IMPR.: \$ 51,518
TOTAL: \$ 69,643**

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property is improved with a two-story multi-family dwelling of stucco construction containing 3,839 square feet of living area. The dwelling is 97 years old. Features of the home include a full, unfinished basement.

The appellant's appeal is based on unequal treatment in the assessment process. In support of this argument, the appellant submitted information on nine comparable properties with the same classification code as the subject. The number of stories for each comparable was not disclosed. The comparables were multi-family dwellings of masonry or frame and masonry construction that were between 93 and 98 years old. The comparable dwellings range in size from 4,068 to 4,338 square feet of living area. Seven of the comparables have full basements, two of which are finished, and each has a garage. The comparables have improvement assessments ranging from \$9.24 to \$10.71 per square foot of living area. The subject's improvement assessment is \$13.42 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed.

The board of review presented descriptions and assessment information on three comparable properties consisting of three-story masonry multi-family dwellings that are either 88 or 100 years old. The dwellings range in size from 3,344 to 3,891 square feet of living area. The comparables have full, unfinished basements and a garage. These properties have improvement assessments ranging from \$14.46 to \$14.97 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not met this burden.

The Board finds the comparables submitted by the parties were all older, multi-family dwellings that were similar to the subject in size and foundation. Their exterior construction varied from the subject. Despite the difference in exterior construction, the comparables had improvement assessments ranging from \$9.24 to \$14.97 per square foot of living area. The subject's improvement assessment of \$13.42 per square foot of living area is within the range established by the comparables. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's improvement assessment is equitable and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
