

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Daniel Modjewski

The parties of record before the Property Tax Appeal Board are Daniel Modjewski, the appellant, by attorney Rusty A. Payton of the Law Offices of Rusty A. Payton, P.C., Chicago, Illinois; and the Cook County Board of Review.

The subject property is a 15-year old, multi-level style dwelling of frame and masonry construction containing 1,133 square feet of living area with a partial, finished basement.

The appellant's appeal is based on unequal treatment in the assessment process. The appellant submitted for consideration four comparable properties described as multi-level frame and masonry dwellings that are between 31 and 37 years old. On the appellant's map, the comparables are located approximately one-half to one and one-quarter mile from the subject property. Each of the comparables has a partial basement. The comparables contain from 1,188 to 1,365 square feet of living area and have improvement assessments ranging from \$11.78 to \$14.83 per square foot. The subject's improvement assessment is \$17.26 per square foot. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. The board of review presented four comparable properties consisting of multi-level frame and masonry dwellings that are between 16 and 18 years old. One of the comparables is located near the subject property, and the other three, based on their parcel index numbers, are located approximately one mile from the subject property. Three of the comparables have partial basements, and one has a crawl-space foundation. The dwellings contain from 1,192 to 1,225 square feet of living area and have

improvement assessments ranging from \$18.21 to \$19.20 per square foot. Based on this evidence, the board of review requested confirmation of the subject's assessment.

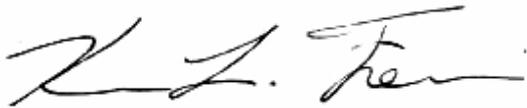
After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not overcome this burden.

The Board finds the range established by the most similar comparables contained in this record is \$18.49 to \$19.20 per square foot of living area. The subject's improvement assessment of \$17.26 per square foot of living area falls below this range. Despite differences in location, three comparables submitted by the board of review were the most similar to the subject in age and physical characteristics. These comparables received the greatest weight in the Board's analysis. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's per square foot improvement assessment is supported and a reduction in the subject's assessment is not warranted.

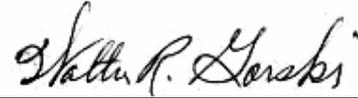

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the

session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
