



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Irina Bashko

The parties of record before the Property Tax Appeal Board are Irina Bashko, the appellant, by attorney Michael Griffin in Chicago, and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 13,987
IMPR.: \$ 14,517
TOTAL: \$ 28,504

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property is improved with a one-story dwelling of frame construction containing 1,422 square feet of living area. The dwelling is 48 years old. Features of the home include a slab foundation, a fireplace, and a two-car garage.

The appellant's appeal is based on unequal treatment in the assessment process. The appellant submitted information on four comparable properties described as one-story frame dwellings that are either 51 or 52 years old. The appellant's comparables all have the same neighborhood code as the subject, and two are located on the same street as the subject. The comparable dwellings range in size from 1,040 to 1,782 square feet of living area. Each has a slab foundation; one has a fireplace; and two have garages. The comparables have improvement assessments ranging from \$2.31 to \$8.94 per square foot of living area. The subject's improvement assessment is \$10.21 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. The board of review presented descriptions and assessment information on four comparable properties consisting of one-story

frame dwellings that range in age from 49 to 54 years old. The comparables all have the same neighborhood code as the subject. The dwellings range in size from 1,352 to 1,480 square feet of living area. Two comparables have crawl-space foundations, and two have unfinished basements, either full or partial. Three comparables have garages; two have a fireplace; and one has central air conditioning. These properties have improvement assessments ranging from \$10.01 to \$16.78 per square foot of living area. As part of its evidence, the board of review disclosed that the comparable numbered two sold for \$347,500 in May 2005 and the comparable numbered three sold for \$460,000 in June 2006. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not met this burden.

Both parties presented assessment data on a total of eight equity comparables. The appellant's comparables numbered two and four differed from the subject in size and received reduced weight in the Board's analysis. The comparables numbered two and four by the board of review differed from the subject in foundation and also received reduced weight. The Board finds the appellant's comparables numbered one and three and the comparables numbered one and three by the board of review were most similar to the subject in size, age, style, and exterior construction. None of these comparables had a basement. Due to their similarities to the subject, these comparables received the most weight in the Board's analysis. These comparables had improvement assessments that ranged from \$8.50 to \$16.78 per square foot of living area. The subject's improvement assessment of \$10.21 per square foot of living area falls within the range established by the most similar comparables. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's improvement assessment is equitable and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
