



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Joseph Haberkorn

The parties of record before the Property Tax Appeal Board are Joseph Haberkorn, the appellant(s), by attorney Joseph G. Kusper, of Storino Ramello & Durkin of Rosemont; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$ 7,474  
**IMPR.:** \$ 63,625  
**TOTAL:** \$ 71,099

Subject only to the State multiplier as applicable.

**ANALYSIS**

The subject property consists of an 8,125 square foot parcel improved with a seven-year-old, two-story style single-family dwelling of frame and masonry construction. Containing 3,142 square feet of living area, the subject features two and one-half baths, a full unfinished basement, central air conditioning, a fireplace and a two-car garage.

The appellant, through counsel, submitted evidence before the Property Tax Appeal Board claiming unequal treatment in the assessment process as the basis of the appeal. In support of this argument, the appellant offered a spreadsheet detailing

three suggested comparable properties located in the same coded assessment neighborhood as the subject. These properties consist of one-story or two-story style single-family dwellings of masonry or frame and masonry construction ranging in age from seven to fifty-two years old. The comparables range in size from 2,732 to 3,233 square feet of living area with amenities such as two and one-half baths, fireplaces and garages; two also are centrally air conditioned. The comparables have improvement assessments ranging from \$8.96 to \$14.67 per square foot of living area. A copy of the subject's 2006 board of review final decision was also included. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final improvement assessment of \$63,625, or \$20.25 per square foot of living area, was disclosed. In support of the subject's assessment, the board of review offered property characteristic sheets and a spreadsheet detailing four suggested comparable properties located in the same coded assessment neighborhood as the subject. The comparables consist of two-story style single-family dwellings of frame and masonry construction ranging in age from four to seven years old. These properties range in size from 2,685 to 3,466 square feet of living area and have amenities such as two and one-half baths, full finished or unfinished basements, central air conditioning, fireplaces and garages. The comparables have improvement assessments ranging from \$21.24 to \$22.58 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject property's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has failed to overcome this burden.

The Property Tax Appeal Board finds that the appellant's comparable numbered one and the board of review's comparables are the most similar to the subject in the record. These properties are similar in age, size, construction type, style and amenities. The Board accords primary weight to these properties. The Board accords the remaining properties less weight. The Board finds that the remaining properties are less similar to varying degrees in style, age, size, and amenities. After considering adjustments and the differences in both parties' suggested comparables when compared to the subject property, the Board finds the subject's per square foot improvement assessment of \$20.25 is supported by the properties contained in the record.

As a result of this analysis, the Property Tax Appeal Board finds the appellant failed to adequately demonstrate that the subject dwelling was inequitably assessed by clear and convincing evidence and no reduction is warranted.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
