



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Steven J. Rosenberg

The parties of record before the Property Tax Appeal Board are Steven J. Rosenberg, the appellant(s), by attorney Stephen Golan, of Golan & Christie LLP of Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND: \$ 13,063
IMPR.: \$ 65,169
TOTAL: \$ 78,232**

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property contains 10,535 square feet of land improved with a 18-year old, two-story, frame and masonry, single-family dwelling. The improvement includes 3,430 square feet of living area, four baths, a partial basement, one fireplace and a two-car garage.

At hearing, the parties jointly requested that PTAB render a decision in this matter based on the written evidence submissions.

The appellant's appeal is based on unequal treatment in the assessment process. The appellant submitted assessment data and descriptions on four comparable properties for consideration. They are improved with a two-story, single-family dwelling of masonry exterior construction. They range: in age at either one or 44 years; in size from 2,577 to 3,240 square feet of living area; and in improvement assessments from \$5.16 to \$5.82 per square foot of living area. Amenities include one or two fireplaces and a multi-car garage. The subject's improvement assessment is \$19.00 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$78,232 was disclosed. The board of review presented descriptions and assessment information on four comparable properties for consideration, one of which is located on the subject's street. They are improved with a two-story, frame and masonry, single-family dwelling. They range: in age from 15 to 21 years; in size from 3,068 to 3,489 square feet of living area; and in improvement assessments from \$19.00 to \$21.33 per square foot of living area. Amenities include a full or partial basement, one fireplace, and a multi-car garage. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The PTAB further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the PTAB finds the appellant has not met this burden.

The PTAB finds the comparables submitted by the board of review are most similar to the subject in style, size, age and amenities. Due to their similarities to the subject, these four comparables received the most weight in the PTAB's analysis. These comparables had improvement assessments that ranged from \$19.00 to \$21.33 per square foot of living area. The subject's improvement assessment of \$19.00 per square foot of living area is at the low end of this range.

After considering adjustments and the differences in both parties' comparables when compared to the subject, the PTAB finds the subject's per square foot improvement assessment is supported and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.



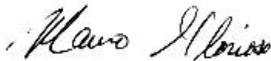

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
