



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: K.C. & Linda Jones
DOCKET NO.: 07-01735.001-R-1

The parties of record before the Property Tax Appeal Board are K.C. & Linda Jones, the appellants, by attorney Clyde B. Hendricks in Peoria, and the Peoria County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Peoria County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$2,190
IMPR.: \$8,680
TOTAL: \$10,870

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property consists of an 87 year-old, one-story, cottage style frame dwelling that contains 966 square feet of living area. The home has a full unfinished basement and a 264 square foot garage.

Through his attorney, the appellant submitted evidence to the Property Tax Appeal Board claiming overvaluation as the basis of the appeal. In support of this argument, the appellant submitted the subject's property record card, multiple listing sheets and a grid analysis of three comparable properties. The comparables consist of 1.5-story or 1.0-story frame or brick and frame dwellings that were built between 1895 and 1958 and range in size from 960 to 1,326 square feet of living area. All the comparables have full or partial basements, one of which has 797 square feet of finished area, one has central air conditioning and a gas log a fireplace and one has a two-car garage. The comparables were reported to have sold between June and August 2007 for prices ranging from \$14,000 to \$23,500 or from \$11.11 to \$24.47 per square foot of living area including land. Based on

this evidence, the appellant requested the subject's assessment be reduced to \$7,600, reflecting a market value of approximately \$22,800.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's total assessment of \$10,870 was disclosed. The subject has an estimated market value of \$32,721 or \$33.87 per square foot of living area including land as reflected by its assessment and the 2007 Peoria County three-year median level of assessments of 33.22%.

In support of the subject's assessment the board of review submitted property record cards and a grid analysis of three comparable properties. The comparables consist of one-story style frame dwellings that were built between 1920 and 1925 and range in size from 912 to 1,058 square feet of living area. Features of the comparables include full unfinished basements and garages that contain from 240 to 360 square feet of building area. One comparables has a fireplace. The comparables sold between April 2006 and August 2007 for prices ranging from \$35,000 to \$44,000 or from \$33.08 to \$48.25 per square foot of living area including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

In rebuttal, the appellant argued the board of review's comparables had amenities not enjoyed by the subject and comparable #2 did not sell through the Multiple Listing Service. The appellant also argued it was unfair to compare owner-occupied dwellings with rental properties.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Property Tax Appeal Board further finds no reduction in the subject property's assessment is warranted.

The appellant contends overvaluation as the basis of the appeal. When market value is the basis of the appeal, the value must be proved by a preponderance of the evidence. National City Bank of Michigan/Illinois v. Illinois Property Tax Appeal Board, 331 Ill.App.3d 1038 (3rd Dist. 2002). After analyzing the market evidence submitted, the Board finds the appellant has failed to meet this burden.

The Board finds the parties submitted a total of six comparables in support of their respective arguments. The Board gave less weight to the appellant's comparables because they differed from the subject in design, exterior construction, age and/or size. The Board finds the comparables submitted by the board of review were similar to the subject in design, exterior construction, age, size and some features and sold for prices ranging from \$33.08 to \$48.25 per square foot of living area including land. The subject's estimated market value as reflected by its assessment of \$33.87 per square foot of living area including

land falls within this range. Therefore, the Board finds the evidence in this record supports the subject's assessment.

In conclusion, the Board finds the appellant has failed to prove overvaluation by a preponderance of the evidence and the subject's assessment as determined by the board of review is correct and no reduction is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
