



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Peter Lisnic, the appellant(s), by attorney David C. Dunkin, of Arnstein & Lehr in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds a reduction in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

ject only to the State multiplier as applicable.

**ANALYSIS**

The subject property has 8,785 square feet of land, which is improved with a 117 year old, two-story, frame, single-family dwelling containing 1,725 square feet of living area. The dwelling's amenities include two baths, a full unfinished basement, and air conditioning. The appellant's appeal is based on unequal treatment in the assessment process.

In support of the equity argument, the appellant, via counsel, submitted descriptive and assessment information on five properties suggested as comparable to the subject. These properties are described as two-story, frame, masonry, or stucco, single-family dwellings that range in age from 81 to 122 years old, and in size from 1,656 to 2,080 square feet of living area. The dwellings include four full unfinished basements and one full basement with a formal recreation room. The dwellings have from one and one-half to two and one-half baths. Additionally, one of the suggested comparables has air conditioning, one has a fireplace, and all of the suggested comparables have a garage, ranging from a two-car to a two and one-half-car garage. These suggested comparables have improvement assessments ranging from \$19.71 to \$23.60 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The Cook County Board of Review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$77,305 was disclosed. In support of the subject's assessment, the board of review presented descriptions and assessment information on four properties suggested as comparable to the subject. These properties are described as two-story, frame or stucco, single-family dwellings that range in age from 53 to 124 years old, and in size from 1,836 to 3,016 square feet of living area. These properties include three full unfinished basements and one slab. The dwellings have from two to three baths. Additionally, two of the dwellings have two-car garages. These suggested comparables have improvement assessments ranging from \$12.60 to \$18.93 per square foot of living area. The subject's assessment is \$37.89 per square foot of living area. The board of review's grid sheet also stated that the subject sold in July 2004 for \$770,000, and that Comparables #1 and #4 both sold in October 2004 for \$351,500 and \$415,000, respectively. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board (the "Board") finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant contends unequal treatment in the subject's improvement assessment as the basis of this appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Walsh v. Prop. Tax Appeal Bd., 181 Ill. 2d 228, 234 (1998) (citing Kankakee Cnty. Bd. of Review v. Prop. Tax Appeal Bd., 131 Ill. 2d 1 (1989)); 86 Ill. Admin. Code § 1910.63(e). To succeed in an appeal based on lack of uniformity, the appellant must submit documentation "showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property." Cook Cnty. Bd. of Review v. Prop. Tax Appeal Bd., 403 Ill. App. 3d 139, 145 (1st Dist. 2010); 86 Ill. Admin. Code § 1910.65(b). "[T]he critical consideration is not the number of allegedly similar properties, but whether they are in fact 'comparable' to the subject property." Cook Cnty. Bd. of Review v. Prop. Tax Appeal Bd., 403 Ill. App. 3d at 145 (citing Du Page Cnty. Bd. of Review v. Prop. Tax Appeal Bd., 284 Ill. App. 3d 649, 654-55 (2d Dist. 1996)). After an analysis of the assessment date, the Board finds that the appellant has met this burden.

The Board finds that Comparables #1, #3, and #5 submitted by the appellant were most similar to the subject in location, size, style, exterior construction, features, and age. Due to their similarities to the subject, these comparables received the most weight in the Board's analysis. These comparables had improvement assessments that ranged from \$22.62 to \$23.60 per square foot of living area. The subject's improvement assessment of \$37.89 per square foot of living area is above the range established by the most similar comparables. Therefore, after

considering adjustments and differences in both parties' comparables when compared to the subject, the Board finds that the subject's improvement assessment is not equitable, and a reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
