



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Perry Moore

The parties of record before the Property Tax Appeal Board are Perry Moore, the appellant(s), by attorney Joseph G. Kusper, of Storino Ramello & Durkin in Rosemont; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$ 20,994  
**IMPR.:** \$ 93,205  
**TOTAL:** \$ 114,199

Subject only to the State multiplier as applicable.

**ANALYSIS**

The subject property consists of an 11,410 square foot parcel of land improved with an 80-year old, two-story, masonry, single-family dwelling. The improvement contains 3,451 square feet of living area as well as a partial basement, two fireplaces and a two-car garage.

The appellant's attorney argued that there was unequal treatment in the assessment process as the basis of this appeal.

In support of the equity argument, the appellant submitted descriptive and assessment data for three suggested comparables located within a several block radius of the subject. The properties were improved with a two-story, single-family dwelling with masonry, frame or frame and masonry exterior construction. They range: in age from 78 to 89 years; in size from 4,098 to 4,963 square feet of living area; and in improvement assessments from \$23.77 to \$24.38 per square foot. The properties each contain a fireplace and a two-car garage, while properties #1 and #2 also include a partial basement. The subject's improvement assessment is \$27.01 per square foot of living area. Based upon

this analysis, the appellant requested a reduction in the subject's assessment.

The board of review submitted "Board of Review-Notes on Appeal" wherein the subject's total assessment was \$114,199. The board of review submitted descriptive and assessment data relating to four suggested comparables. The properties are improved with a two-story, masonry, single-family dwelling. They range: in age from 66 to 82 years; in size from 3,032 to 3,476 square feet of living area; and in improvement assessment from \$28.57 to \$30.80 per square foot. Amenities include basement area, one or two fireplaces, and a two-car garage.

In addition, the board's analysis indicated that properties #2 through #4 were accorded an average condition by the assessor's office, while the subject and property #1 were accorded a deluxe condition without further explanation. Further, the grid sheet indicated that property #4 sold on June 1, 2004 for a price of \$882,500. As a result of its analysis, the board requested confirmation of the subject's assessment.

After considering the arguments as well as reviewing the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the data, the Board finds that the appellant has not met this burden.

The Board finds that comparables submitted by the board of review are most similar to the subject in style, exterior construction, improvement size and age. In analysis, the Board accorded most weight to these comparables. These comparables ranged in improvement assessments from \$28.57 to \$30.80 per square foot of living area. The subject's improvement assessment at \$27.01 per square foot is below the range established by these comparables.

The Board accorded diminished weight to the appellant's properties due to a disparity in exterior construction and/or improvement size.

As a result of this analysis, the Board finds that the appellant has not adequately demonstrated that the subject was inequitably assessed by clear and convincing evidence and that a reduction is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
