



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Guadalupe Martinez, the appellant, by attorney Michael Griffin in Chicago, and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:**     \$ 10,145  
**IMPR.:**    \$ 40,355  
**TOTAL:**    \$ 50,500

Subject only to the State multiplier as applicable.

**ANALYSIS**

The subject property is improved with a two-story multi-family building of masonry construction containing 2,622 square feet of building area. The building is 82 years old. Features of the building include two apartment units, a full, unfinished basement, and a two-car garage.

The appellant's appeal is based on unequal treatment in the assessment process. The appellant submitted information on four comparable properties described as two-story masonry multi-family buildings that range in age from 51 to 94 years old. The comparables have the same neighborhood and classification codes as the subject. The comparables range in size from 2,403 to 3,078 square feet of building area, and each has two apartment units. The comparables have improvement assessments ranging from \$9.70 to \$14.52 per square foot of building area. The subject's improvement assessment is \$15.39 per square foot of building area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. The board of review presented descriptions and assessment information on four comparable properties consisting of two-story

masonry multi-family buildings that range in age from 78 to 85 years old. The comparables all have the same neighborhood and classification codes as the subject. The comparables range in size from 2,448 to 2,793 square feet of building area, and each has two apartment units. These properties have improvement assessments ranging from \$15.99 to \$18.14 per square foot of building area. As part of its evidence, the board of review disclosed that the subject sold in July 2004 for \$505,000. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not met this burden.

All of the eight comparables submitted by both parties were two-story masonry apartment buildings like the subject. The appellant's comparables numbered two through four were much newer than the subject and received reduced weight in the Board's analysis. The Board finds the appellant's comparable numbered one and the comparables submitted by the board of review were the most similar to the subject in age. They were also very similar in size. Due to their similarities to the subject, these comparables received the most weight in the Board's analysis. These comparables had improvement assessments that ranged from \$9.70 to \$18.14 per square foot of building area. The subject's improvement assessment of \$15.39 per square foot of building area falls within the range established by the most similar comparables. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's improvement assessment is equitable and a reduction in the subject's assessment is not warranted

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
