



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Mark Prince

The parties of record before the Property Tax Appeal Board are Mark Prince, the appellant, by attorney James E. Doherty, of Thomas M. Tully & Associates of Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds a reduction in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$36,422
IMPR: \$107,389
TOTAL: \$143,811

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property is improved with a two-story dwelling of frame construction containing 4,091 square feet of living area. The dwelling is 126 years old and is located in Wilmette, New Trier Township, Cook County. The property is classified as a class 2-06 residential property under the Cook County Real Property Assessment Classification Ordinance. Features of the home include a full unfinished basement, three fireplaces and a 2-car garage.

The appellant's appeal is based on unequal treatment in the assessment process. The appellant submitted information on six comparable properties located in neighborhood 94. The comparables consist of two-story masonry, stucco or frame and masonry dwellings that range in age from 67 to 105 years old. The comparable dwellings range in size from 3,242 to 4,260 square feet of living area. Four comparables have full basements, of which one is finished with a recreation room. Two comparables have partial unfinished basements. Six comparables have one or two fireplaces. Five comparables have from 1.5-car to 3-car

garages. One comparable has central air conditioning. The comparables have improvement assessments ranging from \$16.20 to \$27.97 per square foot of living area. The subject's improvement assessment is \$30.34 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$160,542 was disclosed. The board of review presented descriptions and assessment information on four comparable properties located in the same neighborhood code as the subject. The comparables consist of two-story frame dwellings that range in age from 87 to 114 years old. The dwellings range in size from 2,940 to 3,201 square feet of living area. Each comparable has a full basement, three of which are finished with a recreation room, from one to three fireplaces and a 2-car or 3-car garage. One comparable has central air conditioning. These properties have improvement assessments ranging from \$31.00 to \$33.05 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

In rebuttal, the appellant argued summarized the key points and challenged the board of review's comparables.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds a reduction is warranted.

The Board finds comparables #3, #5 and #6 submitted by the appellant and the comparables submitted by the board of review were dissimilar in size when compared to the subject and less weight was given to these properties. The Board finds comparables #1, #2 and #4 submitted by the appellant most similar to the subject in size and features. These comparables had improvement assessments that ranged from \$16.20 to \$26.33 per square foot of living area. The subject's improvement assessment of \$30.34 per square foot of living area is above the range established by these similar comparables. After considering adjustments to the comparables for differences when compared to the subject, the Board finds the subject's improvement assessment is not equitable and a reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
