



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Hadeil Salha

The parties of record before the Property Tax Appeal Board are Hadeil Salha, the appellant(s), by attorney Lisa A. Marino, of Marino & Assoc., PC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$9,451
IMPR.: \$20,127
TOTAL: \$29,578

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property consists of a 6,218 square foot parcel of land improved with a 55-year old, one and one-half story, frame, single-family dwelling which is owner-occupied. The improvement contains 2,224 square feet of living area, one full bath, air conditioning and a two car detached garage. The appellant argued unequal treatment in the assessment process as the basis of this appeal.

In support of the equity argument, the appellant submitted descriptions and assessment information as well as black and white photographs, on a total of three properties suggested as comparable. The properties are located within five blocks of the subject and are improved with one and one-half story, masonry or frame and masonry, single-family dwellings. They range: in bathrooms from one full and one-half to three full and one-half baths; in age from 55 to 84 years; in size from 2,011 to 3,798 square feet of living area; and in improvement assessment from \$4.59 to \$11.80 per square foot of living area. The subject's improvement assessment is \$9.05 per square foot. The properties

also contain: air conditioning for one property, full basements, one of which is finished with a formal recreation room, and two car detached garages. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's improvement assessment of \$20,127 or \$9.05 per square foot of living area was disclosed. In support of the subject's assessment, the board of review presented descriptions and assessment information on four properties suggested as comparable and located within the subject's neighborhood, three of which are within one quarter mile of the subject. The properties are improved with one and one half-story, frame and masonry, single-family dwellings. They range: in age from 54 to 59 years; in size from 1,815 to 1,995 square feet of living area; in bathrooms from one full and one half to two full and one half baths. The properties also include full basements, one of which is finished with a formal recreation room, air conditioning for three properties, and two car garages. The properties have improvement assessments ranging from \$13.63 to \$15.62 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the PTAB finds the appellant has not met this burden.

The parties presented a total of seven properties suggested as comparable to the subject. The PTAB finds the board of review's comparables most similar to the subject in improvement size, design, proximity, and age. These comparables ranged in improvement assessments from \$13.63 to \$15.62 per square foot. The subject's improvement assessment at \$9.05 per square foot is below the range established by these comparables. Further, the board accorded diminished weight to the remaining properties due to a disparity in improvement size for #2 and #3, and age for #1 and #2. Therefore, after considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds that the appellant has not demonstrated that the subject is inequitably assessed. The Board finds that the subject's per square foot improvement assessment is supported and a reduction in the improvement assessment is not warranted.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
