



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Agnes Rapta
DOCKET NO.: 07-25742.001-R-1

The parties of record before the Property Tax Appeal Board are Agnes Rapta, the appellant, by attorney Timothy C. Jacobs of Gary H. Smith PC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds a reduction in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 11,737
IMPR: \$ 81,133
TOTAL: \$ 92,870

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property is improved with a two-story dwelling of stucco construction containing 4,009 square feet of living area. The dwelling is 13 years old. Features of the home include a partial unfinished basement, central air conditioning, a fireplace, and a two-car attached garage. The dwelling is located in Park Ridge, Maine Township, Cook County.

The appellant submitted evidence before the Property Tax Appeal Board claiming overvaluation as the basis of the appeal. In support of the overvaluation argument, the appellant submitted an appraisal report in which a market value of \$925,000 was estimated for the subject property as of January 1, 2007. The appraiser developed the sales comparison approach and the cost approach but gave primary emphasis to the sales comparison approach for estimating the market value of the subject property. Using the cost approach, the appraiser estimated a market value of \$944,825. Under the sales comparison approach, the appraiser considered five comparable properties that ranged from \$800,000 to \$1,200,000. Four of the five properties sold from November 2006 to August 2007, and one of the properties had not yet sold. The comparable properties are improved with two-story masonry or stucco dwellings that range in age from two to nine years old and range in size from 3,100 to 4,222 square feet of living area. After identifying differences between the comparable properties

and the subject, the appraiser made adjustments to the sale prices. As a result, the adjusted sale prices of the comparable properties ranged from \$888,000 to \$988,500. In the brief, the appellant's counsel requested that the 10% level of assessments on class 2 property in Cook County be applied to the appraiser's finding of market value and that the subject's total assessment be reduced to \$92,500.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$115,283 was disclosed. The subject's assessment reflects a market value of \$1,148,237 or \$286.41 per square foot of living area, land included, using the 2007 three-year median level of assessments for Cook County Real Property Assessment Classification Ordinance Class 2 property of 10.04% as determined by the Illinois Department of Revenue. (86 Ill.Admin.Code 1910.59(c)(2)).

The board of review presented descriptions and assessment information on four comparable properties consisting of one or two-story masonry or frame and masonry dwellings that range in age from three to fifty-one years old. The comparables have the same assigned neighborhood code as the subject, and one is located on the same block as the subject. The dwellings range in size from 1,942 to 4,688 square feet of living area. One dwelling has a full unfinished basement, and three dwellings have finished basements, either full or partial. Each comparable has central air conditioning, one or two fireplaces, and an attached garage. These properties have improvement assessments ranging from \$22.06 to \$27.48 per square foot of living area. As part of its evidence, the board of review also disclosed that comparable two sold in December 2004 for \$1,280,000 or for \$291.57 per square foot of living area, land included, and comparable four sold in May 2005 for \$53,000 or for \$27.29 per square foot of living area, land included. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Board finds it has jurisdiction over the parties and the subject matter of the appeal. The Board further finds the evidence in the record supports a reduction in the subject's assessment.

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. National City Bank of Michigan/Illinois v. Illinois Property Tax Appeal Board, 331 Ill.App.3d 1038 (3rd Dist. 2002). Proof of market value may consist of an appraisal of the subject property, a recent sale of the subject property or comparable sales. (86 Ill.Admin.Code 1910.65(c)). After an analysis of the evidence in the record, the Board finds a reduction in the subject's assessment is warranted.

The Board finds the appellant's appraisal report is the best evidence of the subject's market value as of the January 1, 2007

assessment date. The appraiser estimated a market value of \$925,000 for the subject property as of January 1, 2007. The subject's assessment reflects a market value of \$1,148,237 and is in excess of the market value estimate contained in the appraisal report. The board of review submitted four equity comparables but did not refute the overvaluation argument. Although the board of review provided sale prices for two of these equity comparables, these sales occurred in December 2004 and May 2005. One of these sales, comparable #4, was not at all similar to the subject property. The comparable sales utilized in the appraisal sold more proximate in time to the assessment date at issue. Based on this record, the Board finds the subject has a market value of \$925,000 as of January 1, 2007, and the 2007 three-year median level of assessments for Cook County Real Property Assessment Classification Ordinance Class 2 property of 10.04% as determined by the Illinois Department of Revenue shall apply. (86 Ill.Admin.Code 1910.59(c)(2)).

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
