



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Michael Montgomery

The parties of record before the Property Tax Appeal Board are Michael Montgomery, the appellant, by attorney Christopher G. Walsh, Jr. in Chicago and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND: \$ 11,368
IMPR.: \$ 45,772
TOTAL: \$ 57,140**

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property is improved with a two-story dwelling of frame and masonry construction containing 3,228 square feet of living area. The dwelling is 36 years old. Features of the home include a partial, unfinished basement, central air conditioning, a fireplace, and a two-car garage.

The appellant's appeal is based on unequal treatment in the assessment process. The appellant submitted information on four comparable properties described as two-story frame or frame and masonry dwellings that range in age from 19 to 31 years old. The comparables have the same neighborhood code as the subject; however, based on their parcel index numbers, they are not located in close proximity of the subject. The comparable dwellings range in size from 3,117 to 3,277 square feet of living area. Three dwellings have unfinished basements, either full or partial, and one has a slab foundation. Each comparable has one or two fireplaces and a two or three-car garage. Two dwellings have central air conditioning. The comparables have improvement assessments ranging from \$4.19 to \$7.24 per square foot of living area. The subject's improvement assessment is \$45,772 or \$14.18 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. The board of review presented descriptions and assessment information on four comparable properties consisting of two-story frame and masonry dwellings that have the same neighborhood code as the subject. One comparable is located in the same tax block as the subject, and another is located one-quarter mile from the subject. The dwellings range in age from 30 to 36 years old, and they range in size from 2,478 to 2,600 square feet of living area. Each comparable has central air conditioning, one or two fireplaces, and a two-car garage, and each dwelling has a full basement, one of which is finished. These properties have improvement assessments ranging from \$14.66 to \$16.54 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not met this burden.

The Board finds that the eight comparables submitted by both parties were all very similar to the subject in age, style, and exterior construction. The comparables submitted by the board of review were located in close proximity of the subject, and the comparables submitted by the appellant were most similar to the subject in size. These comparables had improvement assessments that ranged from \$4.19 to \$16.54 per square foot of living area. The subject's improvement assessment of \$14.18 per square foot of living area falls within the range established by these comparables. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's improvement assessment is equitable and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
